Lawyer-linguists must be able to discern precisely what EU legal texts intend to convey, and faithfully reflect that intention in their own language.</p> <p>An interpreter works in real time making communication possible between the speaker and the person hearing the oral submissions, faithfully conveying a message expressed orally in a language other than that of the speaker.</p> <p>Every year, the Court offers a number of paid traineeships of a duration of five months. 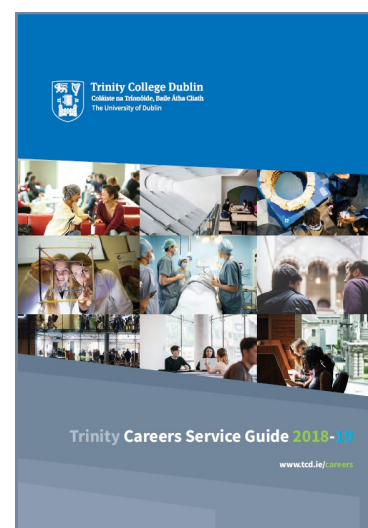
