Module description

This option explores the English 'estate' or 'country house' novel in the twentieth century. We will survey the development and transition of the estate novel in this period, consider the critical and thematic mainstays of the genre, and read from a range of British authors who have engaged this tradition in their writing. In seminar discussions we will pay close critical attention to the impact on the novel of the First and Second World Wars; changing concepts of Englishness; literary representations of class, religion and sexuality, and the estate novel's relationships to Modernism and Postmodernism, Post- imperialism, Metafiction and Gothic. There will also be an opportunity to view some film adaptions of the novels studied. The module texts will be accompanied by directed critical reading (provided on Blackboard). Students taking this module will be expected to have read and prepared both primary and secondary bibliography in full for each class.
