

Fee Payment Methods

The college offers various payment methods to students. All monies must have been credited to the student's account in advance of registration. Students should **allow sufficient time for payments to be processed** through the banking system.

TCD Bank Giro	Suitable for payments made in the Republic of Ireland. **All applications through the PAC system must use Epay facility when paying deposits & fees**	Payments are made using the standard TCD Bank Giro. Payments are made at any bank in the Republic of Ireland. Students MUST ensure that their student number is included in Part 2 of the Giro and they should retain Part 1 for Tax Receipt purposes	Please allow 2 to 3 working days prior to attending registration	Bank of Ireland Trinity Branch 2 College Green Dublin 2 Ireland Account Number: 14020408 Bank Sort Code: 90-00-17
Online e-pay system (Credit and Laser Cards)	Suitable for payments made worldwide. **All applications through the PAC system must use Epay facility when paying deposits & fees**	The URL is epay.tcd.ie – No WWW is required. Online payments take 24 hours to be completed. The confirmation receipt produced at this point merely confirms that the transaction has been submitted. It DOES NOT act as a receipt or confirmation of payments received.	Please allow 24 hours prior to attending registration	College bank details are not required. Credit and laser card payments are passed to the relevant card provider and bank. Transaction details are then automatically transferred to College.
EFT (Electronic Funds Transfer)	Suitable for payments made worldwide. **All applications through the PAC system must use Epay facility when paying deposits & fees**	Student may pay using Electronic Funds Transfer (EFT). Payments made using this method rely heavily upon the originating bank entering the correct details on the transaction report. It is vital that payments made by EFT must include the student number as part of the transaction details. Failure to include the student number may result in payments being delayed. This will in turn prohibit students ability to register. Students should also obtain a copy of the EFT Transaction report.
