# Sources of Information

With any new job, there is a lot to take in. Many resources exist to provide you with information about Trinity, the community, and your role.

### Your Line Manager

Your manager and colleagues are here to support you, and your Line Manager is your first point of contact. When you start in your role, your Line Manager will meet you and explain the expectations and standards required in your new role. Your Line Manager will:

- Organise your local orientation and induction.
- Guide and enable necessary introductions to colleagues and key people.
- Support you with practical workspace essentials ((including relevant access to systems and equipment).
- Support you with essential procedures (including information on processes, policies, job specific training).

### Trinity Induction Session

To complement your local induction, please attend an online HR central induction – you'll find it an invaluable source of information. Sessions are held frequently and are facilitated by HR Learning and Organisation Development in partnership with colleagues across the Trinity community. Induction will:

- Fast-track your engagement with key services.

# Essential Steps to Getting Set up

#### Your Employment Contract

As a new employee, you will receive a contract of employment before commencing with Trinity. This contract sets out all terms and conditions of your employment. If you have any queries regarding your contract, please contact the HR Recruitment Team at <u>recruit@tcd.ie</u>.

Once you accept your offer and return your contract via DocuSign, our Employee Services Team will set you up as a Trinity employee, and the following processes are activated:

- Employee Number
- ID Card
- Login Details
- Payroll

#### Non-EU Employees: Employment Permits/Hosting Agreements

If you are a non-EU employee, your School or Unit will discuss your eligibility to work in Trinity with HR prior to you commencing your employment. Where applicable, an Employment Permit/Hosting Agreement will be sought/issued by TCD on your behalf. To commence employment with Trinity you must have secured an Employment Permit/ Hosting Agreement or have provided proof of your eligibility to work in Ireland. Your employment will always be conditional on your eligibility to have an Employment Permit/Hosting Agreement or any other relevant permission to work in Ireland.

You must familiarise yourself with your obligations in securing these, and if necessary, updating/renewing them in a timely manner for the duration of your employment with Trinity.

- Research Assistants and Fellows may avail of the <u>Hosting Agreement Scheme</u>.

#### Organising your Tax and Registering with Revenue

In Ireland, updating Revenue records is an individual responsibility. When starting your new job in Trinity, you must update your Revenue details online. You must have a PPSN to do this. Your Personal Public Service Number (PPSN) is a unique reference number that helps you access social welfare benefits, public services, and information in Ireland. You will need your PPSN to avoid paying <u>emergency tax</u>. To ensure a smooth transition with Revenue, check which of the following categories you fall into:

# Do you already have a PPSN/are registered with Revenue?

If so, you will need to update your employment details via the <u>Revenue site</u>. This is done easily online through your personal 'MyRevenue' Account. Doing this will reduce the chances of paying emergency tax on your income.

You will need:

- Your PPSN (to identify you on the Revenue system); and
- Trinity's Employer Registration Number: 0053370i.

Are you new to Ireland or is this your first job? Individuals who do not hold (and require) a PPSN must first set up a MyGovID account through the Department of Social Protection, and then apply online for their unique PPSN.

- Step 1: Set up a MyGovID account and apply for your PPSN <u>online</u>.
- Step 2: Log in to your 'MyRevenue' Account to assign your tax details. Trinity's Employer Registration Number is 0053370i.

#### Payment of Salary to Bank Accounts

To organise payment of your salary into your bank account you will need to download, complete and return the Pay Mandate form directly to Payroll Services (through DocuSign) prior to the 1st of the month for inclusion in that calendar month's payroll.

#### **Payroll Dates**

- Monthly paid employees are paid on the 20th of the month for the full calendar month.
- Fortnightly paid employees are paid every second Thursday of each month.
- If you are paid monthly and your employment commences after the 10th of the calendar month, you will not be paid until the following calendar month.

#### Employee Number and your Employee Identity Card

Once you have your employee number, you can apply for your employee identity card (ID card).

#### To get your Employee ID card:

- 1. Complete the online application form by clicking this link <u>Employee</u> <u>ID card Application form</u>.
- 2. Send the completed application form and a Jpeg picture (portrait, sized appropriately) of yourself to <u>HR@tcd.ie</u>.
- 3. Please select an option on the application form to either collect your card from the HR Service Centre or have your card sent by post to either your home or work address.

#### Employee Identity (ID) Card

With your employee ID card, you can:

- Access the campus, Library, Sports Centre and selected buildings.
- Apply for certain memberships, including the Library and Sports Centre.

 Operate the TCard cashless payment system (optional). TCards can be used to pay for a range of services across campus. You can apply when you receive your ID card and top up online.

#### Login Details

Along with your employee identity card, our HR Service Centre administer the issuing of your email login, username and temporary password.

The IT Services team will guide and support you through all other IT matters. You can contact them via the IT Service Desk and webchat. IT Services publish useful links, helpful videos, and online 'how to' guides including:

# Pensions, Life Assurance, and Income Protection

The terms and conditions of your Contract of Employment specify if your position is pensionable. To learn more, visit the <u>HR</u> <u>Pensions website</u> or contact the TCD Pensions Office: <u>pensions@tcd.ie</u>.

Voluntary Life Assurance and Income Protection details are available here: Income Protection and Life Assurance (Death-in-Service).

Non-pensionable employees have access to a Standard Group PRSA facility. Further details may be obtained from the TCD Pensions Office.

#### Bike to Work and TaxSaver Travel Pass Schemes

Trinity will support you to buy you a bicycle from a participating shop should you wish to participate in the Bike to Work scheme and/ or you can avail of an annual travel ticket. The cost is deducted from your gross salary over an agreed repayment term. You can save up to 51% of the total price (depending on your tax rate), which is reflected in your tax deductions.


