The Institute organises its strategic funding and programmes to support the development of Trinity's Arts and Humanities led research themes and the emergence of new research groupings. The themes draw on a critical mass of research from across the university to focus on addressing some of society's major challenges.

They are: **Digital Humanities; Identities in Transformation; Creative Arts Practice;** Making Ireland and Manuscript, Book and Print Cultures. Emerging areas of interdisciplinary research being supported by the Institute are **Medical Humanities**; Environmental Humanities and Cultural Trauma.

We help facilitate and initiate research in these areas through a variety of means which support individual, collaborative and interdisciplinary research.

Looking back on this highly successful year and its manifold achievements, I wish to thank colleagues in the Trinity Long Room Hub member Schools and the Library for ever deeper and more productive collaborations. HIGHLIGHTS 2013-14

ADVANCING COLLABORATIVE AND INTERDISCIPLINARY RESEARCH EXCELLENCE

NEW DEVELOPMENTS

- We welcomed the School of Law and the School of Education as new members of our research community, bringing the number of Trinity Long Room Hub member schools to a total of nine. Both schools are particularly strong in Humanities research that affects public debate and public policy.
- A NEW COLLEGE WIDE RESEARCH THEME ON MANUSCRIPT, BOOK AND PRINT CULTURES WAS ESTABLISHED AS THE FIFTH ARTS AND HUMANITIES-LED RESEARCH THEME OUT OF AN OVERALL NUMBER OF NINETEEN.

The written medium has been the priveleged form of communicating knowledge for millennia and the aim of this research theme is to address all aspects of the study of manuscript and print records, beginning with Trinity College Library Collections.



HIGHLIGHTS 2013-14

SPECTRESS

In May 2014 we launched the SPECTRESS Marie Curie research network on overcoming political and cultural trauma.

This is an international research consortium led by Dr Jennifer Edmond and will help develop cultural trauma as a research focus at Trinity.



Over a four year period SPECTRESS will offer research fellowships for senior researchers as well as for doctoral students at the participating institutions of Yale, the University of Tokyo, Jawaharlal Nehru University, the University of Sao Paulo as well as from leading institutions in Croatia, Estonia, Germany, Ireland and Poland.

RESEARCH SUPPORT

To support and incentivize innovative, collaborative and interdisciplinary research in the Arts and Humanities we:

WE AWARDED 20 GRANTS FROM OUR RESEARCH INCENTIVE SCHEME AMOUNTING TO €60,000

- Sponsored and facilitated 23 conferences and workshops supporting our various research themes as well as individual research projects;
- We awarded 20 grants from our Research Incentive Scheme amounting to €60,000 for projects to be developed in 2014-15.

Our Visiting Research Fellowship programme continued to flourish. During 2013-14 the Institute, in close collaboration with our partnering Schools and the Library, welcomed 10 distinguished Visiting Research Fellows for periods ranging from two weeks to three months.

Influencing public debate is an increasingly important part of our work and we have sponsored some new initiatives in this regard in conjunction with our partners and the Arts and Humanities research themes.

Public lectures which drew large audiences and considerable public interest included: 'The Beatles in Twelve Movements'; 'Europe's Violent Memories 2013-16'; 'Disability and Literature'; 'The Transformative Periphery. Negotiating Identities from the Margins' and 'In Tune: a Millennium of Music in Trinity College Library'.

Nine of our Visiting Research Fellows gave public lectures on their research projects at Trinity. Collectively, the podcasts of their lectures have received 265 plays to date.

Some key public engagement higlights are outlined in the following pages and include: The World War I Road Show; The President of Ireland's Ethics Initiative Ethics Initiative and the Inaugural Annual Edmund Burke Lecture.



REVISITING IRELAND'S ROLE IN WORLD WAR 1

THE WORLD WAR 1 ROADSHOW AT TRINITY ON 12 JULY 2014

6,000+ VISITORS

This showcase was part of a major partnership with RTE, the national public service broadcaster of Ireland, and the National Library of Ireland to mark the the beginning of the centenary of World War 1.

Ireland's part in the war, and Trinity's own unique history during the period, was explored with a series of events throughout the campus including a family collections day and a popular programme of pop up talks and lectures related to the Great War. Trinity's contribution was organized by the Trinity Long Room Hub with the Faculty of Arts, Humanities and Social Sciences and colleagues from the Centre of Contemporary Irish History and the Centre for War Studies. The Roadshow attracted over 6,000 visitors to the campus and was widely covered by RTÉ. A synopsis of the day's events is available on the Institute's website as part of Trinity's contribution to the Decade of Commemorations.

THROUGHOUT THE YEAR THE INSTITUTE ORGANISED THE MAJOR TRINITY EVENTS OF THE PRESIDENT OF IRELAND'S ETHICS INITIATIVE, IN WHICH THE PRESIDENT INVITED THE IRISH UNIVERSITIES TO LEAD A NEW DEBATE ABOUT ETHICS AND THE TYPE OF SOCIETY WE WANT TO LIVE IN.

CYBERETHICS

The rapid growth of cyber technologies and the profound influence of the internet on human behaviour formed the backdrop to the public forum on CyberEthics - CyberLaw | CyberPsychology | CyberBullying on 14 April 2014, organized in conjunction with the RCSI CyberPsychology Research Centre, and the Schools of Law and Education at Trinity. The event was attended by over 190 people and the podcast has been listened to over 700 times to date. The event also garnered great media interest and was covered by RTE Radio 1, East Coast FM and Newstalk. It was featured online by The Journal.ie and the Medical Independent and in the print media by the Irish Times, Irish Independent (above), The Herald and The Metro Herald.

CONSULTATIONS PROGRAMME

The Trinity Long Room Hub Consultations programme, which consists of small circle discussions on issues of national importance bringing together invited members from all sectors of society and academia, was expanded to include discussions as part of the President of Ireland's Ethics Initiative. The Consultations' forum seeks to develop strong partnerships and relationships with a range of organisations in sectors operating outside of academia in Ireland, while highlighting the vital input that Trinity's Arts and Humanities expertise can have on pertinent societal issues.

ANNUAL EDMUND BURKE LECTURE

As part of the Ethics initiative, the distinguished philosopher Baroness Onora O'Neill delivered the inaugural Trinity Long Room Hub Annual Edmund Burke lecture. The event was covered by Newstalk on the Pat Kenny Show and generated two articles in the Irish Times. The Annual Edmund Burke Lectures are made possible by the generous endowment recieved in honour of Padraic Fallon by his family.

"CIRCUMSTANCES MAY BE ESSENTIAL FOR RIGHTS"

Philosopher Baroness Onora O'Neill delivered the inaugural Trinity Long Room Hub Annual Edmund Burke lecture on 'What would Edmund Burke Think of Human Rights?' The first of a series of annual lectures to be delivered by a leading public intellectual on an issue of societal importance, the event was attended by 180 people, with the video of the talk viewed by over 1,000 people, and extensive national media coverage of the event. This lecture marks the deep connection to one of Trinity's most famous graduates.





ADVOCACY

WE WANT TO SHAPE AND DRIVE THE CONVERSATION ON THE FUTURE OF THE ARTS AND HUMANITIES AS CRUCIAL ACADEMIC DISCIPLINES FOR RESEARCH AND IN OUR SOCIETY.



We established the **Annual Humanities Horizons Lecture** to provide a significant contribution to reflection on and advocacy for the Arts and Humanities. The first lecture was delivered in October 2013 by the President of the German Research Foundation, Professor **Peter Strohschneider,** on the topic of 'The Humanities and Society'.

We led the development of an ambitious Horizon 2020 research application that aimed to create an open social platform for linking research producers in the Arts and Humanities with the potential end users of that research from the public, private and policy sectors. We brought a very strong consortium together involving 15 committed and experienced partners from across 12 EU member states and Turkey.

We hosted a Coimbra Group policy seminar in March 2014 on Interdisciplinarity in the Humanities and how universities could encourage and support it. It was attended by Vice-Rectors for Research, Deans, Directors of Humanities Institutes and Centres and Principal Investigators of research groups which included representatives from 18 Coimbra Group member universities and also by Irish Humanities Alliance representatives from across Ireland and Directors of Research from within College.



INTERNATIONALISATION

In developing our international links, we signed a strategic partnership with the Hawke Research Institute of the University of South Australia in Adelaide. The Trinity Long Room Hub hosted visits and signature lectures of the Director, Professor Anthony Elliot, and Deputy Director, Professor Jennifer Rutherford, in 2014. Professor Elliot delivered the Identities research theme Signature Lecture on 29 April 2014 on the subject of 'Reinvention: Identity Transformations and its Consequences'. The Institute Director, ProfessorJuergen Barkhoff, was a distinguished Research Fellow at the Hawke Institute in June and July 2014.



We hosted the first presentation in Ireland of an exhibition 'Labor & Dignity - James Connolly in America' by New York University's Glucksman Ireland House which was funded by the Government of Ireland's Department of Foreign Affairs and Trade as part of Ireland's Decade of Commemorations programme.

ENABLING RESEARCH INFRASTRUCTURE AND ENVIRONMENT

WE ACT AS A CATALYST FOR COLLABORATIONS AND CONVERSATIONS FOR INNOVATIVE RESEARCH AND SCHOLARSHIP INVOLVING STAKEHOLDERS FROM ALL AREAS OF ACADEMIA AND SOCIETY BY CREATING A DYNAMIC RESEARCH ENVIRONMENT, ESPECIALLY FOR INTERDISCIPLINARY RESEARCH PROJECTS.

NEW DEVELOPMENTS

National Collection of Children's Book **Project 2013-15** - We were pleased to provide project support to the National Collection of Children's Books team led by Dr Pádraic Whyte, from the School of English, in partnership with Dr Keith O'Sullivan from the Church of Ireland

College of Education, which was awarded a major Irish Research Council grant to facilitate establish Dublin as a world centre of children's literature research.

The Trinity Centre for Digital Humanities Research – This centre was established in 2013 and is based in the Trinity Long Room Hub. It consolidates the university's Digital Humanities activities, brings together Humanities scholars with colleagues from Computer Science, Engineering and High Performance Computing, and will give greater cohesion and visibility to Digital Humanities at Trinity.

CENDARI Project - In 2013-14, the €6.5 million EU funded CENDARI project, which is coordinated by Dr Jennifer Edmond and her team based in the Institute, completed a mid-term review in which the achievements of the project were deemed commendable by an independent reviewer appointed by the European Commission. The CENDARI Transnational Access Fellowship Programme was also activated and the Trinity Long Room Hub hosted three early career scholars seeking access to a research infrastructure that will help them apply Digital Humanities methods to their historical enquiries.

HIGHLIGHTS 2013-14



In May 2014, Professor Poul Holm, Trinity Long Room Hub Professor of the Humanities, obtained EU COST funding for a four year Oceans Past Platform, led by his research team based in the Trinity Long Room Hub and supporting the development of Environmental Humanities at Trinity. It will establish a European network of historians and archaeologists and researchers from other disciplines to measure and understand the significance and value to European societies of living marine resource extraction and production.

RESEARCH EVENTS AND SUPPORTS

The Principal Investigators based in the Institute were involved in submitting 11 external funding applications for research projects: 5 of these were as partners in bids to the EU's Horizon 2020 programme and 3 were project coordinators. Of the latter Professor Holm was awarded the COST funding mentioned above. In addition, the new dedicated Research Programme Officer for several of our partner schools facilitated 13 grant applications for school based researchers.

205 RESEARCH **RFI ATFD** CONFERENCES, LECTURES, AND **SEMINARS**

Overall, we hosted and promoted 205 research related conferences, lectures, and seminars in the Institute organised by our partnering Schools and the Library.

We facilitated 44 research events organised by other areas of College.

In 2013-14, we provided the infrastructure and promotional support for up to 73 weekly research seminars organised by the Trinity Centre for Early Modern History, the Trinity Centre for Contemporary Modern History, the School of Languages,

Literatures and Cultural Studies and the Biblical and Cognate Studies Research Seminar. Where possible, these are podcasted and made available on our website.

VISITING RESEARCH FELLOWS

THE TRINITY LONG ROOM HUB'S VISITING RESEARCH FELLOWSHIP PROGRAMME IS PIVOTAL TO THE INSTITUTE'S MISSION TO CONNECT OUR RESEARCH COMMUNITY WITH THE MOST DISTINGUISHED SCHOLARS IN THE WORLD AND TO RAISE THE INTERNATIONAL PROFILE OF TRINITY'S ARTS AND HUMANITIES RESEARCH.











During 2013-14 the Institute welcomed 10 visiting research fellows from the United Kingdom, Israel, Beirut, Belgium, Australia and Romania for periods ranging from two weeks to three months. All Fellows engaged with postgraduate students through the research seminars and master classes of their partner schools, and participated in the wide range of research activities in the Institute as well as Trinity's five Arts and Humanities research themes.












PROFESSOR LARISSA ARONIN ORANIM ACADEMIC COLLEGE OF EDUCATION ISRAEL



Larissa Aronin's fellowship was in association with Trinity's Centre for Language and Communication Studies, the School of Linguistic, Speech and Communication Sciences and Trinity's Identities in Transformation research theme. Professor Aronin gave a public lecture entitled 'Bilingualism and Multilingualism - The Same or Worlds Apart?' on 26 May 2014.

PROFESSOR ARONIN EXAMINED THE USE OF MATERIAL CULTURE AS A TOOL FOR SOCIOLINGUISTIC RESEARCH ON INDIVIDUAL AND GROUP IDENTITIES, PROVIDING ILLUMINATING INSIGHTS INTO MINORITY LANGUAGE RESEARCH, SOCIAL WORK PRACTICES AND YIELDING USEFUL IMPLICATIONS FOR THE TEACHING AND LEARNING OF LANGUAGES.

PROFESSOR TARIF KHALIDI AMERICAN UNIVERSITY OF **BEIRUT**



Tarif Khalidi's fellowship was in association with the Department of Near and Middle Eastern Studies in the School of Languages, Literatures and Cultural Studies. Professor Khalidi gave public lectures on 6 March 2014, entitled 'Near Eastern Banditry: A study in History & Folklore', and on 26 March on 'Reflections on Pre-Modern Islamic Physiognomy (Firasa) with particular reference to Fakhr al-Din al-Razi (13th cent.)'. He also gave the Annual Chester Beatty Library lecture on 'Ireland and the Irish in Medieval and Modern Arabic Texts' on 13 February 2014.

PROFESSOR POLLY HA UNIVERSITY OF EAST ANGLIA



Polly Ha's fellowship was in association with the School of Histories and Humanities and the Identities in Transformation research theme. Professor Ha gave a public lecture on her research on 'Recovering the Birth of Independency at Trinity College Dublin Library: Puritanism and Liberty in the Seventeenth Century' on 19 March 2014 and is continuing her collaboration with the Library and colleagues in the Department of History.

PROFESSOR HA'S FELLOWSHIP HAS UNCOVERED HITHERTO UNRECOGNIZED AND UNPUBLISHED MANUSCRIPTS IN THE TRINITY COLLEGE LIBRARY, WHICH ARE THE 'HIDDEN' ARCHIVE OF WALTER TRAVERS, THE SECOND PROVOST OF TRINITY AND A LEADING ELIZABETHAN PURITAN IDEOLOGUE.

They provide information on underground debates among puritans following their suppression by the English Crown which reveal the birth of radical claims to religious independence several decades before the concept was supposed to have existed.

DR JAMES MCCONNEL **NORTHUMBRIA UNIVERSITY**



TRANSNATIONAL ACCESS FELLOW UNDER THE CENDARI **PROGRAMME**

Dr James McConnel's fellowship was in association with the EU funded CENDARI programme to support and stimulate historical research in the two pilot areas of medieval culture and the First World War by facilitating access to key archives, specialist knowledge and collections in CENDARI host institutions.

Dr McConnel's research visit focused on the Irish Songbook during the Great War and aimed to employ digital humanities methodologies to extract data from a range of existing corpora of Irish Great War songs.

DR RAPHAËL INGELBIEN UNIVERSITY OF LEUVEN



Raphaël Ingelbien's fellowhip was in association with the School of English. He gave a public lecture on 24 March 2014 entitled 'How the Irish travelled the Continent, 1829-1914'.

DR INGELBIEN'S RESEARCH VISIT FOCUSED ON THE TEXTUAL PRODUCTION OF THE IRISH TOURIST DURING THE 19TH AND EARLY 20TH CENTURIES AND HOW THAT NEGOTIATED THE NEW IRISH IDENTITIES THAT EMERGED DURING A PERIOD THAT WAS SEMINAL FOR THE (TRANS)FORMATION OF IRISH NATIONALISM.

DR ANDREW MACKILLOPUNIVERSITY OF ABERDEEN



Andrew Mackillop's fellowship was in association with the School of Histories and Humanities. His interests lie in comparative history, especially the highly distinctive experiences of Ireland, Scotland and Wales within British imperialism in Asia over the course of the 'long eighteenth century' from c. 1690-c.1815. Dr MacKillop gave a public lecture on 13 March 2014 entitled 'People and Profit: Irish Human Capital and the Eighteenth Century British Empire in Asia'.

PROFESSOR JENNIFER RUTHERFORD, HAWKE RESEARCH INSTITUTE, UNIVERSITY OF SOUTH AUSTRALIA



Jennifer Rutherford's fellowship was to advance opportunities for inter-institutional collaboration on projects related to Trinity's Identities in Transformation research theme.

She gave a public lecture 'Gate-Crashing: Identification and the Collective Zombie' on 15 January 2014 as part of a special evening of talks on 'Monstrous Identities' to launch the Institute's public lecture series on 'The Transformative Periphery – Negotiating Identities from the Margins'.

DR ROSELLA TINABURI, UNIVERSITY OF CASSINO AND SOUTHERN LAZIO, ITALY



TRANSNATIONAL ACCESS FELLOW UNDER THE CENDARI PROGRAMME

Dr Rosella Tinaburri's fellowship focused on miscellaneous medieval manuscripts in Trinity's library, i.e. on manuscripts conceived as a repository of different texts arranged in a sequence and usually drawn from various sources, whose mutual relations are not always clear to the modern scholar.

HER RESEARCH PROJECT INVESTIGATED THE TESTING OF A MORE COMPREHENSIVE WAY OF DESCRIBING THE TRANSMISSION OF TEXTS AND MANUSCRIPTS IN THE MIDDLE AGES. SHE ENGAGED INTENSIVELY WITH THE DIGITAL HUMANITIES AND THE MANUSCRIPTS, BOOK AND PRINT CULTURES THEMES.

DR ADELA FOFIU. UNIVERSITY OF BABES-BOLYAI, **ROMANIA**



TRANSNATIONAL ACCESS FELLOW UNDER THE CENDARI PROGRAMME

Adela Fofiu's research is focused on inter-ethnic and interdenominational themes in the periodicals published in the province of Transylvania – a site of prolonged nationalist struggles between two cultural worlds, Hungary and Romania.

It will contribute to a larger project at Dr Fofiu's university - the 'Clash of Civilizations or Peaceful Co-Evolution?'. She gave a public lecture on 'Patterns of inter-cultural contact in First World War periodicals in Transylvania' on 13 October 2013.

AS PART OF HER CENDARI FELLOWSHIP AT TRINITY SHE PILOTED INNOVATIVE MEANS OF CONTENT ANALYSIS AND COMPUTER MODELLING TO CONCEPTUALIZE AND VISUALIZE MEDIA FIGURATIONS OF INTER-CULTURAL CONTACT DURING THE GREAT WAR.

PROFESSOR CHARLES J.A. BARR, ST MARY'S UNIVERSITY **COLLEGE TWICKENHAM**



Charles Barr's fellowship was in association with the School of Drama, Film and Music and the Identities in Transformation and Making Ireland research themes. Professor Barr gave a public lecture on 15 May 2014 entitled 'Alfred Hitchcock: the Irish connection, and other untold stories'. Professor Barr used his fellowship to research the only two Sean O'Casey plays produced into mainstream films - by Alfred Hitchcock and John Ford - and how they portrayed Irish identity and have been received over time. Commenting on his experience as a Visiting Research Fellow, Professor Charles Barr noted:

'I SHOULD END BY EMPHASISING THE QUALITY OF THE WORKING ENVIRONMENT OF THE TRINITY LONG ROOM HUB. **EVERYTHING COMBINES TO FACILITATE SCHOLARLY** CONCENTRATION. I WISH I COULD DISTIL THIS QUALITY AND TAKE IT WITH ME, EVERYWHERE I GO FROM HERE'.

EARLY CAREER RESEARCHERS

THE TRINITY LONG ROOM HUB IS DEDICATED TO SUPPORTING OUR PARTNER SCHOOLS' EARLY CAREER RESEARCHERS AND TO INTEGRATING THEM INTO AN INTERDISCIPLINARY COMMUNITY OF SCHOLARS.

RESEARCH SEMINARS

Research seminars are a vital part of the intellectual environment for staff and research students, and invited experts, to enable discussion and knowledge exchange on current research projects with peers and members of the public. As mentioned on page 21, in 2013-14, we provided the infrastructure and promotional support for up to 73 weekly research seminars organised by the Trinity Centre for Early Modern History, the Trinity Centre for Contemporary Modern History, the School of Languages, Literatures and Cultural Studies and the biblical and cognate studies research seminar. Where possible, these are podcasted and made available on our website.

RESIDENT RESEARCHERS

Each year we host, in our state of the art environment, over 50 of our Schools' most outstanding PhD students and Postdoctoral Fellows whose work has been recognized by attracting external funding.

Representing diverse research interests, they are natural agents for promoting inter-disciplinary dialogue and idea exchange and benefit from engaging with each other as well as our visiting research fellows. As part of their residency, they are encouraged to organise research activities that will encourage the participation of students not based in the Institute such as interdisciplinary seminars and reading groups. In 2013-14, our residents helped us organise thesis in three sessions for their Schools which were not only informative and great fun but helped to build confidence and skills around succinct communication of research.

Of special interest to the Schools are the expertise offered by our Research Programme Officer and Accounts Officer.

The Research Programme Officer (RPO), Maureen Burgess, who joined the Trinity Long Room Hub team in 2013, is funded by the Institute and several of our partner Schools as well as College and has provided an invaluable support to staff interested in exploring external funding opportunities or to those who are ready to start applying for external grants.

TRINITY LONG ROOM HUB ANNUAL REPORT 2013-2014

1. WORKSHOPS, SEMINARS AND CONFERENCES

Each year we provide competitive research awards of up to €60K to incentivise individual and collaborative research as well as research related to Trinity's Arts and Humanities themes. Highlights of research outcomes from a selection of projects sponsored by the Trinity Long Room Hub Research Incentive Scheme in 2013-14 include:



FROM SARAJEVO TO TROY: CIVILIANS UNDER SIEGE

IT EXPLORED NEW RESEARCH ON THE PHYSICAL, SOCIAL AND CULTURAL EFFECTS ON CIVILIANS OF ONE OF THE MOST PERSISTENT FEATURES OF WARFARE - THE SIEGE, HOW SIEGES FROM TROY TO SARAJEVO ARE SITES OF ACUTE INTER-RELIGIOUS AND INTER-ETHNIC VIOLENCE AND HOW THE CUSTOMS OF SIEGE WARFARE HAVE BEEN CODIFIED IN LAWS.

Professor John Horne and Dr Joseph Clarke (Department of History, School of Histories and Humanities) with colleagues from the Trinity Centre for War Studies organized a two day international workshop hosted by the Trinity Long Room Hub on 29 February and 1 March 2014. The workshop was highly interdisciplinary, with contributions from historians, classicists and anthropologists. The findings of the workshop will be published in an edited volume of essays, edited by Alex Dowdall and John Horne, in mid-2016. (Supports the Identities in Transformation research theme).

SPONSORED PROGRAMMES AND ACTIVITIES

EARLY IRISH THEATRE, C.1680-1820

FUNDING ALLOWED THE DEVELOPMENT OF A DIGITAL HUMANITIES RESOURCE TO HOST SCHOLARLY EDITIONS OF EIGHTEENTH-CENTURY PLAYS BY IRISH PLAYWRIGHTS, MANY OF WHICH ARE NOT WIDELY AVAILABLE, IF AT ALL, THE PROJECT COMPLEMENTED MARIE CURIE-FUNDED RESEARCH ON THE CENSORSHIP OF BRITISH DRAMA, 1737-1843.

Dr David O'Shaughnessy (School of English) used his funding to produce two critical editions of eighteenth-century plays intended to be used by both scholars and students of the period's theatre: Hugh Kelly, A Word to the Wise (1770), ed. Jerome Devitt; Dennis O'Bryen, A Friend in Need is a Friend Indeed (1783), ed. David O'Shaughnessy [edited from manuscript held at the Huntington Library, Pasadena]. One of the plays was edited by a PhD student in History as part of his structured PhD programme. The eventual public availability of this resource will ensure that scholarly interest and further research into this under-appreciated aspect of Irish eighteenth-century culture can be facilitated on an international basis.

CITIES OF TRANSLATION

THE CITIES OF TRANSLATION THEME IS THE FOCUS OF TWO COLLABORATIVE PROJECTS INVOLVING THE UNESCO CITIES OF LITERATURE AND THE LITERARY TRANSLATION WEBSITE KAFFEEHOUSE.COM. THESE PROJECTS, ALONG WITH THE PAPERS PRESENTED AT THE CONFERENCE, PROVIDE INSIGHT INTO THE RECOGNISABLE NATIONAL IDENTITIES THAT CITIES HAVE AND HOW THEY FUNCTION AS THE CAULDRONS OF CONTEMPORARY CULTURE AND THOUGHT, AND FURTHER THE WORK OF THE CONFERENCE IN ITS MULTIDIMENSIONAL EXAMINATION OF IDENTITY AT WORK IN THE URBAN LANDSCAPE.

This conference organized by Dr Peter Arnds, School of Languages, Literatures and Cultural Studies, analysed three cities in comparison – Dublin, Berlin, and New York – as places of translation, to be understood in the wider sense of moving between languages, cultures, social classes, ethnic groups, topographies, and literatures. The conference attracted scholars from Germany, the UK, Austria, Spain, Ireland, Italy and America, with an equally diverse number of research areas represented, including translation theory, cultural theory, literature, urban theory, and the visual arts.

DOWN THESE GREEN STREETS: AN IRISH CRIME FICTION SYMPOSIUM


THIS SYMPOSIUM – BOTH THE EVENT ITSELF AND ITS OUTCOMES – HAS PROVEN TO BE THE MOST SUBSTANTIAL IRISH CRIME FICTION EVENT EVER HELD, AND HAS CONTRIBUTED DIRECTLY TO THE GENRE'S GROWING PROMINENCE, AS BOTH THE NOVELISTS THEMSELVES AND THE ATTENDEES HAVE NOTED.

Organised by Dr Brian Cliff (School of English) from 22 to 23 November 2013, this symposium was held in partnership with Glucksman Ireland House, New York University. It attracted 17 leading Irish crime novelists, and the best-selling Irish-American crime novelist, Michael Connolly. Over 450 members of the public attended the symposium, which received substantial press coverage. The attendance of an NYU Dean also facilitated the signing of the TCD-NYU Memorandum of Understanding. Scholarly outcomes include two forthcoming book chapters and a forthcoming book, the first monograph on the subject, Brian Cliff, *Irish Crime Fiction: An Introduction* (London: Palgrave, 2017). (Supports the Creative Arts Practice and Identities in Transformation research themes).

RELIGION AND MEMORY: THE 500TH ANNIVERSARY OF THE REFORMATION

THE WORKSHOP FACILITATED COLLABORATIONS ABOUT HOW TO COMMEMORATE THE REFORMATION IN IRELAND IN 2017 AND ABOUT HOW TRINITY COULD GET INVOLVED IN THIS DISCUSSION BOTH WITHIN IRELAND AND IN AN INTERNATIONAL CONTEXT.

The grant to this project was used to support a one day workshop on the theme, 'Religion and Memory: the 500th anniversary of the Reformation' organised in April 2014 by Dr Graeme Murdock from the Centre for Early Modern History (School of Histories and Humanities), with invited speakers from the UK, Germany and the Netherlands. It led to a successful public lecture held in the Trinity Long Room Hub in September 2014 by Dr Margot Kässmann on 'Remembering the Reformation. Challenges of the 2017 Centenary', organised by the Centre for Early Modern History and the Confederal School of Religions, Peace Studies and Theology with support from the Lutheran Church in Ireland and the German Embassy. Dr Murdock also presented a paper to a symposium of the Dublin Council of Churches. (Supports the Identities in Transformations research theme).



THE FUTURE OF THE BODY: PHENOMENOLOGY, MEDICINE AND THE (POST) HUMAN

Funding was awarded to the Medical Humanities research group for a workshop held from 19-20 June 2014. It brought together scholars in Medicine, Medical Humanities, Philosophy and related disciplines. It supported the 'Somatic Identity' thematic cluster under the identities in transformation research theme. This conference addressed questions around what it means to be human as technologies and medical practices increasingly enter previously unchartered territories.

THE AUGUSTAN SPACE: A BIMILLENNIUM CELEBRATION (ROME **AD 14 - DUBLIN 2014)**

2014 marked the bimillenniun of the death of the emperor Augustus on 19 August Ad 14. Funding was allocated to Professor Anna Chahoud, convener of the Manuscripts, Print and Book Cultures research theme to enable the international Augustan Poetry Network to meet for the first time in Dublin (at Trinity) to commemorate this anniversary. The event was co-organised by Professor Anna Chahoud and Monica Gale (Department of Classics, School of Histories and Humanities).

COMPOSITION IN THE 21ST CENTURY

The Trinity Long Room Hub co-sponsored a major international conference, led by Dr Evangelia Rigaki from the School of Drama, Film and Music, and by the Centre of Music Composition and the Creative Arts Practice research theme in association with the New Music Dublin Festival 2014. The Conference addressed aesthetic, technical, practical and economic issues affecting composers of different musical genres today. The keynote speaker was internationally acclaimed composer Sir Harrison Birtwistle.

THE ACADEMIC WORLD IN THE ERA OF THE GREAT WAR

A conference organised by Dr Tomás Irish (TCD) and Dr Marie-Eve Chagnon (Université de Montréal), 14-16 August 2014. Sponsored by Trinity's Centre for War Studies, the Trinity Long Room Hub, and the Department of History and the Cultures, Academic Values and Education Research Centre (CAVE) in the School of Education.

2. PUBLIC LECTURES AND DEBATES

The Institute is committed to demonstrating the relevance and benefits for society of Arts and Humanities research by increasing the visibility and the impact of these projects to wider public and nonspecialist audiences. We connect the university with the wider community and share new scholarly ideas and artistic work by providing a public forum for exciting debates on topical issues.

The following were designed to share and discuss new knowledge arising from research around Trinity's Arts and Humanities-led research themes.



'EUROPE'S VIOLENT MEMORIES 2013-16'

This is a three year public lecture series exploring how wars, their traumatic legacies and contested memories have proven pivotal to the formation of European identities in the 20th century. It is organized in conjunction with the Centre for War Studies and the Centre for European Studies. 2013-14 focused on the legacy of the First World War down to the present. (Supports the Identities in Transformation research theme).


'THE TRANSFORMATIVE PERIPHERY: NEGOTIATING **IDENTITY FROM THE MARGINS'**

How marginal figures and positions challenge mainstream beliefs was the focus of this transdisciplinary public lecture series which addressed a diverse range of topics from zombies, migration and tourism to puritanism and the Argentine tango. It investigated how those at the periphery of society such as the migrant, the vulnerable, the ill, ethnic or religious minorities, but also the radical thinker or the avant-garde artist are crucial for effecting change in society. (Supports Identities in Transformation resesarch theme).



SPONSORED PROGRAMMES AND ACTIVITIES

'DISABILITY AND LITERATURE' LECTURE SERIES



The Institute supported a lecture series on Disability and Literature organized by the School of English in conjunction with the M.Sc. in Disability Studies (School of Social Work and Social Policy) and featuring members of the 'Arts in Education Research Group'. This innovative series of seminars explored the various ways in which disability has been represented in literature from the perspectives of academics, writers, artists and activists in local and **international contexts.** It included speakers from key organisations including the Disability Federation of Ireland, Arts & Disability Ireland and from the field of the contemporary arts. (Supports the Identities in Transformation research theme).

SCOTLAND'S PAST AND FUTURES/EXPLORING THE BIGGER **PICTURE**

The Centre for Irish-Scottish and Comparative Studies in association with the Royal Irish Academy and Trinity's 'Making Ireland' research theme organized a very timely debate on the Scottish Referendum in September 2014 supported by the Trinity Long Room Hub. Coming ten days before the referendum and a day after the first opinion polls had suggested that a majority of Scottish voters favoured independence, the event occurred when Irish public interest in Scotland was at its highest.

THE CONFERENCE PROVIDED A UNIQUE OPPORTUNITY TO DEBATE SOME OF THE BROADER ISSUES, BRINGING TOGETHER HISTORIANS AND POLITICAL SCIENTISTS FROM SCOTLAND AND IRELAND WHO REFLECTED ON THE DIFFERENCES BETWEEN SCOTTISH AND IRISH NATIONALISM, THE CONTENT OF THE DEBATE IN SCOTLAND, AND ON THE WIDER IMPLICATIONS OF THE REFERENDUM FOR IRELAND AND EUROPE, WHATEVER THE RESULT.

SPONSORED PROGRAMMES AND ACTIVITIES



LAUNCH OF THE 'MAKING IRELAND' SEMINAR SERIES

The Making Ireland research theme organised a series of lunchtime lectures in the Spring of 2014 to convene researchers and the public. On 5 March 2014, Professor Sean Duffy gave a talk entitled 'Brian Boru at the Battle of Clontarf: A Medieval version of 1916?'; on March 19th, Professor Jarlath killeen addressed the 'the emergence of Irish Gothic Fiction'; and on 1 April Dr Melissa Sihra explored 'Stratification of Memory, language and place in the theatre of Marina Carr'.

DISCOVER RESEARCH NIGHT 2014

Trinity once again secured funding from the European Commission's Marie Curie Programme to host two more years of Ireland's participation in European Researchers' Night in 2014 and 2015. This is an annual event to raise public awareness of researchers and research careers across Europe.

On 26 September 2014, events and activities were staged across the campus of Trinity College. The Institute worked with our partner schools and research themes to organise activities to showcase some of their tremendous Arts and Humanities research:

- **Skulls, Scripts and Censorship** was a series of 8 workshops related to some of Trinity's leading research on Manuscript, Book and Print Cultures;
- Linguistics researchers grew the **Dublin Language Garden** from the flowers and leaves of the words and phrases of visitors creating a snapshot of the different varieties of languages spoken in Dublin;
- Locating Clarke's Lost Glass was organized by the Library's Digital Resources and Imaging Services team related to the collections of the famous Harry Clarke Stained Glass Studios held in Trinity College Library;
- The Library's **Glucksman Conservation Laboratory** provided visitors with tours of their facilities and introduced them to the research, processes, and skills employed in the care of Trinity's library collections;
- The TCD-led Centre for Global Intelligent Content invited people to become a **digital historian for a night,** providing a personalised journey through the digital archives of the 1916 Rising;
- **Perceived Irishness** invited people to participate in an ongoing research project on Identities in Transformation by PhD student Yaqoub Bouaynaya;
- **The Pregnant Box** (highlighted on pg. 49) explored the narratives of concealed pregnancies and was based on the research of Dr Catherine Conlon, School of Social Work and Social Policy, and the compositions of Dr Evangelia Rigaki from the School of Drama, Film and Music;

SPONSORED PROGRAMMES AND ACTIVITIES

- Michael Gallen, a composer undertaking a PhD in the Department of Music staged his acclaimed Dublin Tiger Fringe Festival funded composition, 'Tardigrade', in order to explore connections and collaborations between musicians and dancers;
- Dr Nicholas Johnson from the Department of Drama created an experimental performance installation entitled 'The Howl Ensemble' in response to Allen Ginsberg's long poem Howl;
- The School of English staged a 'Reading for All Ages' event where the creative side of the School was showcased through readings of poetry and fiction written by staff and students;
- The Centre for Literary Translation and Ireland Literature Exchange hosted a **Translation Slam** with two literary translators; and
- Trinity's Journal of Literary Translation provided a showcase of why human translation can never be replaced by **machine translation**.

Appendix 5.4 UPDATE ON INSTITUTE-BASED PROJECTS 2013-14

Dr Jennifer Edmond, Principal Investigator

CENDARI (The Collaborative European Digital Archival Infrastructure) Feb 2012 – Jan 2016 Sponsor: EUFP7

In March 2014 CENDARI project partners presented the activities carried out in the first 24 months of the project for review by an independent expert, appointed by the European Commission. The report from the Mid-Term Review noted commendable achievements by the CENDARI team in developing the Archive Directory, the Virtual Research Environment (VRE) and the Archival Research Guides. TCD also hosted five visiting fellows as part of the CENDARI Transnational Access Programme in 2013 and 2014, including Dr James McConnel (Northumbria University, UK), Dr Adela Fofiu (Babes-Bolyai University, Romania), Mia Ridge (Open University, UK), Dr Rosella Tinaburri (University of Cassino and Southern Lazio, Italy), and Dr Benjamin Štular (Scientific Research Centre of Slovenian Academy of Arts and Sciences, Slovenia). www.cendari.eu.

EUROPEANA CLOUD (Unlocking Europe's research via The Cloud) (Feb 2013-Jan 2016) Sponsor: EU ICT Policy Support Programme

The principal Investigator for TCD throughout 2014 was Dr Jennifer Edmond, and further research on this project was conducted by Vicky Garnett. TCD's tasks have primarily been investigating and identifying user requirements for tools and content, both existing and potential, as part of Work Package 1. In Autumn 2013, TCD was involved in the organisation of two Expert Forums held in Gothenburg and Amsterdam investigating content and tools within the Humanities and Social Sciences. Throughout most of 2014 TCD's involvement also required close investigation into API use within the Cultural Heritage Sector. This research began in April 2014, and was conducted firstly through desk research and then interviews with leading international researchers in Computer Science and Digital Humanities. In 2014 a research paper was also accepted for presentation at the IDCC15 conference, to be held in London in February 2015. TCD has also contributed to a Content Survey of Europeana by reviewing the 100 largest collections within the portal, and in September 2013, participated in Work Package 5 Strategic Plan meetings in Edinburgh.

NeDiMAH (Network for Digital Methods in the Arts and Humanities) Sponsor: ESF

In 2014 TCD was awarded €7K to organise and host a NeDiMAH/eCloud workshop in The Hague in December 2014 entitled "So We've Built It, But Have They Come?: an API Workshop". This workshop was put together as part of ongoing investigations into API use within the Cultural Heritage Sector, and brought together representatives from cultural heritage institutions who have implemented API use, experienced researchers who make regular use of APIs and 'keen-but-green' researchers who have not used an API to gather data, but wanted to know the potential for their use. The findings of this workshop went on to inform work within Europeana Cloud and a resulting paper delivered in February 2015. Dr Jennifer Edmond is currently co-editing a volume of results from the network (to appear in 2016) called 'Digital Methods and the Scholarly Communications Ecosystem: Downstream from the Digital Humanities'. NeDiMAH ends in May 2015.

SPECTRESS (Social Performance, Cultural Trauma and the Re-establishing of Solid Sovereignties) (Jan 2014-Dec 2017)

Sponsor: EU Marie Curie International Research Exchange Scheme

This is a European Commission funded network of nine international university partners to undertake a four year programme of scholarly exchanges focused on the concept of 'cultural trauma' and national identities. It established a network of participants from Europe (Ireland, Germany, Poland, Croatia and Estonia), Asia (India, Japan) and South America (Brazil), plus the USA, thereby creating a global context for understanding the thorny issue of post-traumatic national self-perception in an era that celebrates the global. The primary modality of interaction is through individual secondments of 3 or 6 months in duration, available to both experienced researchers and early stage researchers. Trinity researchers will have the opportunity to avail of up to 9 secondments over the course of the programme. Likewise it will host, through the Trinity Long Room Hub, an equivalent number from partner institutions. The programme is coordinated by Dr Jennifer Edmond and was launched in April 2014 by a network meeting of all partners which was hosted by the Trinity Long Room Hub. The first of Trinity's researchers to benefit from a secondment under the scheme was Dr Ciaran O'Neill from the School of Histories and Humanities who travelled to Sao Paulo University from July to September 2014.

THE DIGITAL ARTS and HUMANITIES (DAH) PhD PROGRAMME (2011-2015) Sponsor: HEA PRLTI V

The DAH Structured PhD programme is funded under the PRTLI5 initiative and co-funded by the European Regional Development Fund from 2011 to 2015. An inter-institutional, inter-disciplinary structured PhD programme, it can be undertaken either full-time (four years) or part-time (six years). Led by TCD, it combines the strengths of seven Institute partners: National University of Ireland, Galway; National University of Ireland, Maynooth; Royal Irish Academy, University College Cork; Queen's University Belfast; and University of Ulster. The overall coordination of the programme is led by Professor Poul Holm and supported by Joanne D'Arcy, both based in the Trinity Long Room Hub. The programme has an Arts strand and a Humanities strand. The Arts focus is on the application of new technologies in music, drama, and film, including electric sound and image; computer graphics and music; internet; multimedia and other digital-based artistic practices. The Humanities strand focuses on Information Communications Technologies, and opportunities and potential for humanities research, for instance, in editorial practice, management and research of large text bases, image repositories and linguistic corpora.

Cohort I: These students are fully funded by the programme from 2011 to 2015. Of Trinity's 18 students participating in Cohort I, 12 are studying the Humanities strand and are based in the Trinity Long Room Hub. The remainder are based in the Arts Technology Research Laboratory.

Cohort II: TCD has five self-financed students in total in Cohort II (1 Humanities and 4 Arts) for the period 2012-16.

Cohort III: A call for applications for Cohort III was advertised in February 2013 and a DAH information evening took place on 6 February at ATRL. Approximately 70-80 people attended the information evening.

All Cohort I students have been securing their work placement for year three. All TCD Cohort I students will have completed their Innovation Academy by the end of year three.

Professor Holm is also PI on several Environmental Humanities projects including:

HUMANITIES FOR THE ENVIRONMENT (2013-2015) Sponsor: Andrew W. Mellon Foundation

In January 2013 Professor Holm began work on this 36-month project which is led by the European Consortium for Humanities Institutes and Centres. It sponsored a series of think tank workshops to mobilize the humanities to address global climate change and two public lectures by climate change experts, Professor Michael Mann and Professor Kari Norgaard.

IMPACT-EV Project on research and impact evaluation methods for the Humanities (2013-2017) Sponsor: EU FP7

Humanities research has social, economic and cultural impact – but how wide and deep is the impact and can it inform future policy-making? These are the questions guiding this major EU-funded project in which Professor Holm is a partner on a four-year study which commenced in January 2014. Dr Charles Travis and Dr Charles Larkin are research fellows on the project and in 2013-14 the focus was on carrying out interviews with major policy-makers and stakeholders in Europe.
