It was again a momentous year full of new initiatives and exciting developments during which we worked with our partners across the Arts and Humanities and in the Library, and with many other collaborators, to make the Trinity Long Room Hub an even more vibrant and intellectually stimulating place for reflection and exchange, encounter and innovation.

As a research Institute dedicated to the Arts and Humanities, the many different facets of advancing our research agenda are inextricably linked. Addressing research challenges, asking new questions, forging new collaborations, pioneering innovative methodologies for cross-disciplinary discovery, showcasing research results - in all of these dimensions our pursuits come together - in our conferences, workshops, seminars, panel discussions and consultations, our public lectures, readings, performances and exhibitions.

The Institute organises its strategic funding and programmes to support the development of Trinity's Arts and Humanities led research themes and the emergence of new research groupings. The themes draw on a critical mass of research from across the university to focus on addressing some of society's major challenges. They are: **Digital Humanities**; **Identities in Transformation; Creative Arts** Practice; Making Ireland; and Manuscript, Book and Print Cultures. Emerging areas of interdisciplinary research being supported by the Institute are Medical Humanities; Environmental **Humanities** and **Cultural Trauma**. We help facilitate and initiate research in these areas through a variety of means which support individual, collaborative and interdisciplinary research.

A number of important developments and initiatives during the year deserve to be highlighted (with full details available in subsequent sections).


These are addressed according to the key elements of our mission:

## ADVANCING RESEARCH EXCELLENCE

WE SUPPORT AND INCENTIVISE INDIVIDUAL, COLLABORATIVE AND INTERDISCIPLINARY RESEARCH IN THE ARTS AND HUMANITIES.

Our Visiting Research Fellowship Programme is pivotal to advancing research collaborations and projects and plays an important role in raising the international profile of Trinity's Arts and Humanities scholarship. During 2014-15 the Institute, in close collaboration with our partnering Schools and the Library, welcomed 16 distinguished international Visiting Research Fellows for periods ranging from two weeks to three months. Professor Robert Savage of Boston College, a Visiting Fellow in 2012-13, returned to launch his new



publication on *The BBC's Irish Troubles* based on research undertaken during his fellowship.

■ We are transforming the research funding culture across the Arts and Humanities:

We facilitated 37 conferences and workshops supporting our various research themes as well as individual research projects; 20 of these were competitively sponsored through our Research Incentive Scheme to the value of €60K;


We awarded €37K to fund new projects for development in 2015-16;

Over 80 competitive research applications were directly supported through the Hub's and Schools' dedicated Research Programme Officer.

In addition to our support of Trinity's five major Arts and Humanities led research themes (Digital Humanities, Creative Arts Practice, Making Ireland, and Identities in Transformation), we support other collaborative research groupings and emerging areas of critical mass:

Environmental Humanities - Founding director of the Trinity Long Room Hub, Professor Poul Holm was awarded an Advanced European Research Council Grant of €2.5 million by the European Research Council, the first ever Senior ERC award for the Humanities in Ireland. Through this project, he and his team will explore the North Atlantic fish revolution, c. 1400-1700 AD over the next five years. This research builds on the interdisciplinary groupings around Environmental Humanities which the Institute has hosted and supported over the last number of years;





Medical Humanities - A new Medical Humanities research seminar series was launched, bringing together researchers from across the Health Sciences, Social Sciences and the Humanities. A Medical Humanities and Health Initiative arose from this seminar series and a Medical Humanities Steering Committee was formed in June 2015;

Cultural Trauma - The Social Performance, Cultural Trauma and the Reestablishing of Solid Sovereignties (or SPECTRESS) project is a network of nine international university partners that has been funded by the European Commission to undertake a four year programme of research and scholarly exchanges focussed on the concept of 'cultural trauma' and national identity formation. Led by Trinity's Dr Jennifer Edmond, the first cohort of visiting scholars under this scheme arrived in Trinity in 2014-15.

### PUBLIC ENGAGEMENT

THE INSTITUTE IS AN ADVOCATE FOR PUBLIC HUMANITIES AND A FORCE FOR DRIVING TRANSFORMATIVE CHANGE IN THE COMMUNICATION OF ARTS AND HUMANITIES RESEARCH BY ARTICULATING ITS VALUE TO WIDER AND MORE VARIED AUDIENCES.

During 2014-15 a series of initiatives and developments significantly increased the capacity and reach of the Institute's public outreach:

- Two new event formats were instituted to increase the public facing engagement of Trinity's Arts and Humanities research and also to enable collaboration with colleagues and other disciplines across College. These included the 'Behind the Headlines' discussion series and the 'First Up' lecture series, both highlighted in the following pages.
- All sixteen of the Institute's Visiting Research Fellows gave public lectures on their research projects at Trinity. Collectively, the podcasts of their lectures have received 632 plays to date.
- Building on the success of the 2013 and 2014 Discover Research Nights, we facilitated the organisation of many Arts and Humanities activities as part of European Researchers Night on September 25th 2015.
- We delivered the second year of the Europe's Violent Memories Lecture series (see highlights).

Overall, in the period October 2014 to September 2015 we facilitated and promoted over 250 research related conferences, lectures, and seminars in the Institute organised by our partnering Schools and the Library; we also facilitated 44 research events organised by other areas of College.

60% OF THESE PUBLIC ENGAGEMENT ACTIVITIES ARE PODCASTED. THE 2014-15 PODCASTS HAVE RECEIVED 5,000 PLAYS, WITH ALMOST HALF OF THESE FROM OUTSIDE OF IRELAND, ENCOMPASSING 49 COUNTRIES AROUND THE WORLD.





#### **PUBLIC HUMANITIES PROGRAMME**

In recognition of the importance of Trinity's Arts and Humanities in contributing to greater public understanding of societal issues, in January 2015, Terry and Marjorie Neill, both Trinity alumni, gave a major donation to facilitate the development of a five year public humanities programme led by the Trinity Long Room Hub. We very gratefully acknowledge Terry Neill's tremendous and manifold support. His close involvement, his width of perspective, his wealth of experience and his very practical hands-on support for the Institute and its objectives and for the whole Arts and Humanities has been transformative over the last few years.

#### **BEHIND THE HEADLINES**

The Behind the Headlines public discussion series was introduced to offer background analyses to current issues by experts drawing on the long-term perspectives of Arts and Humanities research. It aims to provide a forum that deepens understanding, combats simplification and polarization and thus creates space for informed and respectful public discourse.

# EUROPE'S VIOLENT MEMORIES

War Trauma and Identity in the 20th Century: Lecture Series 2013-2016

This three-year series of public lectures delivered by eminent international scholars in different disciplines, including history, literary and film studies and memory studies, explored how war, its traumas and its contested memories have proved pivotal to the formation of European identities in the 20th century. Each year the series adopts a different focus.

The focus of the second instalment of the three-year series, in 2014-15 marked the seventieth anniversary of the end of the Second World War in 1945, and focused on the extreme violence of the Second World War and the ways in which this has shaped subsequent European memories and identities.

The series was organized by the Centre for War Studies (School of Histories and Humanities) and the Centre for European Studies (School of Languages, Literatures and Cultural Studies) in association with the Trinity Long Room Hub.



# BEHIND THE HEADLINES

Multi-award-winning Irish author Colm Tóibín gave a public talk focusing on same-sex relationships and literature on Thursday May 14th in Trinity College Dublin. The talk, organised by the School of English as part of the Institute's **Behind the Headlines** series, focused on the representation of same-sex relationships in Irish and international literature, his experience of being a gay man and gay writer in Ireland and recent social, cultural and legal changes relating to same-sex relationships in Ireland.

Colm Tóibín's talk was followed by a panel discussion featuring academics who responded to the lecture and discussed the representation of same-sex relationships in literature. This discussion, chaired by Professor of English Nicholas Grene, featured Dr Paul Delaney, Assistant Professor in English, Trinity, Dr Heather Ingman, Adjunct Professor in English, Trinity, and Professor Danielle Clarke, School of English, Drama, and Film, UCD.

The event attracted significant international media attention including an interview with Colm Tóibín in the Washington Post online edition (52 million readers globally), which featured a photo of Colm in Trinity's front square and the Trinity Long Room Hub's audio recording of the event, which was carried in the online edition of The Irish Times. There was also remarkable coverage on Social Media. An audio podcast and media coverage of the event secured significant attention on Twitter. Highlights included tweets from Saoirse Ronan (99.5k followers) and Fintan O'Toole (43k followers). Over all, 72,726 Twitter accounts were reached with 206,631 impressions (total number of times tweets were delivered to timelines). Colm's Tóibín's opinion piece in the Irish Times, which was an abridged version of his talk in Trinity, was one of the Top Five articles read and was also promoted on the paper's App.

# FIRST UP: CREATIVE ENTREPRENEURS ON BREAKING THROUGH



#### **ADVOCACY**

**The Humanities World Report, 2015** was launched in the Institute in June 2015. Authored by Trinity Long Room Hub Professor of Humanities, Poul Holm, Professor of History at Stockholm University, Arne Jarrick, and Senior Lecturer in Philosophy at University of Kent, Dr Dominic Scott, this report was the first worldwide examination of the value of humanities research around the globe.

The new book was formally launched by Professor of Anglo-Irish Literature and Drama, Margaret Kelleher, UCD who is also a Member of Science Europe's Humanities Committee, at a special event in Trinity College Dublin.

The Humanities World Report presents a first step towards assessing the state of the humanities globally. The research is based on extensive interviews conducted with 90 humanities scholars across 40 countries as well as an in-depth literature review. Topics include the nature and value of the humanities, the challenge of globalisation, the opportunities offered by the digital humanities, variations in funding patterns around the world, and the interaction between humanities and society.


The picture that emerges from this report is that humanities scholars are deeply committed to the social value of their work and appreciate the long-term importance it has for addressing global challenges.

Commenting on the significance of the book, Trinity College author, Professor Holm said:



"We provide much-needed information on the global condition of Humanities research. We aim to provide an overview of new emerging research fields and of the institutional conditions in which research is conducted. The interviews in particular give a whole new perspective by giving voice to humanities scholars in Africa, Asia and Latin America. We were struck by the vitality of humanities. Contrary to what is often said the humanities are not in crisis but more vital than ever."





#### INTERNATIONALISATION

#### STRATEGIC PARTNERSHIP WITH FUDAN UNIVERSITY

In developing the Trinity Long Room Hub's international links, the Institute signed a Memorandum of Understanding with the Development Institute, Fudan University as part of the President of Ireland's State visit to China in December 2014. It is aimed at developing research partnerships in the area of transforming identities as an important mutual strategic step towards the expansion of Humanities research via international collaboration.

In 2013, President Michael D. Higgins launched Trinity's 'Identities in Transformation' research theme in the Trinity Long Room Hub. It involves a multi-faceted exploration of the memories and stories that contribute to a sense of identity especially where these are contested memories.

As a central part of this collaboration, the Trinity Centre for Asian Studies will work specifically with the Fudan International Centre for Studies of Chinese Civilisation. Professor Xu Ning-sheng, President of Fudan University, said: 'Fudan attaches great importance to the strategic partnership relation with Trinity College Dublin and we see a great potential in the cooperation with TCD in arts and humanities research on the platform of FDDI and ICSCC.

#### PARTNERSHIP WITH HAWKE RESEARCH INSTITUTE


We strengthened the strategic relationship with the Hawke Research Institute, University of South Australia and welcomed a Hawke Visiting Fellow, Dr Mary Knights, Director of the South Australian School of Art Gallery, for 6 weeks in May 2015. She is participating in the Hawke's EU funded Centre on Mobilities Migrations and Cultural Transformations.

# ENABLING RESEARCH INFRASTRUCTURE AND ENVIRONMENT

#### **NEW DEVELOPMENTS**

Trinity Long Room Hub PI, Dr Jennifer Edmond became a partner on a new Digital Humanities project called Parthenos, which was funded as part of a bid to the EU's Horizon 2020 programme. PARTHENOS stands for "Pooling Activities, Resources and Tools for Heritage E-research Networking, Optimization and Synergies", and is aimed at strengthening the cohesion of research in the broad sector of Linguistic Studies, Humanities, Cultural Heritage, History, Archaeology and related fields through a thematic cluster of European Research Infrastructures, integrating initiatives, e-infrastructures and other world-class infrastructures, and building bridges between different, although tightly, interrelated fields. PARTHENOS is led by PIN (Italy) and has 16 partners.


#### **RESEARCH EVENTS AND SUPPORTS**

We facilitated and supported Trinity's five Arts and Humanities led research themes in their preparations for international strategic reviews in June 2015, including the provision of additional financial and technical support to help with building coherence and visibility through website development.


In consultation with the Directors of Postgraduate Teaching and Learning in our partner Schools and other College unites, we are currently developing a new pilot programme of workshops to help early career researchers in the Arts and Humanities shape their academic goals and future career paths. Some of these will be in partnership with the Schools and others with external partners such as the Irish Humanities Alliance. We supported the introduction of the thesis in three presentation format to our Schools to help students articulate the importance of their research in a fund and succinct way.

We introduced a new communications and promotional strategy for new research grants and monographs from our Schools –with 25 new research publications promoted online in 2014-15. We also began to host book launches for Schools and facilitated 7 book launches.


























# VISITING RESEARCH FELLOWS

THE TRINITY LONG ROOM HUB'S VISITING RESEARCH FELLOWSHIP PROGRAMME IS PIVOTAL TO THE INSTITUTE'S MISSION TO CONNECT OUR RESEARCH COMMUNITY WITH THE MOST DISTINGUISHED SCHOLARS IN THE WORLD AND TO RAISE THE INTERNATIONAL PROFILE OF TRINITY'S ARTS AND HUMANITIES RESEARCH.











During 2014-15 the Institute welcomed **16** Visiting Research Fellows which included scholars from Europe, Australia, Canada and the US for periods ranging from two weeks to three months. All fellows engaged with postgraduate students through the research seminars and master classes of their partner Schools, and participated in the wide range of research activities in the Institute as well as Trinity's five arts and humanities research themes.





















Fellows progress their major research projects, work with the unique collections of Trinity College Library, and engage intensely with colleagues and students from cognate areas within the university and in other institutions on collaborative research.

#### PROFESSOR CAROLYN **MUESSIG, UNIVERSITY OF** BRISTOL



Carolyn Muessig's fellowship was in association with the School of Histories and Humanities and Trinity's Manuscript, Book and Print Cultures research theme. Professor Muessig gave a public lecture entitled 'Responses to a most unusual miracle: understanding the stigmata in the Middle Ages' on 18 November 2014.

Specializing in the study of preaching in the Middle Ages, Professor Muessig had intended focusing on the Library's papal letters and Inquisition material during her fellowship. However she also discovered an unpublished diurnal used by Italian Dominican nuns which she believes is the only manuscript witness to the liturgical office of the stigmatic Catherine of Siena.

#### PROFESSOR MAURO PALA, UNIVERSITY OF CALIGARI



Mauro Pala's fellowship was in association with the School of Languages, Literatures and Cultural Studies and the Identities in Transformation research theme. He gave a public lecture on 25 March 2015 entitled 'Gramsci and the Great Community: Subalternity, Hegemony and Autonomy in Irish Literature and Culture'.

Susan O'Neill's fellowship was in association with the School of Drama, Film and Music and the Arts Education Research Group in the School of Education. She gave a public lecture on 'Enhancing Wellbeing in Later Life: Multimodal Affordances of Intergenerational Arts Practice' on 26 May 2015.

#### **DR ANDREW MURPHY,**UNIVERSITY OF ST ANDREWS



Andrew Murphy's fellowship was in association with the School of English and the 'Identities in Transformation' and 'Manuscript, Book and Print Cultures' research themes. Dr Murphy gave a talk on 'Bringing the Nation to Book: Literacy and Irish Nationalism' on 18 May 2015.

Dr Murphy completed research tracing the emergence of an Irish 'common reader' over the course of the nineteenth century. At the time, many Irish cultural commentators considered popular reading to be potentially debasing and de-nationalising, as Irish readers were seen as being troublingly attracted to the cheap products of the London print trade.

She gave a public lecture on 9 February 2015 entitled 'From Sinai to the Skelligs: Evidence for Cultural Contact Between the Insular and Near Eastern Churches, including New Material from St Catherine's Monastery'.

THE FELLOWSHIP FACILITATED THE RESEARCH AND WRITING OF AN IMPORTANT ARTICLE ON THE BOOK OF ARMAGH, ONE OF TCD'S MOST IMPORTANT EARLY MANUSCRIPTS.

'The Hub research environment, with its aesthetic and practical benefits and its extended opening hours, was thoroughly conducive to sustained, focused work, and to quick trips back to base from library, museum and teaching environments in order to feed findings back into the research. The atmosphere was vibrant, exhilarating and inter-disciplinary. It was a wonderful opportunity to learn of research in other arts and humanities areas and periods and to have input from fellows outside of one's usual discipline and peer group.'

# PROFESSOR ANTHONY CALESHU, UNIVERSITY OF PLYMOUTH



Anthony Caleshu's fellowship was in association with the School of English. He used his fellowship to progress research on friendship as a magnanimous force towards creative practice. He gave a public lecture on 22 October 2014 entitled 'Poetry and Friendship: Creative Practice and Critical Reading'.

His fellowship helped him to advance the final drafting of *The Victor Poems*, a collection of poems, which has subsequently been published by Searsman; and the completion of a long poem, 'To Be an Epicurean', which was subsequently published in The Manchester Review 14 (2015); as well as facilitating long-term plans to publish a book on 'The Poetics of Friendship.'

#### PROFESSOR PATRICK JOYCE, UNIVERSITY OF MANCHESTER



Patrick Joyce's fellowship was in association with the School of Histories and Humanities. He was focused on conducting research for his third book on freedom and power in British history, following *The Rule of Freedom* (Verso, 2003), and the *State of Freedom*. He gave two public lectures during his visit: 'The Children of Freedom: The Time-Spaces of History' on 2 March 2015 and 'What is the State (and can we remake it?): Historical Perspectives' on 9 May 2015.

The History research seminars are always podcasted and those for 2014-15 have been played up to a thousand times on our website.

# INSTITUTE STAFF

In 2014, we appointed a full time Events and Promotions Officer, Sarah Dunne. The Events Officer promotes all events based in the Hub or associated with us through our growing mailing list and social media channels as well as through posters and on our website. This role is important in highlighting the visibility of our Arts and Humanities events to a wider public audience and in helping the Schools with promotional activity around research initiatives. Also of special interest the Schools are the expertise offered by our Research Programme Officer and Accounts Officer. The Research Programme Officer (RPO) in funded by the Trinity Long Room Hub and several of our partner Schools as well as College, and provides an invaluable support to staff interested in exploring external funding opportunities.



# MEMORIES AND IDENTITIES IN CENTRAL AND EASTERN EUROPE


THE CONFERENCE ADDRESSED THE PROBLEM OF MEMORY FROM THE PERSPECTIVE OF SEVERAL DISCIPLINES (HISTORY, POLITICS, SOCIOLOGY, GEOGRAPHY, CULTURAL STUDIES AND LINGUISTICS) AND LED TO THE SUBMISSION OF A PROJECT APPLICATION TO THE EU'S HORIZON 2020 PROGRAMME, INVOLVING DR APOR AS A PARTNER, WHICH WAS FUNDED IN 2016.

# UNCONVENTIONAL WARFARE: GUERRILLAS AND COUNTER-INSURGENCY FROM IRAQ TO ANTIQUITY

Organised by the Trinity Centre for War Studies, this conference brought together speakers from universities across Ireland, the UK, US, France and Belgium. It led to an exciting exchange of ideas on the commonalities and contrasting experiences of conflict across disparate geographic and chronological contexts the outcomes of which will be published in an edited collection of essays Unconventional Warfare from Antiquity to the Present Day by Palgrave MacMillan in 2017. (Supported the Identities in Transformation research theme).



THIS CONFERENCE EXAMINED THE LIVED EXPERIENCE (THEORY AND PRACTICE) AND HISTORICAL REPRESENTATION OF COUNTER-INSURGENCY AND GUERRILLA WARFARE, INCLUDING EXPLORATION OF FIGHTERS' IDEOLOGICAL EVOLUTION AND THEIR RELATIONSHIPS WITH THE COMMUNITIES FROM WHICH THEY EMERGED. THE RESPONSES AND STRATEGIES OF CONVENTIONAL FORCES AND STATES WAS ALSO CONSIDERED.









# STAINED GLASS, RELIGION AND NATIONAL IDENTITY IN 19TH AND 20TH CENTURY IRELAND: THE HARRY CLARK STUDIOS

Funding was granted to the Digital Resources and Imaging Services Team in the Library to organise a symposium to draw attention to the archival material from the famed church decoration and stained glass firm J. Clarke & Sons, and its successor Harry Clarke Stained Glass Limited, as well as its digital surrogate, the Clarke Studios Demonstrator project. The outcomes from the symposium included the appointment of a PhD student researching the Harry Clarke Archive in the Department of Art History and to a scholar in NUIG examining stained glass windows from the Studios in several African churches. The Harry Clarke design also featured on the Trinity Long Room Hub's window as part of this symposium. (Supported the Making Ireland research theme).

THE SYMPOSIUM DEMONSTRATED HOW THE ARCHIVE COULD BE USED TO ADDRESS WIDE HISTORICAL AND SOCIAL ISSUES, INCLUDING TOPICS SUCH AS RELIGIOUS HISTORY, GENDER ISSUES, NATIONAL IDENTITY, MIGRATION STUDIES, AND POST-COLONIAL STUDIES.



# FAITH-BASED CONFLICT RESOLUTION AND PEACEMAKING IN PALESTINE

Funding was given to Dr Carlo Aldrovandi in the School of Religions, Peace Studies and Theology, to support a field trip to Israel and the West Bank in September 2015 to conduct interviews with key representatives of religious Zionist and ultra Orthodox communities, non-government organisations and political parties. (Supported the Identities in Transformation research theme).

THE MAIN OUTPUT WAS TO SET THE FOUNDATIONS OF A LONG TERM RESEARCH AGENDA TO BRIDGE A SUBSTANTIAL GAP BETWEEN SECULAR, RATIONALITY BASED APPROACHES AND MORE RELIGIOUSLY EMBEDDED UNDERSTANDINGS AND PRACTICES OF CONFLICT RESOLUTION AND DIPLOMACY IN THE MIDDLE EAST. Dr Tom Walker, School of English, organised a conference in July 2015 to examine various modes of poetic collaboration in the period 1890-1940. The theme of partnerships between poets and collaborators such as publishers, translators, musicians, painters, photographers, filmmakers and theatre practitioners brought interdisciplinary theories and practices to the debate. Several articles based on the research presented are to be published in a special issue of the journal *Modernist Cultures*, published by Edinburgh University Press, in 2018 to be edited by Dr Walker and Dr Alex Runchman of the School of English.

### WHEN GERMAN EYES ARE SMILING

As much as literary translation involves a dialogue between a translator and an author, it also necessitates a dialogue between the literary heritage of two cultures. Funding was given to Prof Sarah Smyth, Director of the Centre for Literary Translation, to support a practitioners' workshop of German-language literary translators and Hiberno-English writers, giving them the opportunity to discuss their experiences, challenges and creative solutions.

# AUTONOMOUS PROFESSIONAL OR A MECHANISTIC DELIVERY ROBOT: AN EXPLORATION OF THE IDENTITY OF IRISH, FINNISH AND ENGLISH TEACHERS

The ways in which autonomy or its absence affects the formation of teachers' professional identities in three different cultural contexts formed the basis of this study. Dr Maija Salokangas from the School of Education was given funding to investigate the effects of freedom within pedagogical practice and the pressures for increased public accountability on teaching professionals in Ireland, England and Finland.

This new series was organised in conjunction with the School of Medicine. Each lecture touched on an aspect of Medical Humanities from the perspective of a different discipline. These events offered the opportunity to see medicine through the eyes of academics who are concerned with literary, historical, philosophical, aesthetic and technological perspectives of health, illness, disability and practice.



### **DISCOVER RESEARCH NIGHT 2015**

Trinity once again secured funding from the European Commission's Marie Curie Programme to host Ireland's participation in European Researchers' Night on 25 September 2015. This is an annual event to raise public awareness of researchers and research careers across Europe. Events and activities were staged across the campus of Trinity College. The Institute worked with our partner schools and research themes to organise activities to showcase some of their tremendous Arts and Humanities research:

- Linguistics students and researchers invited the public to join them in the **Dublin Language Garden** to explore language use in Dublin and Ireland;
- The Library's Glucksman Conservation Laboratory provided visitors with tours of their facilities and introduced them to the research, processes, and skills employed in the care of Trinity's library collections and their Digital Imaging Resources Team helped visitors explore the Library's collections online;
- Researchers chatted about projects such as 'Bloomsday's Big Data: Tweetflickrtubing James
  Joyce's Ulysses (1922)'; 'The 1641 Depositions'; 'The Down Survey of Ireland'; 'Consuming
  Culture En Route: Readers, Books in Series, and the Railway Bookstall in Late-Victorian Ireland
  and England' and 'Archaeological Figures in 3D';
- The Centre for Literary Translation and Ireland Literature Exchange hosted a **Translation Duel** with two literary translators to showcase translation as creative practice; there were talks and tours on art history and architecture.

### Appendix 5.4 UPDATE ON TRINITY LONG ROOM HUB HOSTED RESEARCH PROJECTS 2014-15

### **Dr Jennifer Edmond, Principal Investigator**

### **PARTHENOS**

(May 2015 - April 2019) Sponsor: EU H2020

The PARTHENOS project commenced in May 2015. TCD is led in PARTHENOS by Dr Jennifer Edmond, with Vicky Garnett as researcher (commencing September 2015). The project aims to strengthen the cohesion of research in the broad sector of Linguistic Studies, Humanities, Cultural Heritage, History, Archaeology and related fields through a thematic cluster of European Research Infrastructures, integrating initiatives, e-infrastructures and other world-class infrastructures, and building bridges between different, although tightly interrelated fields. TCD's work in this project during 2014-15 was largely within WP2, investigating user requirements within the community, with a focus on aspects that can inform the work on developing training and skills development opportunities, which is being led by TCD.

# SPECTRESS (Social Performance, Cultural Trauma and the Reestablishing of Solid Sovereignties) (Jan 2014 - Dec 2017) Sponsor: EU Marie Curie International Research Exchange Scheme

This is a European Commission funded network of nine international university partners to undertake a four year programme of scholarly exchanges focused on the concept of 'cultural trauma' and national identities. The programme is coordinated by Dr Jennifer Edmond. It established a network of participants from Europe (Ireland, Germany, Poland, Croatia and Estonia), Asia (India, Japan) and South America (Brazil), plus the USA, thereby creating a global context for understanding the thorny issue of post-traumatic national self-perception in an era that celebrates the global. In 2014-15, the programme of secondments began in earnest, with TCD sending out 4 researchers to conduct research in Sao Paulo and Delhi, and receiving its first fellow from Brazil. The resulting multidisciplinary and multicultural reflections on the network theme of 'cultural trauma' can all be found on the project website: https://spectressnetwork.wordpress.com/. In addition to these bilateral exchanges, the network also held a week-long training school in Dubrovnik in May 2015. Attended by staff and students from across the network partners and beyond, the School gave experienced and early stage researchers alike an excellent opportunity to compare approaches and national trends in the discussion of cultural trauma.

### CENDARI (The Collaborative European Digital Archival Infrastructure) Feb 2012 – Jan 2016 Sponsor: EUFP7

This €6.5M project is coordinated by Dr Jennifer Edmond with the support of Deirdre Byrne as Project Manager. In January 2015 the CENDARI project held its fourth annual General Assembly meeting in Paris which coincided with a Sustainability Workshop, co-hosted with DARIAH (the Digital Research Infrastructure for the Arts and Humanities). The workshop brought together representatives of CENDARI, the DARIAH Virtual Competency Centres (VCCs) and partner/affiliate projects to focus on the opportunities and requirements for sustainability through DARIAH or the project outputs from CENDARI and other related projects. The workshop was the beginning of a collaborative process which will result in CENDARI producing a Sustainability Plan before the end of the project. The project will enter its final year in 2015/2016 and the partners will prepare to launch the final CENDARI infrastructure in January 2016.

SPARKLE (Scholarly Primitives and Renewed Knowledge-Led Exchanges) (March 2015 - September 2015) Sponsor: Irish Research Council Government of Ireland "New Foundations" Scheme

Led by Dr Jennifer Edmond, in collaboration with Dr Alexander O'Connor (DCU), and Dr Naveen Bagalkot from Srishti Labs in India. Supporting research was conducted by Vicky Garnett in TCD. The SPARKLE project aimed to extend the scope and activities of an existing multidisciplinary network to address the gap in understanding and scholarly practice in interdisciplinary projects. This was conducted through a close observation of the knowledge creation process of humanist, mapping and documenting their cognitive journey from source to understanding. In the period 2014-15, TCD conducted interviews with leading academics within the humanities to determine any patterns within everyday scholars practices. Plans were also put in place for a workshop to be held early in the 2015-16 academic year.

# EUROPEANA CLOUD (Unlocking Europe's research via The Cloud) (Feb 2013-Jan 2016) Sponsor: EU ICT Policy Support Programme

The primary researcher for TCD throughout 2014-15 was Vicky Garnett, supported by project PI Dr Jennifer Edmond. TCD's tasks were primarily investigating and identifying user requirements for tools and content, both existing and potential, as part of Work Package 1. The 2014-15 period began with continued work into data reuse, particularly with APIs among the AHSS research community. This culminated in a workshop, funded through NeDiMAH, held in The Hague in December 2014, which investigated uses of APIs in cultural heritage projects as well as those of researchers to learning how to use such methods. The outputs from this workshop as well as the desk research and interviews conducted since April 2014 were presented in a paper at the IDCC15 conference, held in London in February 2015. From March 2015, TCD was engaged in further work with WP1 to determine how specific research topics might be used within the Europeana context. This work continued beyond the period of reporting here. TCD also collaborated with colleagues at DCU Athens, and UGOT to produce a poster for delivery at the King's College London "Blue Skies Above, Solid Ground Below" conference in June 2015, and participated in a workshop in July 2015 at University College London covering the lessons learned from Europeana Cloud and how they can be developed in Europeana Research.

## NeDiMAH (Network for Digital Methods in the Arts and Humanities) Sponsor: ESF

In 2014 TCD was awarded €7K to organise and host a NeDiMAH/eCloud workshop in The Hague in December 2014 entitled "So We've Built It, But Have They Come?: an API Workshop". This workshop was put together as part of ongoing investigations into API use within the Cultural Heritage Sector, and brought together representatives from cultural heritage institutions who have implemented API use, experienced researchers who make regular use of APIs and 'keen-but-green' researchers who have not used an API to gather data, but wanted to know the potential for their use. The findings of this workshop went on to inform work within Europeana Cloud and a resulting paper delivered in February 2015. Dr Jennifer Edmond is currently co-editing a volume of results from the network (to appear in 2016) called 'Digital Methods and the Scholarly Communications Ecosystem: Downstream from the Digital Humanities'. NeDiMAH ends in May 2015.

# THE DIGITAL ARTS and HUMANITIES (DAH) PhD PROGRAMME (2011-2015) Sponsor: HEA PRLTI V

The DAH Structured PhD programme is funded under the PRTLI5 initiative and co-funded by the European Regional Development Fund from 2011 to 2015. Led by Trinity, it combines the strengths of seven Institute partners: National University of Ireland, Galway; National University of Ireland, Maynooth; Royal Irish Academy; University College Cork; Queen's University Belfast; and University of Ulster. In its first year the programme funded 18 students who engaged in their final year of their PhD in October 2014-September 2015. All are expected to submit their thesis on track. Subsequent cohorts were self-funded or Irish Research Council funded. The majority engaged with this programme on a part time basis and were self-funded. It is expected that a no cost extension will be offered up to December 2016.

Professor Holm is also PI on several Environmental Humanities projects including:

# Oceans Past Platform (Networking European marine environmental history) (2015-2018) Sponsor: EU COST Network

Professor Holm is leading the three year COST Action T (OPP) which aims to measure and understand the significance and value to European societies of living marine resource extraction and production to help shape the future of coasts and oceans. The integrative platform will lower the barriers between human, social and natural sciences; multiply the learning capacity of research environments; and enable knowledge transfer and coproduction among researchers and other societal actors, specifically by integrating historical findings of scale and intensity of resource use into management and policy frameworks. www.tcd.ie/history/OPP

# IMPACT-EV Evaluating the Impacts and Outcomes of European SHH Research (2014-2018) Sponsor: EU FP7

Humanities research has social, economic and cultural impact – but how wide and deep is the impact and can it inform future policy-making? These are the questions guiding this major EU-funded project in which Professor Holm is a partner on a four-year study which commenced in January 2014. Dr Charles Travis and Dr Charles Larkin are research fellows on the project and in 2013-14 the focus was on carrying out interviews with major policy-makers and stakeholders in Europe. Dr Marisa Ronan is now undertaking the final deliverables of the project.

European Observatory of the New Human Condition (Integrating Humanities for the Environment) (2013-2016) Sponsor: Andrew W. Mellon Foundation

In January 2013 Professor Holm began work on this 36-month project which is led by the European Consortium for Humanities Institutes and Centres. It sponsored a series of think tank workshops to mobilize the humanities to address global climate change. During this report period interest in developing a Global Observatory of the New Human Condition beyond 2016 is being discussed.
