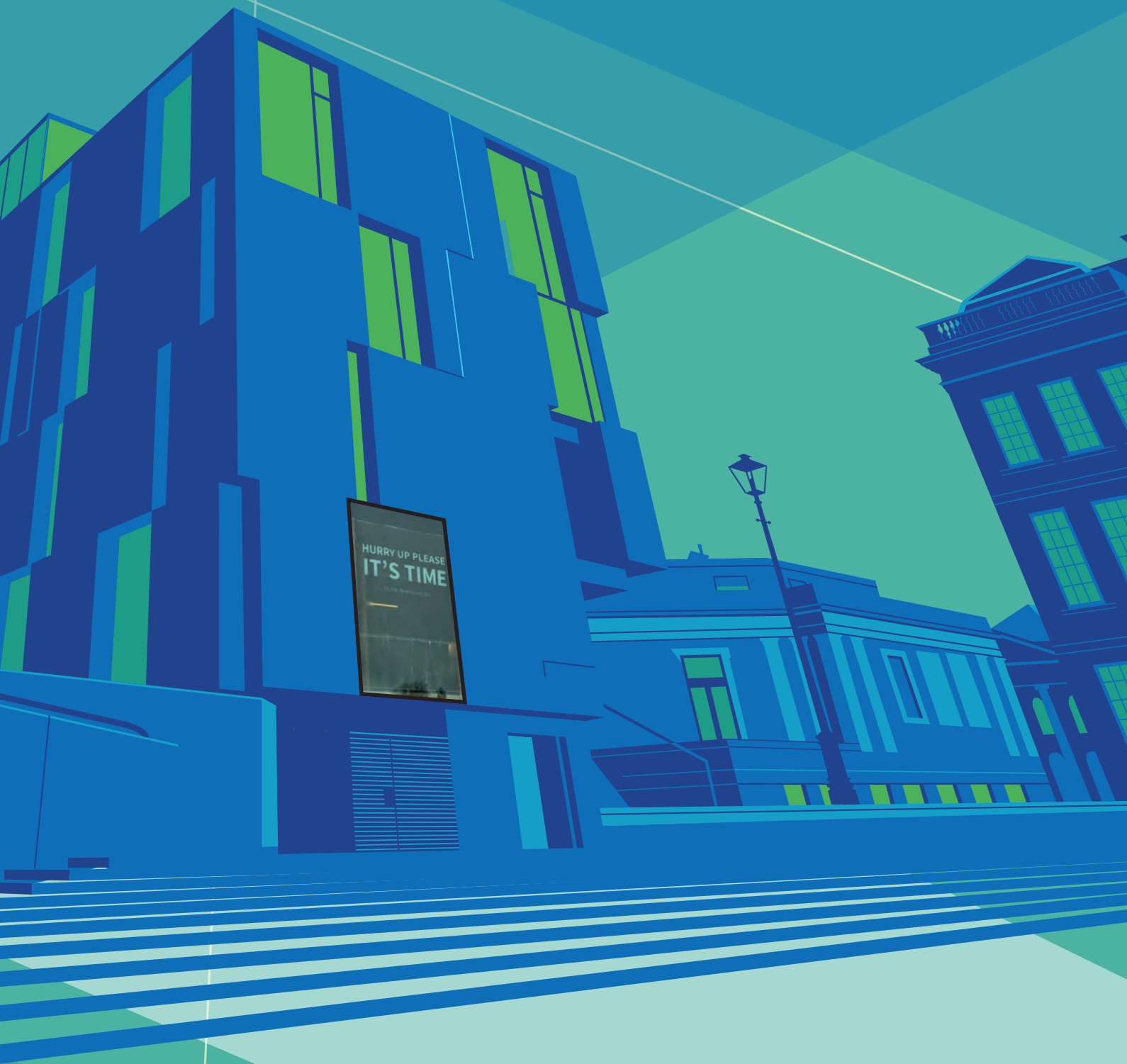

MESSAGE FROM THE DIRECTOR

Professor Eve Patten



If one thing is clear from the academic year 2022-23 it's that Trinity research is visibly thriving right across our partner schools and the wider Arts and Humanities community. Thinking thematically, many of our research initiatives this year have turned to aspects of communication. We have discussed the changing vocabulary of children's books in our Behind the Headlines series; the translation of cetacean acoustics with one of our distinguished visiting fellows; the languages of digital technology through the EU-funded Human+ programme and History of the Future Podcast, and the possible meaning of the secret code in the first folio displayed at the 'Shakespeare the Irishman' Library exhibition. How language works in its many forms (and how – as T. S. Eliot wrote of poetry – it can often communicate even before it is understood) connects all our interests and disciplines.

We have also shared work on communication in times of political crisis, through our Annual Humanities Horizons Lecture with Professor Lyndsey Stonebridge and in many related discussions where Trinity's researchers have continued to speak to, and condemn, the humanitarian crisis of the war in Ukraine. We have brought together academics and politicians to revisit the aspirations of the Good Friday Agreement and reconsidered the language of apartheid in our research partnership with the University of Western Cape, a partnership now cemented in the Charlotte Maxeke-Mary Robinson Visiting Research Chair.

A highlight of the year was the launch of the new Trinity Centre for the Book, which, together with the Institute's participation in the PublishOA.ie Research Consortium, signals our commitment to the written heritage of Ireland's past and to both print and digital bibliodiversity in Ireland's future. Researching the world's varied forms of communication, including the rich communication of books, is a way of protecting language itself against degradation and loss. And in this context, we have ended the academic year by marking the United Nations Decade of Indigenous Languages with a poignant window display onto Fellows' Square featuring lines from 'Small', by Trinity poet and scholar Eiléan Ní Chuilleanáin.

We continued to support our vibrant research community in their individual and collaborative research, sharing their research findings through our public events, videos, podcasts, website, social media, newsletter and through the media. I want to congratulate the many members of our research community who published new research and received funding awards, some of which you will find highlighted in this report under 'community celebrations'. We were also driven to gather many colleagues across the Arts and Humanities and the wider university faculties in Trinity and beyond to discuss the new proposed Research and Innovation Bill, which will change the funding landscape of Ireland for years to come. In our advocacy role, we were determined to use our platform and voice to ensure that there was parity of esteem between the disciplines when the new funding body is formed. That is why I was one of the many signatures of a letter to the Minister, which was delivered to his department in-person in May and featured in the *Irish Times*.

We take particular pride in supporting our Early Career Researchers, over 40 of whom are provided with a dedicated study space each year. This year, we organised many skill-building workshops for this community and in the spirit of fostering public-engaged scholars, we challenged our researchers to go deeper and bolder in creating visual representations of their research. We also hosted nine international fellows working on fascinating projects with our partner schools, including Professor Roisín Higgins' 'A Sensory History of the Troubles', and Dr Susan Manly's research exploring Maria Edgeworth's attitude towards West Indian and especially Jamaican slavery in the early nineteenth century. Many of the fellows were spotlighted in our weekly fellow in focus lunchtime public conversations, where university staff, students and members of the public gathered to interact with them. For information on our fellows, research projects and initiatives, I invite you to review the past academic year with us in the pages that follow.

Trinity Long Room Hub forges unprecedented new partnership in South Africa

This inaugural Humanities Chair emerges out of a longstanding collaboration between the Trinity Long Room Hub Arts and Humanities Research Institute at Trinity College Dublin and the Centre for Humanities Research at UWC. Relationships and networks forged through these institutions' fellowship programmes have laid the groundwork for an historic announcement made on the 15 March 2023 by H.E. Fionnuala Gilson, Ambassador of Ireland to South Africa, and the Rector and Vice-Chancellor of the University of the Western Cape (UWC), Professor Tyrone Pretorius at the Centre for Humanities Research, University of Western Cape.

Through funding support from the Irish Department of Foreign Affairs, the initial phase of the work of the Research Chair will bring scholars and artists in Ireland to Southern Africa, hosted by the UWC's Centre for Humanities Research. The Trinity Long Room Hub has already begun the work of raising additional funds to bring scholars and artists from South Africa to Trinity. The reciprocal commitment of the Research Chair formalises and expands the purposeful relationship between the two institutes and will support the study of concepts in Irish Studies in southern Africa and the study of concepts in South African Studies in Ireland.



The Research Chair's themes will explore arts and archives of post-partition societies; technology and the human, society and aesthetic education; poetics and post-partition futures and new models of reconciliation and peace in the wake of colonialism, partition and apartheid. In July 2023, it was announced that Professor Eoin McNamee, esteemed Irish author and lecturer in

Trinity's School of English and Oscar Wilde Centre, would take up the inaugural Research Chair delivering a keynote lecture entitled 'Sequins, Pearls and Amobarbital: the Border in Ireland as Unconcluded Space', at the CHR's celebrated international Winter School in August 2023. In his inaugural lecture, Professor McNamee discussed how he uses the literary form as a way of talking about the border, sectarian tensions, and the complicated narratives of the Troubles. The talk, which was followed by a fascinating Q&A discussion, was delivered to an audience of distinguished scholars and artists, including SARChI Chair in Visual History and Theory Patricia Hayes, and lawyer and activist Albie Sachs, one of the chief architects of the post-apartheid constitution of 1996.

Earlier in July 2023, during his visit to South Africa, Tánaiste, Minister for Foreign Affairs and Minister for Defence Micheál Martin delivered a lecture to inaugurate the Charlotte Maxeke – Mary Robinson Research Chair and open an exhibition on 25 years of the Good Friday Agreement.

The Tánaiste said the Government of Ireland was "proud and pleased" to support the new Research Chair which would draw on the "close historical ties" between Ireland and South Africa. He welcomed the fact that the Charlotte Maxeke – Mary Robinson Chair was established in an Irish university known for its resistance to apartheid, noting that Trinity had hosted the South African politician and UWC academic Kader Asmal, founder of the Irish anti-apartheid movement, as Professor in Law and Human Rights during his 27-year exile in Ireland.

The podcast, co-hosted by entrepreneur, and Democracy Forum Media Fellow, Mark Little, and Dr Ellie Payne, Coordinator of the Democracy Forum, has already been downloaded more than 4.5K times.

'The History of the Future' was officially launched by the Provost of Trinity College Dublin, Dr Linda Doyle, at an in-person event in the Trinity Long Room Hub on 8 February, 2023. Mark Little and Dr Payne explained their motivation and journey in co-creating the series and were joined by Dr Jennifer Edmond, Associate Professor of Digital Humanities at Trinity and Bruce Shapiro, Executive Director, Dart Center for Journalism and Trauma at Columbia University, who feature in episode one and episode three respectively.

Pioneering venture sees launch of Trinity's first Researcher Impact Framework



This is the question at the centre of Trinity's new 'Researcher Impact Framework' (RIF), a new open-access guide developed by Dr Giovanna Lima, Trinity's first Research Impact Officer hosted by the Trinity Long Room Hub, and Sarah Bowman from the Office of the Dean of Research and lead of Trinity's Research Impact Unit pilot. Launched as part of a discussion event in the Trinity Long Room Hub on 12 October 2022, the RIF will assist researchers in identifying, recognising, and valuing the multiple activities of academic life by building and communicating a comprehensive awareness of their scholarly labour with accurate impact statements and supporting indicators.

The RIF stems from work developed by Giovanna and Sarah as part of Trinity College Dublin's Research Impact Pilot, pioneered by the Office of the Dean of Research, the Trinity Long Room Hub, and the School of Medicine.

Commenting on the publication of the RIF, Professor Eve Patten, Director of the Trinity Long Room Hub said: "This is a pioneering venture that reflects the embedding of impact awareness in our everyday research activity. The authors are to be congratulated on an excellent publication, which will be of value to academics at every stage of their research career."

New Centre for the Book will make Trinity a world leader in history of the book

In April 2023, the Trinity Long Room Hub announced that the new Trinity Centre for the Book will be hosted in the Trinity Long Room Hub in collaboration with the Library of Trinity College Dublin.

Launched as part of the celebrations for the 400th anniversary of Shakespeare's first folio which went on display at the Library of Trinity College Dublin on the 13 April 2023 ('Shakespeare the Irishman'), the Trinity Centre for the Book aspires to make Trinity a world leader in the field of the history of the book.

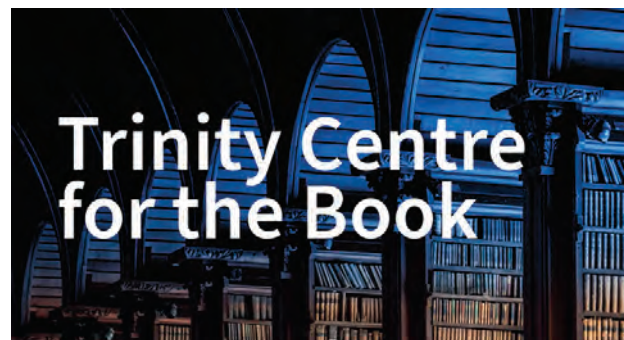
From the use of written word to recent developments in non-alphabetic forms of communication such as emojis and the emergence of AI-driven content generation engines such as ChatGPT, the Centre will look at all aspects of the history of the book to broaden our understanding of its rich cultural and social importance, and the role it has played in communicating knowledge and lived experience across millennia.

The new centre led by Dr Mark Faulkner, School of English, will capitalise on Trinity's outstanding Library collections that span thousands of years, from the Egyptian Books of the Dead to the

Library's rapid response collecting initiative 'Living in Lockdown' – a hybrid collection of physical works and born digital submissions.

The centre, which builds on the work of the Manuscript, Book and Print Cultures research theme, will also harness the university's significant concentration of expertise, with more than 150 researchers publishing over 1,000 works on book history over the last ten years. This includes expertise from academic staff across English, Arts History, Modern Languages, Classics, History, Religions, Education and Computer Science.

Trinity's Colonial Legacies Project prompts public discussion on University's history

Trinity Colonial Legacies (TCL) is a 2-year project which seeks to contextualise and historicize the university's deep links to colonialism both in Ireland itself and in the wider world. It also seeks to raise awareness of college's physical and intellectual colonial legacies, monuments, and endowments in the present. The Trinity Legacies Review Working Group chaired by Professor Eoin O Sullivan, Senior Dean, has now concluded engagement around two initial issues of concern to the University and members of the public, namely the return of the Inishbofin remains and the denaming of the Berkeley Library.

Dr Ciaran O'Neill, Deputy Director of the Trinity Long Room Hub, has been working alongside colleagues Dr Patrick Walsh and Dr Mobeen Hussain (School of Histories and Humanities) as part of the Trinity Legacies Review Working Group to oversee the research, analysis and public consultation of the case of the Inishbofin remains which was the first case to be considered by the group.

In February, a decision was approved by the Board of the University to return human remains to the island of Inishbofin, from where they were taken without the community's consent more than a century ago. The remains were returned to the island community in July 2023, preceded by a private handover ceremony in Trinity College Dublin attended by the Provost Linda Doyle.

In advance of the Board's decision, the Trinity Long Room Hub's popular Behind the Headlines forum held an online discussion in February on 'Returning Remains: Context, Consent and Colonialism' where panellists addressed the complexities and tensions surrounding the retention or reburial of human remains in the museum and university sectors. Leading the discussion, Dr Ciaran O'Neill said that "over the past academic year Trinity College Dublin has begun the necessary work of listening to communities of origin for some of the human remains stored on site, and in particular those taken from a graveyard on the offshore island of Inishbofin in July of 1890."

Speaking on the panel Professor Samuel Redman, University of Massachusetts at Amherst detailed his experience in the museum sector in North America where he has worked on questions of repatriation, particularly in relation to native American communities. He highlighted how “the Smithsonian Institution, at its peak, had an estimated 38,000 sets of human remains”, and a further estimate suggesting that there may be up to 500,000 sets of native American remains held in US repositories and institutions, with a further 500,000 sets of human remains held in European institutions, including the British Museum.

In April, a further decision taken by the Trinity College Dublin Board, responded to the calls to de-name the Berkeley Library due to the philosopher’s links with slavery. This process, also overseen by the Trinity Legacies Review Working Group, involved several months of research, analysis and public consultation in their efforts to consider legacy issues on a case-by-case basis.

Trinity’s Provost Dr Linda Doyle said:

“The landscape of a university, especially one as old as Trinity, is not static. Each generation of students and staff deserves a chance to influence decisions. In this case, it was our students who called on us to address the issue. We welcome their engagement, and we thank the Trinity Legacies Review Working Group for its assistance in providing evidence-based information to underpin this decision.

“George Berkeley’s enormous contribution to philosophical thought is not in question. However, it is also clear that he was both an owner of enslaved people and a theorist of slavery and racial discrimination, which is in clear conflict with Trinity’s core values.”



Indigenous knowledge and the ‘more than human’ explored by new Rooney Writer Fellow

Poet, pacifist and fabulist Nidhi Zak/Aria Eipe was appointed as the 2023 Rooney Writer Fellow at the Trinity Long Room Hub.



Nidhi Zak/Aria Eipe's first collection, *Auguries of a Minor God*, was published by Faber & Faber in 2021. A finalist for the Dylan Thomas Prize, John Pollard Foundation International Poetry Prize and the Butler Literary Award, it was chosen as a Poetry Book Society Recommendation, National Poetry Day Recommendation, Shakespeare & Co. Year of Reading Selection, and a Book of the Year by both the Irish Times and The Irish Independent.

During her tenure as the Rooney Writer Fellow, Nidhi researched a project titled ‘Honey and the Hare’, exploring the human relationship to the more-than-human across both ancient Celtic and Indian traditions, and ultimately how indigenous wisdom

and practices recognising the interconnectedness of being can provide enduring responses to intersecting ecological crises. This transdisciplinary project draws inspiration from Joseph Beuys’s 1965 performance ‘How to Explain Pictures to a Dead Hare’ and an anonymous Middle English poem ‘The Names of the Hare’, investigating the symbolism of the Hare linking to Vedic, Buddhist, Celtic and Gaelic deities, alchemy, the moon and the feminine while also exploring connections in folklore, mythology and deep ecology.

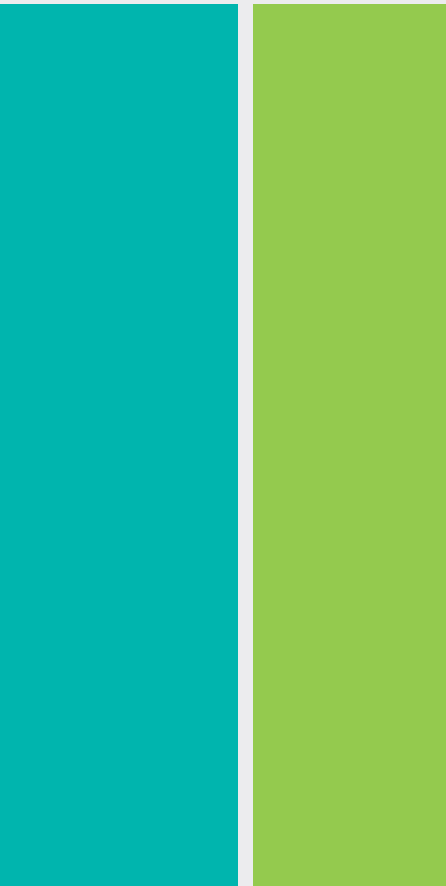
The Rooney Writer Fellowship was launched in 2021 by Dr Peter Rooney, Director of the Rooney Prize Foundation. The Fellowship enables a creative writer to join the research community in the Trinity Long Room Hub and to engage with the institute’s many research projects and initiatives. The inaugural Fellow in 2022 was author Caitríona Lally.

In the Trinity Long Room Hub’s popular ‘Fellow in Focus’ lunchtime discussion in April, Nidhi sat down with fellow poet and writer Seán Hewitt of Trinity’s School of English to discuss her project at the Trinity Long Room Hub and to explore how communicating without written language and without a narrative brings us closer to the more-than-human world.

Ireland's Border Culture



Ireland's Border Culture: Literature, Arts, and Policy (IRBORDCUL) is a two-year collaboration between Professor Eve Patten, TCD, and Dr Garrett Carr of the Seamus Heaney Centre at Queen's University, Belfast. Funded under Strand 1 of the HEA Shared Island North-South Research programme, it will bring literary and visual resources from Irish border culture and identity to life in order to illuminate Ireland's 'cultural borderscape.' In January 2023, Dr Orla Fitzpatrick commenced in the role of Ireland's Border Culture Research Fellow. Her background is in librarianship and her main research interests are Irish photographic and design history. Her book *Lost Ireland* was published by Rizzoli and Pavilion in 2021. She curated 'Imaging Conflict: photographs from revolutionary era Ireland', a major exhibition at the National Museum of Ireland which opened in October 2022. This looked at the production and consumption of photographic images in conflict situations.

First digital directory of Irish publishers launched on Bloomsday 2023

PublishOA.ie – a research consortium funded by the National Open Access Forum (NORF) – is conducting an all-island feasibility study into creating a comprehensive Open Access digital infrastructure designed to meet the needs of authors, readers, publishers and funders in Irish scholarly publishing. The research consortium has 10 partners and is co-led by the Royal Irish Academy and the Trinity Long Room Hub. There are eight affiliate organisations. The funding for this project was approved by the National Open Research Forum (NORF) at the end of 2022 and the project will run until November 2024.

One of the key outputs from this project was published in June 2023, on Bloomsday, with the first digital directory of Irish publishers by PublishOA.ie. The Directory of Irish Publishers is an all-island map of the Irish publishing landscape, listing over 180 active book and journal publishers. From Belfast to Bantry and from Dublin to the Galway Gaeltacht, Irish publishers are active as never before.

Human+ fellowship programme



The Human+ research fellowship programme at Trinity College Dublin is an interdisciplinary programme connecting computer science researchers with researchers from the arts and humanities and enterprise to forge a human-centric approach to technology development for the long-term betterment of society. Co-funded by the European Commission's Marie Skłodowska-Curie actions, the project has currently appointed 6 experienced researchers for a 2-year post-doctoral programme.

Human+Tech Talks

The programme conducted a series of 'Tech Talks' during the academic year 2022-23 with discussions from Human+ fellows on ethics and AI, identity and behaviour in the digital world, the future of robots and personalised online education systems.

Human+ Fellows Dr Kata Szita, Dr Qian Xiao, Dr Nicola Palladino, and Dr Pat Treusch discussed these prescient technological questions with multi-disciplinary teams of supervisors, enterprise mentors, and other key specialists in this area.

Dr Dalila Burin joins the Human+ Program:

In April 2023, HUMAN+ welcomed its latest research fellow to the team, Dr Dalila Burin. She has a PhD in Neuroscience from the University of Turin and has previously worked at the Smart Ageing Research Centre in Tohoku University and the International Research Centre for Neurointelligence at the University of Tokyo. Dr Burin has combined her background in cognitive neuropsychology with Immersive Virtual Reality (IVR) techniques to improve physical and cognitive functions in both young people and the elderly. Her HUMAN+ research project, ‘BStrongBSmart,’ in collaboration with her two mentors Dr Rachel McDonnell, Associate Professor at the School of Computer Science, and Dr Nicholas Johnson, Associate Professor of Drama, advances these interests with a human-centric approach: she will explore how visual manipulations of the virtual body can affect the physical body, in terms of cognitive and physiological reactions. This can have a beneficial impact on physical exercise for performers (such as dancers) and preserve bodily functions in the case of elderly people or those with motor disorders.

SHAPE-ID (Shaping Interdisciplinary Practices in Europe)

In its April 2023 report, LERU (the League of European Research Universities), a world-leading association of 23 research universities, lauded the Trinity Long Room Hub-led Shape-ID project’s role in contributing to its analysis of the current academic and policy landscape. ‘Implementing interdisciplinarity in research-intensive universities: good practices and challenges’, provides an important update to LERU’s seminal 2016 study on interdisciplinarity whose findings have been referenced worldwide. It also acknowledges the key insights that the SHAPE-ID consortium has made to the field of interdisciplinary research since the 2016 report. A Hub-organised SHAPE-ID webinar on the LERU report also took place on May 23rd 2023 with representatives from LERU and Science Europe and was chaired by Professor Jane Ohlmeyer.

A theme of ‘broadening perspectives’, with an expanded focus on culture and life, was evident in the dialogues that ran throughout the forum’s busy day, which explored the possibilities of creating truly human-centred innovation and policy, and an ethical and engaging marketplace for culture.

A selection of recent awards and achievements across our Arts and Humanities schools

New €2.4m Trinity-led Horizon Europe transdisciplinary education project

Congratulations to Mairéad Hurley, Assistant Professor School of Education, on the launch of the 'LEVERS project' which has been funded by the European Commission, UKRI & SERI to investigate the potential of localised learning ecosystems to support community climate responses in nine countries: Ireland, the UK, Portugal, Belgium, Switzerland, Slovenia, Serbia, Greece, and Cyprus.

Seán Hewitt awarded 2022 Rooney Prize for Irish Literature

Congratulations to Seán Hewitt (School of English) who was awarded the 2022 Rooney Prize for Irish Literature at a ceremony in Trinity College Dublin in October 2022.

The €10,000 Rooney Prize, awarded annually since 1976, celebrates an outstanding body of work by an emerging Irish writer under 40 years of age. It is administered by the Trinity Oscar Wilde Centre for Creative Writing in the School of English, Trinity.

Virtual Record Treasury of Ireland team awarded prestigious Ellis Prize

The Archives and Records Association (UK and Ireland) awarded the prestigious Ellis Prize to the Virtual Record Treasury of Ireland, marking the first time the prize has been presented to a group rather than an individual.

The Virtual Record Treasury of Ireland is a research programme working to digitally recreate the state archives destroyed by fire in 1922. Led by historians Peter Crooks and Ciaran Wallace at Trinity College Dublin the Virtual Treasury is funded by the Department of Culture under the Decade of Centenaries Programme (2012-2023).

New publication of the letters, writings, and speeches of Oliver Cromwell

The Letters, Writings, and Speeches of Oliver Cromwell (Oxford University Press) includes a volume edited by Micheál Ó Siochrú, Professor in Modern History, which was launched by British Ambassador to Ireland Paul Johnston at an event in Trinity Long Room Hub on Mon, 28th November, 2022.

The three-volume publication consists of more than 1,000 items. It not only publishes newly identified material, but also edits a large number of items from recovered originals, which have not previously been edited.

Jane Ohlmeyer wins prestigious European Research Council Advanced Grant

Professor Jane Ohlmeyer, Erasmus Smith's Professor of Modern History (1792) in the School of Histories and Humanities, won a highly prestigious European Research Council (ERC) Advanced grant valued at €2.5m. The project, to be based at the Trinity Long Room Hub, is entitled 'VOICES: Life and Death, War and Peace, c.1550-c.1700: Voices of Women in Early Modern Ireland.'

Professor Ohlmeyer, former director of the Trinity Long Room Hub, has been awarded a 2023 Royal Irish Academy Gold Medal in the Humanities, and she has also been elected as a fellow of the British Academy.

School of English World University Rankings

The latest QS World University Rankings by Subject sees Trinity College's English Language and Literature taking Ireland's highest rank at 22nd in the world. Trinity is ranked in the top 100 universities in the world in the Arts and Humanities more generally.

Centre for Literary Translation celebrates 10 years

Congratulations to the Trinity Centre for Literary and Cultural Translation who celebrated their 10-year anniversary in 2023. Provost Linda Doyle was the guest of honour at a celebration held to mark the 10th anniversary since the Centre was launched by the late Seamus Heaney in 2013.

Based in Fenian Street, the Centre's current director is Dr James Hadley. The Centre's mission is to develop, promote and support literary translation in Ireland through education and outreach; publications; and community building.

400 years after publication, Ireland's only copy of Shakespeare's First Folio goes on display

Congratulations to the Library of Trinity College Dublin and Andrew Murphy, Professor of English and curator of the First Folio exhibition, 'Shakespeare the Irishman' which marks 400 years since the Bard's complete works were first published. Research Incentive Scheme funding facilitated the delivery of this public exhibition along with a conference on *Hibernicising Shakespeare*.

Ireland's only copy of Shakespeare's First Folio was the centrepiece of the exhibition launched in April 2023 by author Anne Enright at a ceremony in the Old Library.

ERC Grant worth €2.5m awarded to Trinity's Professor Christine Casey

Congratulations to Professor Christine Casey, School of Histories and Humanities, who has been awarded a European Research Council (ERC) Advanced grant for her project CRAFTVALUE to examine the collective achievement in Anglo-Irish architectural endeavour during the period 1700-1800.

New Library sculptures honouring trailblazing women

On climate change and the environment:

Behind the Headlines: how can the Arts and Humanities respond to ecological destruction?

Responding to the devastation of the First World War, T.S. Eliot wrote of showing ‘fear in a handful of dust’ in his monumental 1922 poem, *The Waste Land*.

On the centenary of the poem’s first full publication, and against the backdrop of COP27, the United Nations’ Climate Change Conference, the Trinity Long Room Hub’s ‘Behind the Headlines’ discussion held on 10 November 2022 discussed how the Arts and Humanities can respond, creatively, to ecological devastation, and whether such responses amount to effective climate protest.

“What we want to do this evening is to engage T.S. Eliot’s imagery, 100 years on, as a springboard to thinking about waste lands, both actual and potential, in the context of climate crisis”, said Professor Eve Patten, Director of the Trinity Long Room Hub, in opening the event.

Supported by the John Pollard Foundation, the Behind the Headlines series offers background analyses on current issues from experts drawing on the long-term perspectives of Arts & Humanities research. The panel for this discussion, titled ‘Waste Lands: Imagining Climate Catastrophe’, featured award-winning Irish filmmaker Neasa Hardiman; Conor Brennan, an Early Career Researcher in Germanic Studies; Dr Cathriona Russell, Professor in Trinity’s School of Religion; and Dr Yairen Jerez Columbié, an eco-poet and Assistant Professor in Trinity’s School of Languages, Literatures and Cultural Studies.

On democracy and resistance:

Michael Ignatieff delivers sixth Annual Edmund Burke Lecture



‘Democracy and the Legacy of Revolutionary Violence’ was the theme of the sixth Annual Edmund Burke Lecture delivered by Canadian writer, historian and former politician Michael Ignatieff in October 2022. From American independence in 1776 to Ireland after the 1916 Easter Rising, many of the world’s democracies have their origins in moments of revolutionary violence, Ignatieff told a packed audience in Trinity College’s Burke Theatre where he also discussed the works and theories of Edmund Burke in relation to liberalism today, and tackled the question of how democracies with a revolutionary heritage manage their historical memory of foundational violence.

‘Totalitarianism and the Humanities’ focus of the Annual Humanities Horizons Lecture for 2023

“What do oppressive political cultures find so upsetting about books and reading?” asked Professor Lyndsey Stonebridge, Interdisciplinary Professor of Humanities and Human Rights at the University of Birmingham, as she delivered the Trinity Long Room Hub Annual Humanities Horizons Lecture in April 2023 on the subject of ‘Totalitarianism and the Humanities’ in Trinity’s Thomas Davis Theatre.

The Annual Humanities Horizons Lecture was established by the Institute to provide an opportunity to reflect on and advocate for the disciplines of Arts and Humanities. As this year’s distinguished guest lecturer Professor Stonebridge — author of numerous books including the recent *Writing and Righting: Literature in the Age of Human Rights* (2020) — described her honour at being invited to speak at the “prestigious” research institute.

Drawing in part from her forthcoming book *We Are Free to Change the World: Hannah Arendt’s Lessons in Love and Disobedience*, she turned to the political philosopher’s writing on twentieth-century totalitarianism and the book which made Arendt an “academic celebrity” in the US, *The Origins of Totalitarianism*, to explore how humanities are back in the frontline of ideology and politics.

Ukrainian President Volodymyr Zelenskyy addresses third-level students of Ireland

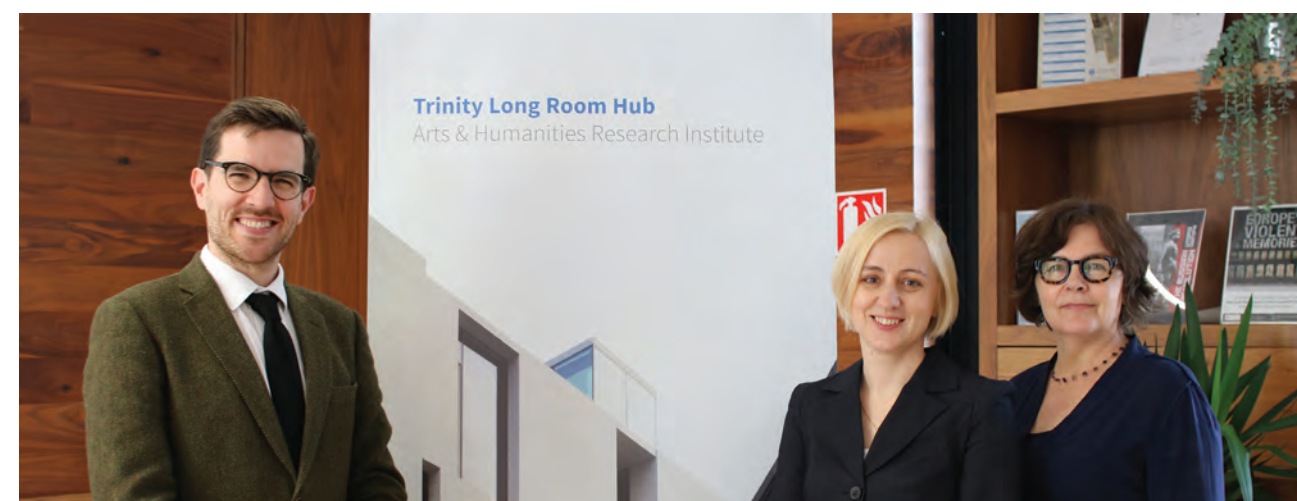


A full audience in the Trinity Long Room watched as President Zelenskyy discussed the ongoing war in Ukraine, taking live questions from students at Dublin City University. The event was organised by the Trinity Long Room Hub’s Democracy Forum and was followed by an in-person panel discussion on democracy, EU support for Ukraine, and European values, with the German Ambassador to Ireland, Mr Cord Meier-Klodt, and the Deputy Head of Mission of the Embassy of the Czech Republic in Ireland, Mr Filip Vurm. Trinity’s Dean of the Faculty of Arts, Humanities and Social Sciences, Professor Gail McElroy, chaired the discussion. A recording of the event is available to view on our website.

Fighting Fascism? The Historical Roots of the Russian-Ukrainian Conflict

For its war of aggression against Ukraine the Russian Federation has invoked claims of neo-Nazism and a supposed genocide against the Russian-speaking majority population in Ukraine. How should we understand this disinformation? What episodes of modern Ukrainian history does the Russian regime chose to use instrumentally to legitimate its warfare, and why? This lecture in November 2022 delivered by Dr Per A. Rudling, Associate Professor of History and 2019-2024 Wallenberg Academy Fellow at the Department of History at Lund University, and organised by the Trinity Centre for European Studies, provided a background to the difficult and undigested past, interethnic violence and the Holocaust in Ukraine, and how it has come to be used as a political instrument to legitimise war and conquest.

Ukraine's Constitutional Futures



Ukraine's constitutional structures have regularly been revised since its independence. While it was already moving on a path towards closer association with Europe, new urgency for progressing EU membership presents a significant challenge for Ukraine to bring its laws, governance structures, and judiciary in line with highest international standards, including in the field of human rights protections. In this discussion from May 2023, Dr Svitlana Khyliuk from the Ukrainian Catholic University in Lviv, Ukraine spoke to Dr David Kenny (School of Law, TCD) about Ukraine's possible constitutional futures after the war; the challenges of aligning Ukraine's legal system with that of the EU; Ukraine's identity and its place in Europe; and the ongoing war and how it impacts on her work in the Law School in Lviv. In advance of this discussion, Dr Svitlana Khyliuk and Dr David Kenny spoke to the Pat Kenny radio show on Newstalk.

Rashid Khalidi delivers lecture on 'The Hundred Years' War on Palestine'

In a lecture at the Trinity Long Room Hub in May 2023, Professor Rashid Khalidi told audience members and guests from the Mission of the State of Palestine in Ireland that he has witnessed in recent years a "growing willingness" among people to appreciate the Palestinian narrative and that he hoped his new book *The Hundred Years' War on Palestine: A History of Settler-Colonialism and Resistance, 1917-2017* (2020) would appeal to a wider general audience. The event was organised by the Trinity Long Room Hub in partnership with the School of History, UCD. Professor Khalidi, who spent two months as a fellow in the Trinity Long Room Hub in 2022, said that in any history he has ever read, he can find no evidence of conflict in Palestine between Jews and Arabs until the British arrived. He described Zionism as a "settler colonial project" not dissimilar to that which took place in Australia and the United States. "Every colonial conquest", he noted, "has always engendered the resistance of the colonised", adding that it has always been necessary to delegitimise the resistance by characterising it as criminal or with other negative associations.

On futures of Ireland:

Censorship, Media, and Conflict: The Case of Northern Ireland

On Thursday, 15 December 2022, the Trinity Long Room Hub's Democracy Forum and Boston College convened a panel of journalists, legal experts, and historians to discuss the broadcasting bans introduced by the governments in London and Dublin as violence escalated in the Northern Irish conflict in the 1970s and 1980s. Eve Patten, Director of the Trinity Long Room Hub, opened the discussion with the quotation from George Orwell that is inscribed beside his statue at the BBC headquarters: "If liberty means anything at all, it means the right to tell people what they do not want to hear." She posed the question: "were public broadcasters able to maintain their commitment to the freedom of speaking and hearing during the traumatic events and scenes of the Troubles?" What followed was a fascinating panel discussion about the broadcasting ban, state censorship, and the Troubles by Robert Savage, Professor of History at Boston College and former Trinity Long Room Hub Visiting Research Fellow, Ailbhe O'Neill, Ussher Professor in Law at Trinity College Dublin and Senior Counsel at the Bar of Ireland, Roger Bolton, British television producer and TV and radio presenter, and Tommie Gorman, Irish journalist and former RTÉ Northern Editor.

25th Anniversary of the Belfast/Good Friday Agreement

On 30 March 2023 in the run-up to the anniversary of the Belfast/Good Friday Agreement, the Trinity Long Room Hub and Trinity's School of Religion, Theology, and Peace Studies (organised by Etain Tannam, Associate Professor in International Peace Studies) hosted the British Ambassador to Ireland, Paul Johnston, for a panel discussion with students and parliamentarians from the Northern Ireland Affairs Committee in the House of Commons and the Oireachtas Good Friday Agreement Implementation Committee.

Trinity panel discussion examines Brexit negotiations

Three years after the UK officially left the EU, what can be learnt by looking back at the Brexit negotiation process, and how has that process impacted the enduring relationship between the EU and the UK? This was the focus of How the EU Got Brexit Done, a panel discussion in the Trinity Long Room Hub on 31 January 2023 featuring Stefaan De Rynck, the Senior Advisor to the EU's Chief Brexit Negotiator, Michel Barnier, from October 2016 until March 2021. The panel was chaired by Bill Emmott, Chair of the Trinity Long Room Hub board and former Editor-in-Chief of *The Economist*, and also featured Professor Gail McElroy, Dean of the Faculty of Arts, Humanities and Social Sciences at Trinity, and Dr Etain Tannam, Associate Professor in Trinity's School of Religion. The panel was organised by the Trinity Centre for Constitutional Governance and the Jean Monnet Centre of Excellence for EU Law, Politics, and Constitutional Governance at Trinity College Dublin in association with the Trinity Long Room Hub.

On cultural and literary heritage:

'Behind the Headlines' weighs in on the 'rewrite' debate

With the news that publishers Puffin and the Roald Dahl Story Company are to rewrite potentially sensitive or offensive elements of the popular children's books, our 'Behind the Headlines' panel questioned whether languages, images, and texts should be 'subject to change'?

On 5 April 2023, an in-person and online audience joined the Trinity Long Room Hub's signature 'Behind the Headlines' discussion to hear from children's literature expert Dr Jane Suzanne Carroll of Trinity's School of English; constitutional expert, Dr David Kenny, School of Law; author and journalist Martina Devlin; and Beckett studies expert, Professor Nicholas Johnson from the School of Creative Arts, Trinity. Introducing the panel, Professor Eve Patten, Director of the Trinity Long Room Hub questioned the sanctity of a work of art, asking "do we have the right to edit, to change, to update it?"

400th anniversary of Shakespeare's First Folio

As part of the celebrations for the 400th anniversary of Shakespeare's 'first folio' which went on display at the Library of Trinity College Dublin on the 13 April 2023 ("Shakespeare the Irishman"), the Trinity Long Room Hub hosted an in-person lecture by Professor Andy Murphy (TCD) in conjunction with the School of English and with Trinity College Library.

Trinity holds the only copy of the First Folio on the island of Ireland and Professor Murphy discussed the particular features of the Trinity copy, including examining some of the peculiar marks and inscriptions to be found in the book. The Trinity Long Room Hub also sponsored a one-day symposium 'Shakespeare the Irishman', featuring papers from Neil Rhodes of the University of St Andrews in the UK, and from Mark Burnett, Emer McHugh and Molly Quinn-Leitch (Queens University Belfast); Patrick Lonergan and David O'Shaughnessy (University of Galway); Stephen O'Neill (NUI Maynooth); Jason McElligott (Marsh's Library) and Marc Caball (University College Dublin). The week-long celebrations of Shakespeare's first folio also marked the launch of the new Trinity Centre for the Book led by Dr Mark Faulkner, School of English and hosted by the Trinity Long Room Hub.

Moore Letters spanning 50 years of trans-Atlantic correspondence acquired by Trinity College Dublin



A collection of some 830 letters written by members of two related families, the Moores and Hughes, who resided in Derry and Baltimore, has been acquired by Trinity College Dublin. On Wednesday 10th May at the Trinity Long Room Hub, this valuable correspondence was the subject of a discussion organised by the School of Histories and Humanities in association with the Library of Trinity College Dublin, the University of Galway, and the Trinity Long Room Hub. Members of the Moore family and others interested in the current plans for publication of the letters heard from speakers Professor Claire Connolly (School of English, University College Cork), Dr Jane Maxwell (Manuscripts Curator, TCD Library), Professor Ciaran O'Neill (Deputy Director Trinity Long Room Hub, Department of History TCD), Professor Amy Prendergast (School of English, TCD), Professor Breandán Mac Suibhne (Acadamh na hOllscolaíochta Gaeilge, University of Galway, and Project Co-editor) and Professor David Dickson (Trinity Long Room Hub Emeritus Research Fellow, and Project Co-editor).

Analysing Ireland's political and social relationships with Europe

As part of the Department of Foreign Affairs **Communicating Europe Initiative 2022**, an online seminar 'Visions of Europe in Irish Cultural Debate since 1940' was hosted on 13 December 2022 with Professor Richard Kearney (Boston College), one of Ireland's most prominent public intellectuals, whose work in philosophy, culture and politics builds on a deep engagement with Europe. Marking fifty years of Ireland's membership of the European Union, the panel also included Professor Michael Cronin (TCD), Emeritus Professor Eda Sagarra from Trinity's School of Languages, Literatures and Cultural Studies, and Professor Aidan O'Malley from the University of Rijeka in Croatia.

In order to make decisions surrounding the future of technology we must shift our perception of the past. This was one of the key takeaways of 'Technology's Deep Time,' an in-person event featuring Professor Genevieve Bell, Director of the School of Cybernetics and a Distinguished Professor at the Australian National University, and her colleague Andrew Mearns, celebrated press photographer and the Cybernetic Futures Lead at the Australian National University. They were in conversation with Professor Chris Morash, Seamus Heaney Professor of Irish Writing at TCD, in an evening discussion panel organised by the Trinity Long Room Hub and the School of English. Told through a series of stunning colour-saturated photographs depicting scenes in the outback on the Oodnadatta Track in South Australia, about 670km north-northwest of Adelaide, 'Technology's Deep Time' was a fascinating invitation to approach technology with a new awareness of time, demonstrating how a wider appreciation of the past can better inform the choices we make for the future.

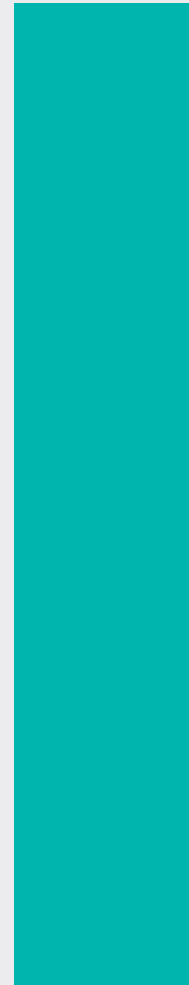
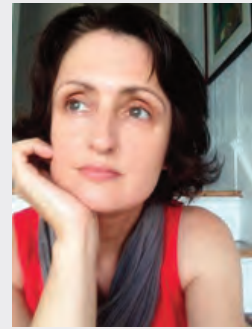
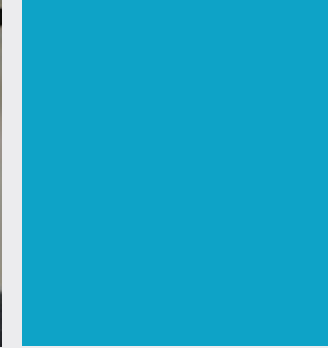
Advocating on behalf of the Humanities in a new Research Funding Agency

The panel event also included the participation of Deirdre Lillis, Assistant Secretary, Department of Further and Higher Education, Research, Innovation and Science.

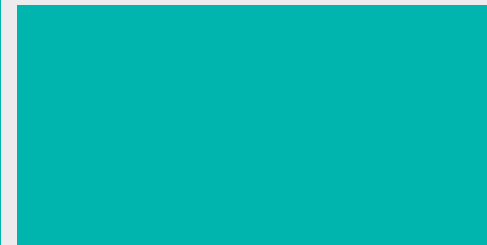
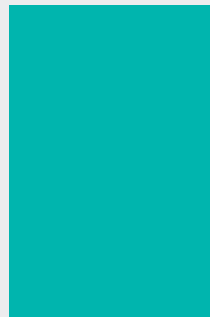

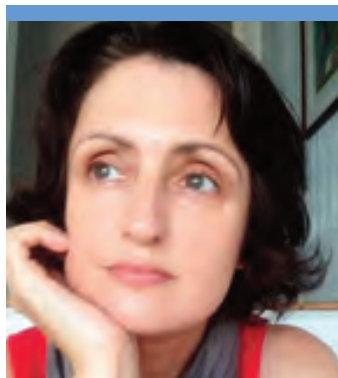
VISITING RESEARCH FELLOWS

Mary Burke



Bohemian Ireland

Professor Mary Burke joined us from the University of Connecticut in association with Professor Chris Morash in the School of English. Her fellowship project, 'Bohemian Ireland', explored post-war Ireland's dispersed, creative, and colourful expatriate scene. It embraced traditions that mainstream Ireland then considered dated, unprofitable, or "disreputable," seeding the eventual embrace of land stewardship, multiculturalism, and traditional foodways.

Professor Burke delivered a public lecture entitled 'Race, Politics, and Irish America: A Gothic History' as part of the School of English's Staff and Postgraduate Seminar Series, and presented on her research on Bohemian Ireland at a Trinity Long Room Hub coffee morning.

Nidhi Zak/ Aria Eipe



Honey and the Hare

Nidhi Zak/Aria Eipe was appointed as the Trinity Long Room Hub's 2023 Rooney Writer Fellow. *Auguries of a Minor God*, her first collection, was published by Faber & Faber in 2021. Nidhi is the recipient of a Next Generation Artist Award in Literature from the Arts Council of Ireland and currently serves on the Expert Advisory Committee for Culture Ireland as well as the Advisory Board of Diversifying Irish Poetry.

During her tenure as the Rooney Writer Fellow, Nidhi researched a project titled 'Honey and the Hare', an epistemological study into the alchemical quest for the numinous. Taking its departure from Joseph Beuys's 1965 performance 'How to Explain Pictures to a Dead Hare', she investigates the core elements that Beuys used to interrogate and extend his idea of a 'social sculpture' in the human relationship to the more-than-human, including the totemic figure of the hare and the elixir of immortality, across both ancient Celtic and Indian traditions. Dariusz Komorowski



Identity, Community and Actor-Network Theory. Things in Literature in the Context of Creating Identity and Community

Professor Dariusz Komorowski joined us from the University of Wroclaw in association with Professor Juergen Barkhoff in Trinity's School of Languages, Linguistics and Cultural Studies. His research focuses on Swiss culture, the relation between local, cultural and national identity, and the history of ideas, notably republicanism and the common good in contemporary German literature.

During his time at Trinity Long Room Hub, Dariusz delivered a Fellow in Focus event in conversation with Professor Barkhoff as well as a seminar entitled 'Things and Ideas of Community in the Literary Works of Matthias Zschokke: An Attempt at an ANT-based literary analysis.' This was part of the School of Languages, Literatures and Cultural Studies research seminar series which is also available online in the Hub's podcast library.

Susan Manly



Maria Edgeworth's attitudes towards West Indian and especially Jamaican slavery in the early nineteenth century

Dr Susan Manly is based in the University of St Andrews and her fellowship was in association with Professor Aileen Douglas in Trinity's School of English. As part of Dr Manly's research for her new political biography of author Maria Edgeworth, she has been looking at Edgeworth's attitude towards West Indian and especially Jamaican slavery in the early nineteenth century. Edgeworth's fictions and plays often figured emancipated African and Creole characters. The extent and nature of Edgeworth's personal knowledge of and implication with the West Indies, however, has never been fully established. During her time at the Trinity Long Room Hub, Dr Manly participated in a Fellow in Focus discussion with Prof Aileen Douglas (School of English) about her work on Edgeworth. This discussion is available in the Hub's podcast library.

Lucy McDiarmid



A study of non-standard, unconventional, ‘odd’ Irish writers of the last 100 years

Professor Lucy McDiarmid joined us from Montclair State University in association with Dr Paul Delaney at Trinity’s School of English. Her fellowship enabled her to consult Trinity Library’s manuscripts of Leland Bardwell’s poems as part of a study of non-standard, unconventional, ‘odd’ Irish writers of the last 100 years.

During her fellowship at the Hub, Professor McDiarmid delivered a public lecture entitled ‘Recent Irish Poetry and the Slightly Magical’ as a part of the School of English Staff and Postgraduate seminar series. She also spoke about her work at the Hub’s research coffee morning and in conversation with Professor Eve Patten at a Fellow in Focus event in March of 2023.

Composite Chorography: Collecting the Americas in the Fagel Collection in the Library of Trinity College Dublin

Frank Rexroth



Towards a New Typology of ‘Higher’ Knowledge in the Twelfth Century: Scholasticism and the Emergence of Experts and Intellectuals

Professor Frank Rexroth joined us from the University of Göttingen in association with Professor Ruth Karras in Trinity’s School of Histories and Humanities. While at the Trinity Long Room Hub, Professor Rexroth studied some of Trinity College Library’s 12th and 13th century manuscripts and letter collections as part of his work on medieval intellectual culture. The first outcome of his fellowship has already appeared in print: “*Unerwünschte Experten. Der Intellektuellengestus in der gelehrten Praxis des 12. Jahrhunderts,*” in *Intellektuelle. Karrieren und Krisen eines Typus vom Mittelalter bis zur Gegenwart*, edited by Wolfgang Eric Wagner (Basel, 2023). Professor Rexroth delivered a public Fellow in Focus discussion with Professor Ruth Karras, as well as speaking about his work at the Trinity Long Room Hub research coffee morning during his fellowship at the Hub.

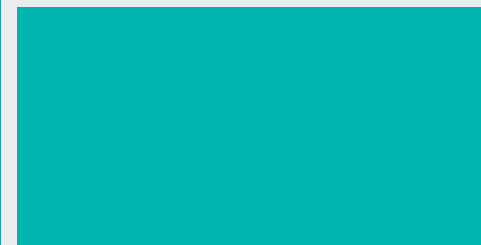
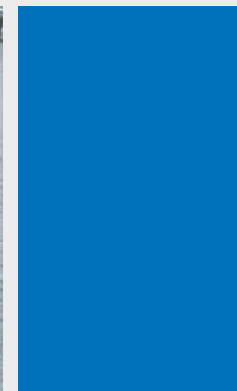
Şebnem Susam-Saraeva



The Intersemiotic Translation of Cetacean Languages and Cultures in Arts and Music

Dr Şebnem Susam-Saraeva joined from the University of Edinburgh in association with Dr James Hadley in Trinity’s School of Languages, Literatures and Cultural Studies. Her work at the Hub investigated the intersemiotic translation of cetacean languages and cultures in arts and music. Dr Susam-Saraeva’s public lecture ‘Dolphin and Whale Communication in Arts and Music: Towards a New Ethics of Translation and Representation’ can be viewed on the TLRH website. The article of the same name which was written during her fellowship is forthcoming in Enza De Francisci and Cristina Marinetti eds. *Translation in the Performing Arts* (London and New York: Routledge, 2024). Also forthcoming in 2024 is ‘Translation and narrative in climate crisis discourse,’ upon which she commenced work at the Hub. Dr Susam-Saraeva’s Fellow in Focus discussion with Dr James Hadley is available to listen to on the Hub’s podcast library. Şebnem also delivered a talk on ‘Translation’ and ‘Narrative’ in Climate Crisis Discourse’ at the Centre for Translation and Cultural Studies, DCU. She taught a session on translation/interpreting and maternal health for masters students at the Trinity Centre for Literary and Cultural Translation. She also delivered a workshop for Early Career Researchers on publication and impact with the Translation Studies Network of Ireland at the Trinity Centre for Literary and Cultural Translation.

EARLY CAREER RESEARCHERS



In 2022-2023 we welcomed 40 outstanding PhD students in the Arts and Humanities, and 5 Postdoctoral Fellows from our member schools. Representing 18 different disciplines and 16 nationalities, this dynamic cohort have had the opportunity to work together and share their diverse interdisciplinary research journeys across the year

During their time at the Trinity Long Room Hub, our Early Career Researchers (ECRs) participated in dedicated confidence and competence building workshops and training, and also had the opportunity to lead their own academic events. 70 events took place in support of, or led-by, our Early Career Researchers during the year. This included 17 skill-building workshops for early career researchers (including workshops on careers, mindfulness for researchers, research impact and tools as well as 6 research poster design workshops and research exchanges). It also included seminars, conferences, reading groups and workshops delivered by our Early Career Researchers.

Coffee Mornings

Our weekly research coffee mornings continued to provide an opportunity for Early Career Researchers to present and discuss their work in a collegial and constructive environment with the mentorship of Hub staff, established academics, and visiting research fellows. These community events offer a wonderful networking opportunity and feature researchers of all career stages (including Visiting Research Fellows, projects staff, and RIS awardees), but they offer our ECRs in particular an opportunity to hone skills, from public speaking to the concise presentation of their research to non-specialist audiences. Further to the 70 ECR events above, the Hub ran 26 research coffee mornings across the 2022-23 academic year.

Research Poster Development

Following a suite of research poster development workshops delivered on site at the Hub, our Early Career Researchers designed powerful and engaging posters to communicate their research visually, especially to non-specialist audiences. Those who developed posters participated in an online research exchange with the University of York and went on to present their work at a showcase in the ideas space, where the work is now publicly displayed.



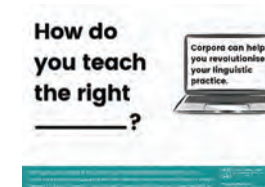

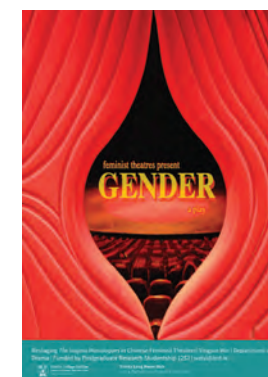

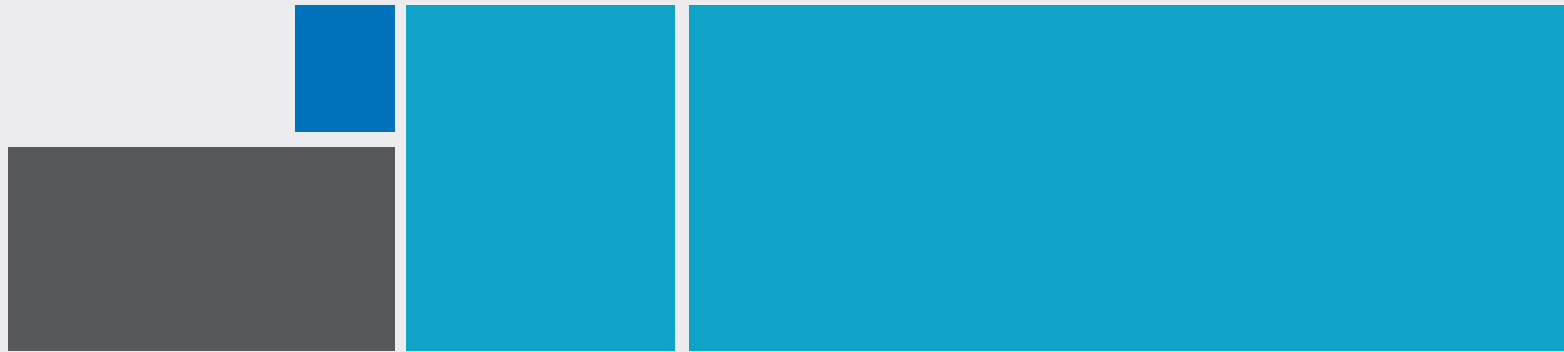

CLS INFRA (Computational Literary Studies Infrastructure)

March 2021 — Feb 2025

European Commission Horizon Europe



The digital age offers new opportunities to undertake literary studies research but also new challenges for the standardisation of resources. CLS INFRA (<https://clsinfra.io>) is a 4-year project bringing together 14 partner institutions from across Europe to build a sustainable infrastructure for literary research for Europe's multilingual literary heritage in a digital age. The project will align these diverse resources with each other, build the tools needed to interrogate them, and widen the base of users. The TCD Digital Humanities team, based in the Trinity Long Room Hub, focusses on supporting communications, user requirements, dissemination, and training work in this project. In the years 2022-2023, Jennifer Edmond, Associate Professor of Digital Humanities and Co-Director of the Trinity College Dublin Centre for Digital Humanities, and Vera Yakupova, a recent graduate from the TCD MPhil in Modern and Contemporary Literary Studies and currently a research assistant in the TCD DH Centre, are working on widening the user base for CLS tools within and beyond the academic community by looking at applied literature and narrative paradigms. The task includes gathering perspectives via 15-20 focused interviews with professionals and enthusiasts from the fields of policy, consultancy, journalism, publishing, art, and medicine. The TCD DARIAH team also contributes to the project with Vicky Garnett, Training and Education Officer for DARIAH-EU, involved in organising the CLS INFRA Training School at UNED in Madrid May 2023, and with Eliza Papaki, contributing to the project team through her role as Outreach and Communications Officer for DARIAH-EU.

DARIAH-EU (Digital Research Infrastructure for Arts and Humanities)

Over the course of 2022-23, the Trinity Long Room Hub continued its strong relationship with Europe's digital infrastructure consortium for the Arts and Humanities, DARIAH-EU. From the 1st to the 3rd of November 2022 the Centre hosted the DARIAH General Assembly, the DARIAH National Coordinators Meeting, and the DARIAH Innovation Forum at the Trinity Long Room Hub. The Innovation Forum was inaugurated in 2017 and acts as a platform to explore how DARIAH can facilitate better relationships between arts and humanities researchers and industry. This event was organised by the Centre for Digital Humanities and the Trinity Long Room Hub in collaboration with the Human+ Programme and ADAPT. While Jennifer Edmond, Associate Professor of Digital Humanities and Co-Director of the Trinity College Dublin Centre for Digital Humanities, stepped down from her role as President of the Board of Directors for DARIAH-EU in (July 2022), she continued as a director to the end of December 2022, and continues still today to act as local line manager for two key DARIAH Coordination Office staff seconded from TCD. These staff members are Vicky Garnett, Research Fellow and DARIAH Training and Education Officer and Research Fellow Eliza Papaki, DARIAH Outreach and Communications Officer. Michelle Doran left the Centre in mid-2022 but continued as an active member of the DARIAH Research Data Management Working Group. Through DARIAH, Vicky Garnett has also been involved in the ongoing EOSC-Future project, and Eliza Papaki completed work on the Triple-EU project, both dedicated projects for Open Science.

KT4D Knowledge Technologies for Democracy

Feb 2023 - Jan 2026

European Commission Horizon Europe

Artificial Intelligence (AI) and Big Data are rapidly changing and evolving fields, strongly interwoven into both our society and culture and increasingly viewed and criticised as disrupters of current conceptions of democratic governance and exchange. Knowledge Technologies for Democracy (KT4D) takes a different approach to AI and Big Data, framing these instead as Knowledge Technologies and an opportunity to improve civic participation in democratic governance. Led by Jennifer Edmond, Associate Professor of Digital Humanities and Co-Director of the Trinity College Dublin Centre for Digital Humanities, Trinity College Dublin will coordinate KT4D's Europe wide consortium of 12 partner organisations with extensive expertise in technology, communication, and research (4 research-performing organisations, 4 SMEs, and 4 non-governmental organisations). The KT4D project (kt4democracy.eu) will investigate how democracy and civic participation can be better facilitated in the face of rapidly changing knowledge technologies, enabling actors across society to capitalise on the many benefits these technologies can bring in terms of community empowerment, social integration, individual agency, and improved trust in both institutions and technological instruments while identifying and mitigating potential ethical, legal and cultural risks. The ultimate goal is to foster civic participation in democracy by capitalising on the benefits of developments in AI & Big Data technologies. Central to the project is the understanding that to fully address the social and fundamental rights costs of AI and Big Data, we need more than just technological fixes, we need to address the underlying cultural influences and barriers. KT4D will develop and validate tools, guidelines and a Digital Democracy Lab Demonstrators platform to address these extensive societal concerns. Our results will then be validated across three user needs scenarios in four different European Cities.

In the 2022-23 academic year, KT4D (launched Feb 23) began with a virtual and subsequent in-person kick-off meeting to establish the project's working groups. The KT4D consortium has attended the Sustainable AI event in Sweden and received media coverage from national and international outlets such as Silicon Republic.

MOZART

1 October 2022 – 30 September 2026
European Commission Horizon Europe

MOZART is an interdisciplinary project that will deliver robotic prototypes for the handling of fragile and delicate objects. TCD is leading the Social Sciences and Humanities work package of the project. This includes investigating usability aspects of MOZART prototypes, as well as examining how to effectively integrate technological innovation with matters of economic, social, and environmental sustainability, while fostering the interdisciplinary project work. The project started during the 2022/2023 academic year. In March, we submitted the first deliverable of the project, the first report on human-robot interaction affordances, in which we deliver the MOZART Affordance Canvas (WP 5, task 5.2). This is a novel conceptual framework that we developed to investigate sociotechnical aspects of industrial robotics automation, combining methodologies and perspectives of feminist HRI, feminist STS, feminist food studies, women's history, and history of technology through an integrative-interdisciplinary lens across STEM and AHSS. In March, the research blog of the project (WP 8, task 8.4) was released, and three blog posts were published until August. In April, we started archival research for the historical case study of the MOZART Affordance Canvas. Between June and August, we organised introductory visits to MOZART robotics labs, and held the first qualitative interviews and group workshop. In June, we discussed the first research insights emerging from the historical case study in three academic events (research seminar 'Follow the chicken. Looking for non-human animals in the history of technology', June 8th, Eindhoven History Lab, Eindhoven University of Technology; workshop 'Representing Femininity. Constructing and Deconstructing the Image of Women in Italy', June 19th, University College Dublin and University of Bologna (held online); panel 'Interesting failures to come: history, actors, and scenarios in unsuccessful digital technologies projects' June 28th, STS Italia Conference, University of Bologna).

Who Wants To Write An Email?

2023

Science Foundation Ireland Discover Programme Grant

Who Wants To Write An Email? (WWTWAE) is a theatrical interactive game show that engages audiences in discussing and debating the ethics and effects of AI predictive text applications (i.e. SmartCompose or ChatGPT) on their identities, relationships, shaping of thought and language, and what it means to be human.

Staged similarly to *Who Wants To Be A Millionaire*, WWTWAE's dramatic set, lighting, tense music, slick animations, and escalating rounds of questions create an absurd amount of comedic tension as contestants obsessively try to make sense of writing suggestions in emails made by a proprietary algorithm. This art science experience is designed to facilitate the audience in live sense making, critical thinking and collective imagining on AI and how it shapes society and our everyday lives.

Conceptualised and led by Centre Director Jennifer Edmond and her artist collaborator Laura Allcorn, the project was created through a co-creation process through a series of adult education and STEM expert workshops.

WWTWAE will tour to Dublin and two regional cultural venues with low STEM engagement, targeting adult audiences that don't typically seek out or have opportunities to participate in novel art-science experiences. We'll reach an audience of over 350. Another key project output is an online toolkit that captures our evaluation findings and offers practice insights for future art science engagement projects that are designed for audience participation.

Human+: Human-Centric Approaches to Technology Development (2020-25)

European Union Horizon 2020 Marie Skłodowska-Curie COFUND Action



This transdisciplinary, international fellowship programme is led by the Trinity Long Room Hub in partnership with ADAPT, the SFI Centre for Digital Content Innovation at Trinity College Dublin. The focus of Human+ is the development of human-centred approaches to technology, drawing on the insights of the arts and humanities, along with computer science and enterprise. Research clusters include Visual Media; Human and Computer Interaction; Technology's Impact on Society; and Exploring Contexts, Meaning and Narratives in Digital Media. In 2023, Dr Dalila Burin joined the programme on a 2-year postdoctoral project 'Researching perception of embodied virtual humans to

improve immersive virtual reality (VR).' The continuing fellows on the program are Dr Lauren Buck, Dr Qian Xiao, Dr Nicola Palladino and Dr Kata Szita. This year the programme ran a public series of Human+ Tech Talks more detail of which is available in the Highlights section of this report along with news and details of recent publications.

Ireland's Border Culture: Literature, Arts, and Policy – An Interdisciplinary Enquiry

A HEA Shared Island funded project



This research project is run by the Trinity Long Room Hub in partnership with the Heaney Centre at Queen's University Belfast. In 2023 Dr Orla Fitzpatrick was appointed as a postdoctoral fellow on this HEA. Coming from a visual arts background, Dr Fitzpatrick joins the project team from the National Museum of Ireland. The PI team has completed the initial research strands of the research resource and shaped a design strategy for the digital portal. Dr Fitzpatrick has presented the project at several academic fora and will speak at the EFACIS conference on 'Unions and Partitions' at QUB, 24-27 August QUB. She will also lead a pilot presentation of the project in autumn/winter 2023.

PublishOA.ie (2023-24)

National Open Research Forum 2022 Open Research Fund

Publish OA was created in response to the Irish government's target of achieving 100% open access to publicly funded scholarly publications by 2030 and is funded by the National Open Research Forum (NORF). The project will run until November 2024; its key objective is to evaluate the feasibility of establishing a national OA platform for journals and books for Ireland. The project is led by the Royal Irish Academy (RIA) and Trinity College Dublin and involving 11 institutions and publishing groups island-wide. The Trinity Long Room Hub will lead a full work package on reporting, networking and communications. Dr Jane Mahony was appointed to the project as research assistant with responsibility for communications and reporting. The Hub team worked with Dr Mahony and the RIA to publish a Bloomsday feature on the current status of OA and the Irish publishing landscape in June 2023. Read the full feature on our website.

Schuler Democracy Forum

Funding: Philanthropic (Dr Beate Schuler)

The Schuler Democracy Forum has three key aims:

1. Research: apply Arts and Humanities research to questions related to media and democracy.
2. Knowledge exchange: bridge divides between academia, media, enterprise, government and civic society to shape policy and practice.
3. Engage diverse audiences through collaboration with civic society and an innovative public humanities programme.

The Forum Coordinator (Dr Elspeth Payne) and Media Fellow (Mark Little) completed their co-created research project which interrogates questions on the interface of media, democracy, and technology. The key project output in 2023 was the 'History of the Future' podcast, a six-part series examining ideas about the future, truth, fear, identity, freedom, and agency. Each episode is a unique fusion of perspectives, bringing together leading arts and humanities researchers and media innovators to discuss how to navigate an uncertain tomorrow. The Provost launched the podcast at an event in the Hub on 8 February 2023 which was attended by core project stakeholders from research and the media. The podcast has been promoted through interviews with the Media Fellow and/or Forum Coordinator on Newstalk Pat Kenny, Newstalk Hard Shoulder, RTÉ Brendan O'Connor, and in the *Irish Times*, as well as via social media and the institute's partner networks. The Hub window also featured the podcast artwork to bring the series to the attention of those walking through Trinity.



The Forum coordinator began work on the Critical ChangeLab project (2023-26), funded under the HORIZON-CL2-2022-DEMOCRACY-01-04-Education for democracy call (Grant agreement ID: 101094217). The Critical ChangeLab project will develop a new model for democratic pedagogy which aims to promote active democratic citizenship at a time when polarisation, deep political divisions and declining trust in a democracy are spreading across Europe. The Model promotes creative and narrative practices to explore the historical roots of local and global challenges and the value systems and worldviews underlying distinct types of relations (human-human, human-nature, human-technology). The coordinator is working with colleagues in the TCD School of Education as part of a consortium of ten European research and practice partners. A virtual kick-off meeting was held in April 2023, with in-person workshops hosted by Wagg in Amsterdam in May 2024.

The Schuler Democracy Forum hosted three high-profile events with strategic partners:

- > **President Zelenskyy's address to students in Ireland** (18 November 2022) in association with Trinity Research in Social Sciences (TRiSS). The broadcast was followed by an in-person discussion on democracy, EU support for Ukraine, and European values led by the German Ambassador to Ireland and the Deputy Head of Mission of the Embassy of the Czech Republic in Ireland.
- > **Censorship, media, and conflict: the case of Northern Ireland** (15 December 2022) in partnership with Boston College. The panel discussion examined the broadcasting bans introduced by the governments in London and Dublin in the 1970s and 1980s from a historical, legal, and journalist perspective.
- > **SLAPPS: A Threat to Our Freedom of Expression and Our Democracy** (23 March 2023) A conference on strategic lawsuits against public participation (SLAPPs) in partnership with Trinity School of Law and the Index on Censorship.

SHAPE-ID: SHAPING INTERDISCIPLINARY RESEARCH PRACTICES IN EUROPE (2019-21)



While the SHAPE-ID project completed its funding period in 2021, the project is required to disseminate its findings until 2025 and continues to impact the research landscape.

In February 2023 a new report from the League of European Research Universities (LERU), entitled ‘Implementing interdisciplinarity in research-intensive universities: good practices and challenges’, acknowledged the significant contributions the SHAPE-ID project and its resource toolkit for inter- and trans-disciplinarity have made to the landscape since LERU’s previous 2016 report on the subject. It noted how:

“The EU-funded SHAPE-ID project has synthesised extensive academic and policy literature findings on interdisciplinarity, including factors of success and failure. Today, the key issue is not lack of knowledge about the importance nor processes and practices of inter- and transdisciplinarity, but rather with the diffusion and implementation of that knowledge within the knowledge systems. To address this, SHAPE-ID recently provided a toolkit supporting pathways to interdisciplinary and transdisciplinary research for researchers, research organisations, funders, policy-makers, and societal partners, all of whom must play a part in advancing and enabling a culture of inter- and transdisciplinarity.”¹

In May of 2023, following the publication of the report, SHAPE-ID hosted an online LERU Report Roundtable with Professor Wernli and LERU to discuss the report’s findings and recommendations.

“We Persist, Therefore We Have Hope”: trauma and resilience of Hongkongers through their art since 2019

A public exhibition of protest art from Hong Kong was designed for and installed in the Trinity Long Room Hub building as part of this interdisciplinary project which brought together Resistance Studies, the Creative Arts, Medicine, and Sociology as well as engaging with activists, artists, and members of the Hong Kong community. The exhibition was the inaugural event of a “protest art” theme at the Trinity Centre for Resistance Studies. It was bookended by two public, interdisciplinary panel discussions, which involved both artists and academics.

Seeing Isfahan: a collaboration between the Chester Beatty and TCD History of Art and Architecture

Anna McSweeney, School of Histories and Humanities

This interdisciplinary project was a collaboration with Dublin’s Chester Beatty Library and held in association with the Chester Beatty exhibition ‘Meeting in Isfahan: Vision and Exchange in Safavid Iran’. To research the representations of Isfahan in the Chester Beatty’s Safavid manuscripts, the project brought together expertise from diverse disciplinary areas: art history, museum studies, history, literature, and manuscript conservation. The project delivered an international, two-day, public conference



entitled ‘Seeing Isfahan: Perspectives on the Safavid Image.’ This conference was open to the public, free of charge, and drew strong attendance. Massumeh Farhad (National Museum of Asian Art, Smithsonian Institution) gave a keynote lecture entitled “Towards a New Pictorial Language: Painting and Patronage in Seventeenth-Century Iran.” The event was livestreamed, and the recording is available in the Trinity Long Room Hub’s video and podcast library.

Project PI Dr Anna McSweeney described the research impact and the achievements of the project in terms of its public engagement, collaboration, and network-building:

“The immediate impact of the project was to assemble an important group of specialist scholars focused on Safavid Isfahan at the conference. The scholars we brought together were of extremely high status and quality, ranging from young emerging scholars to the most established in the field. It served to put Trinity on the map, alongside Chester Beatty, as a place to study and view Islamic manuscripts of the highest quality. We hosted a successful, international and interdisciplinary two-day conference in May 2022. The conference was open to public attendance and included a livestreamed keynote lecture. The conference supported a stated aim to inaugurate a longer-term collaboration between TCD and Chester Beatty Islamic art specialists. [...] The conference, collaboration and network connected TCD to a globally distributed group of Islamic art historians and a locally interested group of public attendees, thereby enhancing the visibility of Trinity’s Arts and Humanities research to this important non-western field.”

Dr McSweeney’s vision for the next steps of the project includes a co-edited book and the further development of research into the Chester Beatty collection and Islamic Art at Trinity. This will be achieved through outreach and network building, in conjunction with the new Trinity Centre for the Book.

Trinity's Early German Printed Books: towards the digitisation of the 1872 catalogue

PI: Dr Graeme Murdock, School of Histories and Humanities

Co-PI: Laura Shanahan, Head of Research Collections

This project was a collaboration between the Department of History and the Library of Trinity College Dublin. It involved the literary, historical and bibliographic analysis of a stock of early sixteenth-century German-language texts.

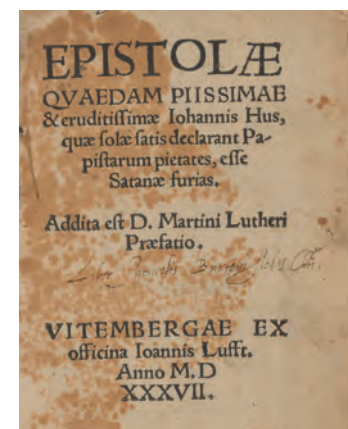
"The project has also crucially advanced understanding of the research value of Trinity's early printed collection of German texts. [...] We have identified 'rare' items that have no existing digitised copy elsewhere and therefore understand which books should be prioritised by the Library for digitisation. We have also investigated the provenance of this collection of early sixteenth-century German texts - study of the books themselves has revealed a good deal about their journey from print-shops in eastern and southern German towns in the 1520s and 1530s to Dublin. Revealing something of the social history of these books in turn raises important questions about early sixteenth-century German Lutheran networks and print culture and this merits further research."

This project is still underway and further dissemination activities and outputs are planned and underway, including collaborative publications. Laura Shanahan, Head of Research Collections at Trinity College Library, added that: "We are actively delivering the decant of the Old Library Collections as part of the preparation for the redevelopment of the building. The completion of this work on the German Reformation Pamphlets has increased our awareness of the collection and will enable greater access to the collection in future. As such, the impact is timeless. I will continue to be involved with future engagement activities around this collection." Project Co-PI Shane Mawe reflected on the importance of the project in terms of improving access to the library's collections. He noted three future phases of the project, including "Promotion of the findings; [the] potential to explore philanthropic funding to expand the project and with the assistance of Library colleagues, [and] the enhancement of the related 1872-catalogue records in 'Sierra', the Library Management System."

'Tracing the Untranslatable': An intercultural exploration of dramatic tension

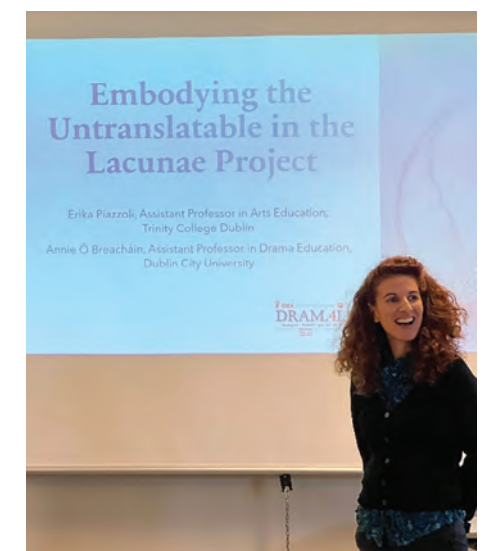
Dr Erika Piazzoli, School of Education

At the heart of this investigation into untranslatable words and the depth of cultural insight they hold is a question: "How can untranslatable words be explored performatively to channel dramatic tension towards intercultural awareness?" Engaging with multiple cultural groups via an international team of researchers and artists the project aims to research how 'embodying the untranslatable' in performance might provide new methods of supporting and developing intercultural awareness.

The grant has led to conference papers, workshops, and seminars in Iceland, the UK, and Italy. It has created momentum via network creation and its data collection methodology has inspired another pilot program by Professor George Belliveau in the University of British Columbia, in which Dr Piazzoli participated. This has led to another forthcoming publication in the *McGill Journal of Education*. Dr Piazzoli has also been invited to publish a paper on the project in the *Arts Journal*, Special Issue 'Exploring Research-Based Theatre within Contemporary Theatre Education'. Data analysis for this project is ongoing but six more papers are planned for the PI and the research team – one per untranslatable word selected by the project.
