Post Summary

Novel optical access and metro networks are essential to support fast growing capacity requirement, driven by future applications and services for 6G and beyond. Networks are also evolving to support a large variety of signals across larger access and metro network areas. For these novel scenarios, flexibility becomes an essential feature, driven by the development of flexible components and open networks. These however require the development of intelligent control planes to autonomously manage network requests, maintaining high availability and optimal resource utilization.

One Post Doctoral researcher position is available for work in the <u>area of intelligent AI-driven</u> <u>control planes for optical communications networks</u>. The work will involve the <u>development</u> <u>of AI models and intelligent control plane mechanisms</u> to satisfy requirements of high capacity, availability, heterogeneity, and low latency, required by future 6G networks.

The work will be developed around open optical systems and software defined networks control planes and will include both access and metro networks.

The applicants should have a solid theoretical background on machine learning and optical networks and willing to engage in testbed-oriented research. The work will be <u>carried out in</u> the <u>new OpenIreland research infrastructure</u>, a large-scale testbed for experimentation in optical, wireless and cloud technologies.

The position will be based in the CONNECT research centre at Trinity College Dublin, Ireland and will be funded under the European Horizon project ECO-eNET and other national, European, and industry projects. The researcher will have the opportunity to build their research portfolio within a range of projects within CONNECT. The researcher will also be part of the School of Computer Science and Statistics in TCD.

The position will be under the direction of **Prof. Marco Ruffini and Prof. Dan** Kilper

Standard Duties and Responsibilities of the Post

The primary focus of the EPR will be to perform research on the EU project, although they might also work on other projects. In addition, the EPR's activity will be broader and the EPR is also expected to:

- Conduct a specified programme of research under the supervision and direction of the Principal Investigator
- Engage in the dissemination of the results of the research in which they are engaged,
 as directed by, with the support of and under the supervision of the Principal
 Investigator. (Actively publish research findings in high impact journals and at key
 conferences as part of the research group effort to disseminate research outputs).
- Engage in the wider research and scholarly activities of the research group, School or
 University

- Interact closely with postgraduate research students associated with the same research group and possibly have an agreed role in supporting these students in their day-to-day research in conjunction with an academic supervisor.
- Take leadership and contribute to generation of papers, reports and other funding proposals.
- Carry out administrative work to support the program of research where required,
 including regular funding agency reports and internal reports etc.
- Carry out additional duties as may reasonably be required within the general scope and level of the post.
- Contribute to the financial management of a research project.
- Support collaboration with industry in areas relevant to the research group
- Liaise with different TCD units such as research project administration team and Finance in aspects related to the research activities performed.
- Engage in appropriate training and professional development opportunities as required by the Principal Investigator, School or University, in order to develop research skills and competencies.
- Gain experience and contribute to grant writing with the support of and under the supervision of the Principal Investigator
- Acquire generic and transferable skills (including project management, business skills and
- postgraduate mentoring/supervision).
- Contribute to broader outreach and engagement activities such as organising technical meetings, outreach to schools and other interested parties etc.

The post is primarily funded by the European Commission but may involve funding from other sources based on the successful candidates interests.

The appointable candidate will hold a PhD, preferably in a Computer Science or Electronic Engineering or related discipline (preferably with a few months of postdoctoral experience).

Qualifications

PhD or equivalent experience. The post is applicable to both new or experienced PhD holders, and salary will be commensurate with experience and achievement. The successful candidate will join a team of highly skilled and innovative researchers in next generation optical and wireless networks.

- Working knowledge of python programming language and Linux operating system.

The Selection Process in Trinity
