

ABSTRACT

I address the evidence that European Monetary Union has been followed by some product market reform but very limited labour market reform by showing some conditions under which, in a monetary union:

- (i) labour market reform may not be optimal,
- (ii) it is optimal for product market reform to precede labour market reform,
- (iii) the desired degree of product reform in a country may depend on that elsewhere.
