Foreword

This publication provides an overview of the evolution of the agricultural situation in the EU and in all Member States over the last 10 years. It can therefore be interpreted as a dynamic photograph of European agriculture at the beginning of the new century.

It is mainly based on statistical information from Eurostat, as available in September 2002. In certain cases, data collected or estimated by the Directorate-General for Agriculture have also been used.

This report contains three chapters. Chapter I focuses on the agricultural economy in the EU and covers the following aspects: the role of agriculture in the economy, structures of agricultural holdings, employment in agriculture, prices, income and trade. Chapter II gives an overview of the market balance sheets for a certain number of agricultural products. Chapter III covers the main budgetary aspects.









2.6. Standard Gross Margin per holding (Economic Size Unit)













4.8. Development in agricultural income in the EU (index form : base 1980=100 and %)





4.10. Farm profitability: ratio of gross farm income to total assets, 1991 and 1999 (%)




4.11. Fixed assets as percentage of total assets in 1991 and 1999 (%)

5.1. Total Agricultural World trade and EU market share (billion EUR)






5.2. EU trade in raw and processed products (billion EUR)

5.3.1. Cereals: Total world trade and EU market share (million EUR)





5.3.3. Livestock and meat: Total world trade and EU market share (million EUR)





5.3.5. Fruit and vegetables: Total world trade and EU market share (million EUR)











5.5.1. Intra-EU export per Member State - 2001









1.2.1. Development of European balance sheet - Durum Wheat





1.3.1. Development of European balance sheet - Total coarse grains







1.5.1. Development of European balance sheet - Grain Maize










































1. Budget breakdown: EAGGF Guarantee Section* 1993-2001 in the EU (million EUR)



2. Trend in EAGGF Guarantee Section expenditure by Member State (million EUR)







7. Development in the PSE of the agricultural sector as a whole in the EU (in % of the value of total gross farm receipts)


