Victorian Literature

This module will explore the Victorian period through the close study of important Victorian novels, of some of the poetry, and of some non-fictional prose of the period. It is envisioned that the texts studied will change on a regular basis, and will most likely include writing by Dickens, the Brontës, Trollope, Thackeray, Gaskell, Hardy, Tennyson, Browning, Barrett Browning, Clough, Hopkins, Swinburne, Rossetti, Carlyle, Ruskin, Pater, Wilde, and some popular and children's writers.

Learning Outcomes

To develop an understanding of some important Victorian writing. To develop awareness of the historical and social context in which this writing was produced.

To explore the development of particular genres and themes.

To acquire knowledge of critical approaches to the material.

To develop ability to focus discussion of particular issues through analysis of particular texts.
