In recent years, the medieval and early modern Waldensians have enjoyed a renewed scholarly interest giving rise to a number of new publications. Moreover, 2017 marks the anniversary of Reformation which resulted in a number of scholarly events. There are, however, significant gaps in scholarship on the Waldensians, most notably a lack of critical editions as well as studies around topics such as intertextuality and the circulation of texts. Such research would allow scholars in the field to gain a better knowledge of Waldensian text production and the place of that movement within the medieval and early modern religious space in Europe.

The Trinity Centre for Medieval and Renaissance Studies will be hosting a conference on the Waldensians on the 9th to 10th February 2018 in Trinity College Dublin. The purpose of this conference will be to advance this discussion of the movement and to foster international collaboration in Waldensian studies. Negotiating in Europe: Celebrating François de Callières (1717-2017)

The paper will be in English.

Alain Lempereur is an affiliated faculty and executive committee member of the Programme on Negotiation (PON) at Harvard Law School. His recent research and expertise address responsible negotiation and leadership, as well as humanitarian negotiation and mediation. In the past 25 years, in over 60 countries, he has conducted consulting missions and executive training for international organizations (eg. EU, FAO, ICRC, MSF, OCHA, OECD, NRC, UNDP, UNEP, UNITAR, WHO, WWF), national governments, global consulting firms (The Boston Consulting Group, McKinsey, etc.) and

corporations (eg. Faurecia, Generact, Orange, Sanofi-Pasteur, Scientific-Atlanta, Vivendi). He belongs to the UN mediators' network. He established Essec Irene, a European negotiation institute that he led during fifteen years. He created the negotiation teaching at ENA (1997-2010) and at the European Commission (2004-2010). He also became the Essec Negotiation and Mediation Chair Professor. He was a visiting professor at Harvard University and lectured at the Fletcher School of Law and Diplomacy, the Afghan Institute of Diplomacy, the Algerian Institute of Diplomacy and International Affairs, the Cameroon Institute of International Relations, the College of Europe, the Cyprus International Institute for Management, the Lebanese University, the Paris School of International Affairs, ParisTech, the UN University for Peace, the Universities of Brussels, Corsica, Mannheim, Mons, Paris II and V.
