POLITICAL STUDIES ASSOCIATION OF IRELAND

PROPOSED CONSTITUTION

- 1. The name of the Association shall be the Political Studies Association of Incland (Cumann Polaiteolaiochta na hEireann).
- 2. The aim of the Association shall be to promote the academic study of politics in both philosophical and empirical modes.
- 3. Membership of the Association shall be open to members of the staff of third-level institutions and of other appropriate bodies who are engaged in teaching or research in the area of politics; to post-graduate students of politics; and to other persons approved by the Committee. The subscription rate shall be determined at the Annual General Meeting.
- 4. The affairs of the Association shall be conducted by a Committee which shall consist of a President, Vice-President, Secretary, Treasurer and six ordinary members, elected at the Annual General Meeting, and up to three members co-opted by the Committee. Any election shall be conducted by means of the single transferable vote by a returning officer appointed by the outgoing Committee. The term of office of Committee members shall expire at the succeeding Annual General Meeting. Vacancies occurring between Annual General Meetings may be filled until the following Annual General Meeting by the Committee from the list of members. At Committee meetings five shall form a quorum.
- 5. The Association's business year shall end on each 31st December. Cheques shall be signed by two persons so authorised by the Committee. The accounts shall be kept by the Treasurer and shall be audited and certified annually, and the audited accounts for the year shall be submitted to the next Annual General Meeting for approval.
- 6. At least one week prior to the Annual General Meeting, each member shall be sent a notice listing the main businesses to come before the meeting.
- 7. A Special General Meeting of the Association may be called by the Committee or upon the request of one third of the membership.
- 8. In case of an equality of votes at any meeting of the Association or of its Committee, the person presiding shall have a second or casting vote.
- 9. Any doubt that may arise as to the interpretation of this constitution shall be determined by the Committee, subject to appeal to a general meeting.
- 10. This constitution may be amended at the Annual General Meeting. Motions to amend the constitution must be received by the Secretary at least two weeks prior to the Annual General Meeting. The Committee shall, however, be empowered to accept emergency resolutions at the Annual General Meeting.

NOTES ON PROPOSED CONSTITUTION

This document has been drafted after examination of the constitutions of three comparable associations: the Sociological Association of Ireland, the Geographical Society of Ireland and the Irish Association for European Studies. It is much shorter than the others, confining itself to essential points and leaving a good deal for interpretation or to be decided elsewhere.

The following matters that arise in other constitutions have been omitted, but might require to be dealt with: grades of membership; alternate Committee members; date of AGM; frequency of Committee meetings; fate of funds if association dissolves; details relating to elections (nominations, etc.); question of who shall chair meetings; date from which subscriptions are valid; preparation of a roll of members. It could, of course, be argued that some at least of these are covered by implication in the constitution.

Note the following particular points:

- Art. 1: All other societies seem to have an alternative Irish name. It may solve problems later if we adopt one now.
- Art. 2: This is adapted from the announcement of the formation of the Association published in the Sociological Association of Ireland Bulletin, no. 28, March 1982.
- Art. 3: This is a formulation of the policy on which, I believe, we agreed at our first meeting.
- Art. 4: This may appear to be a top-heavy body in view of the small number of members, but if the quorum is to be set at five we would need at least double this number of committee members to ensure that meetings could take place. "President" has been used to avoid the "Chairman/Chairperson" issue. Use of the STV for Committee elections is likely to cause all kinds of difficulties; but in practice we will probably have few elections. In theory, the one-year term of office might cause instability, but in practice the opposite problem colonisation of offices by a small number of individuals is more likely in our case.
- Art. 5: This appears to be a bit formidable, but something like this is probably essential. I assume that the Association will have a current account. Colleagues in Business Studies departments would presumably be willing to act as honorary auditors?

1. ADOPTION OF CONSTITUTION:

The draft constitution was adopted, subject to the following amendments:

Art. 1: Accuracy of Irish version of title to be checked;

Art. 2: Delete "academic", delete words after "politics";

Art. 3: Add "and shall be due by 1 January";

Art. 4: Reduce number of ordinary elected members to four; reduce quorum to four; insert as third sentence "Only paid-up members shall be entitled to vote in Committee elections";

Art. 5: Replace "business year" by "financial year"; insert after "certified annually" "by a person designated by the Committee";

Art. 6: Add provision that each member shall be notified of the date of the Annual General Meeting at least four weeks before the date of the meeting.

It was decided that the next annual conference should be held in Northern Ireland under the auspices of the University of Ulster, preferably in Derry in late September or early October. Paul Arthur agreed to act as conference convenor.

5. OTHER BUSINESS:

Michael Laver, conference convenor, reported that the event had been successful financially and would show a profit.
