


Legacy Stories

ROB VAN MESDAG

Rob Van Mesdag (1930-2018) came to Trinity from the Netherlands in 1949 to study Commerce. He lost one brother, an RAF pilot, in the war; another had been interned in a German camp. As a rower, Rob won the Emerald Challenge Cup for senior scullers at the Trinity Regatta in 1949 and represented the Netherlands at the European Championships from 1952-1956, winning bronze in 1955, and competing at the 1952 Helsinki Olympics.

Rob worked for the family business, Van Houten Chocolate, until it was sold in 1962, after which he moved to London as the rowing and sailing correspondent for Dutch and English newspapers. He lived in Fulham with his partner, Michaele Wellington-Hall, and served as a warden in All Saints Church, and ambassador for the homeless charity 'Crisis'.

He came over for the Trinity Regatta each year and was elected president of the Dublin University Boat Club (DUBC) from 1990 to 2006. He left a legacy to Trinity in his will and seed funding to DUBC, which was used to fund the Rob Van Mesdag Summer Rowing Camps for secondary school students coming from disadvantaged areas.









ELLIS AND JANE BRADFORD MARY CARSON

Ellis Eugene Bradford and Jane Dolan Bradford were New Yorkers who came to Trinity on the 'GI Bill' in 1947, Ellis having served at the Battle of Okinawa. They were influenced in choosing Trinity because three of Jane's grandparents were Irish. Ellis studied mathematics before switching to classics, and Jane studied English literature.

After graduation, Ellis was recruited by the First National Bank in New York, later Citibank, where he spent his entire career. The family, now with three children, lived in Venezuela, Geneva, Paris, Casablanca and Liberia. Ellis was a life trustee of Trinity and the university awarded him an honorary LLD in 1989. As philanthropists who believed in the power of education, Ellis and Jane endowed access scholarships at Hamilton College and left a generous legacy to Trinity for its unrestricted use. The college is using this legacy gift for the Trinity Sanctuary Fund, established in 2022 to support students seeking sanctuary.

Mary Carson graduated from Trinity in Natural Sciences in 1962. After obtaining her doctorate in 1965, she worked in ETH in Zurich, one of the leading chemistry schools in the world, before returning to Trinity in 1967 and making history as the Department of Chemistry's first female lecturer.

Mary was a dedicated tutor, always prepared to help students with any issue, academic or personal, and she was instrumental in building up the chemistry library, the nerve centre for research. On retirement in 2000, she continued to assist at the annual Trinity Book Sale, and she left a gift in her will to support the research mission of the School of Chemistry, as well as establishing an annual student book prize in her name for Freshman students.

FUND MEDICAL RESEARCH

Trinity is ranked in the global top 1% for medicine and biological sciences. Our renowned medical research institutes in Biomedical Sciences, Neuroscience, Translational Medicine and the recently established Trinity St James's Cancer Institute are co-locating Trinity's interdisciplinary research with the clinical expertise of partner hospitals to pioneer new ways to prevent, detect and treat disease and other health issues.

PROTECT OUR HERITAGE & CULTURE

Trinity's historic campus, home to the Long Room and the Book of Kells, is unique and irreplaceable. For more than 430 years it has been a beacon of learning and culture in Dublin, Ireland and Europe. Our campus is a dynamic living space, constantly invigorated by new buildings, art, sporting facilities, plantlife and botany. Through a legacy gift, you can be part of protecting and enhancing our living campus into the future.

A Legacy that Endures Forever

GIVING TO TRINITY'S ENDOWMENT FUND

By choosing to direct your legacy gift to Trinity's Endowment Fund you can ensure it continues to benefit Trinity in perpetuity. The Trinity Endowment Fund ('the Fund') is a collection of over 440 individual funds, both new and historic, with the earliest dating back to the 1820s. It is a vital pillar of university financing which is used to fund research, support teaching and learning, and assist students in need. The capital sum of your legacy gift to the Endowment Fund would remain invested with the annual income directed to your choice of School, scholarship, research activity or another area of your choice.

The Fund is managed by the university's Investment Committee, which maintains a well-diversified portfolio across asset classes and geographic markets, thus minimising risk and protecting the capital value. The portfolio is structured to provide good returns with reliable cash generation and low volatility. The Committee takes a proactive, market leading approach to sustainable investment and this has reduced the portfolio's carbon footprint and enhanced its sustainability profile.

In the past decade, the Fund has more than doubled: from €144 million in 2014 to €290 million today – €18 million of this increase has come from new gifts to the Endowment Fund, with the rest the result of good investments. Over the past decade, the Fund has generated three and five year returns of 27.1% and 38.9% respectively, enabling it to provide €58 million of income to the University over the decade 2013-2023. A strong Endowment Fund will ensure Trinity thrives for future generations.



Endowment Fund in Numbers

DID YOU KNOW?

Trinity Endowment Fund supports the Postgraduate Traveling Scholarship in Medicine and Surgery and the Provost's Asian Travel Bursary. It also funds the Mainie Jellet Fund which was established in 1987 by members of the artist's family to help students in art history to travel abroad.



Leave a Legacy to Trinity

Leaving a gift in your will is a tax-efficient way to support the charitable causes and organisations that are important to you. As legacy gifts are entirely exempt of inheritance tax, 100% of your gift will be directed to support the university.

If you would like to remember Trinity in your will, there are a number of different options:

- » A Residuary gift: a percentage of your remaining estate after fees and other gifts have been taken care of
- » A Pecuniary gift: a fixed sum of money
- » A Specific gift: an asset or shares

We can provide suggested wording for your will, along with our registered charity number, to ensure that your gift can be efficiently transferred to the university and allocated in accordance with your wishes. We recommend that you always consult your solicitor.



Taking the Next Step

If you are considering making a provision for Trinity in your will, we are very grateful.

Your will is a private document but if you choose to share your intentions with us, we can work closely with you to ensure your wishes are met and we can thank you for your support as a member of the 1592 Circle.


