The right care, in the right place, at the right time

Ireland's complex, fragmented health system continues to penalise patients through very long waits to access care, high out-of-pocket charges and an over reliance on hospital care. This is recognised by the WHO, the European Commission and the OECD (Organisation for Economic Co-operation and Development) as needing reform.

Sláintecare is Ireland's national healthcare reform plan, adopted by government in 2018, aiming to deliver universal, accessible, quality, integrated healthcare.

Professor Burke was part of the Trintiy team, who provided technical support to the crossparty Committee on the Future of Healthcare who developed Sláintecare.

Professor Burke's research supports reform implementation through identifying the barriers to reform and promoting evidence-informed research and strategies to strengthen health systems and promote equity. She both collaborates with and challenges health systems leaders to deliver on reform.

This work showcases Trinity's expertise in supporting large-scale reform projects over the long-term, supporting policymakers in devising the policy while also holding them to account via rigorous analysis of the implementation process.

Supporting the development of Sláintecare

As a key member of the Trinity team providing technical support of the Oireachtas
Committee on the Future of Healthcare,
Professor Burke provided evidence and analysis, ensuring the plan was both realistic and ambitious. They hosted three workshops with the Oireachtas Committee – the first ever 'workshops' with an all-party Oireachtas
Committee. This led to assisting the
Committee with its remit 'to devise crossparty agreement on a single long-term vision for health care and direction of health policy in Ireland'

This work significantly influenced the final report, published on 30 May 2017, entitled Sláintecare. In 2018, Sláintecare was adopted by government and in 2025, it remains the key health pillar of the new Programme for Government and of irish health policy.

Current Monitoring Project

She is currently Principal Investigator on a HRB/Department of Health Evidence for Policy grant researching and writing a new Health System in Transition report for Ireland. Published in June 2026 by the European Observatory on Health Systems and Policy to coincide with Ireland's presidency of the EC, this will give a high-level overview of Ireland's health system and policy, allowing progress to be tracked over time.

COVID-19 Project

Previously, Professor Burke was funded in a Partnership Award with the Department of Health and the HSE to monitor progress on the design and implementation of the regions. This found the governance of the design and implementation of the new regions lacking transparency and accountability. Her work combines academic research, public commentary, and policy advice, pressing for stronger governance and genuine reform.

Presentations to Government

Professor Burke frequently presents to the HSE, the Department of Health and the Houses of the Oireachtas. In 2021 – 2024, she led a team which presented research findings at internal seminars to the Department of Health and public webinars to the HSE. These detailed her team's research findings including the rapid system change that occurred during the COVID-19 pandemic and the risk of the system reverting to type. In March 2023, she was invited to appear before the Oireachtas Health Committee assessing progress on Sláintecare reforms.

Professor Sara Burke is Director of the Centre for Health Policy & Management in Trinity College Dublin's School of Medicine. She is also co-Director of the national SPHeRE PhD programme.

A recognised expert in Irish health service reform, she is currently the Principal Investigator of a research project entitled *Producing a Health in Transition health system review (HiT) for Ireland as part of the European Observatory on Health Systems and Policies HiT series* and leads a team who report on Ireland for the European Observatory Health Systems COVID-19 response monitor.

She has over 25 years of experience as a researcher in health policy, publishing *Irish*Apartheid, Healthcare Inequality in Ireland in 2009 and being a consistent voice appearing weekly on healthcare reform on Irish national radio between 2008 and 2015.
