Report of the Irish Language Officer</b></p> <p>The Irish Language Officer gave an account of the events of the term and the ongoing work of the Office.</p> <p><b>2020/21 Residency Scheme</b></p> <p>The application process for the 2020/21 Residency Scheme is open for current students. It is intended to hold the interviews on Microsoft Teams and work is underway with the university's IT Services to decide on the best approach for this process.</p> <p>The Residency Scheme for first year students will not be advertised until further information is available on the Leaving Certificate and the dates and approach that will be required in the new academic year. There is currently a lot of uncertainty surrounding these matters and therefore, it is difficult to plan ahead for the Scheme.</p> <p><b>Irish Language Classes</b></p> <p>There are twelve learners registered for the online classes and this subscription will expire at the end of May.</p> <p>A new supplier contract will be required in the new academic year. At this point, it may be necessary to hold all classes online for Michaelmas Term. This may reduce the choice of suppliers available as they will need to be capable of providing live online classes. It is currently difficult to estimate how much interest there will be in the courses if they are fully online.</p> <p><b>Conversation Circle</b></p> <p>The conversation circle was held online on a pilot basis last week and those who regularly attend, and a number of staff and students were invited to take part. Over 20 people took part online for one hour. There was a significant amount of interest in the event and it is intended to continue on a trial basis.</p> <p><b>Induction for new staff</b></p> <p>The new staff induction has moved online with the programme greatly reduced as it only lasts for two hours. There is currently no opportunity to present on Irish language matters. It is currently being evaluated how information on Irish and other areas can be shared in a different way online.</p> |
