

## TJH Law Study Abroad Options 2023/24



\*Michaelmas term only exchange permissible due to College requirement that you **cannot** finish a minor subject abroad in JS year. Full year and Hilary term exchanges are not permitted as you would finish your minor subject abroad.

If you wish to study abroad and graduate with an LL.B. degree, you must follow pathway Option B where you study 30 ECTS Law and 30 ECTS Business in JS Year and 60 ECTS Law in SS year.

You cannot study abroad if you follow pathway Option A, whereby you study 40 ECTS Law & 20 ECTS Business in JS and SS year, as it would be too difficult to study all the required Professional Law modules.

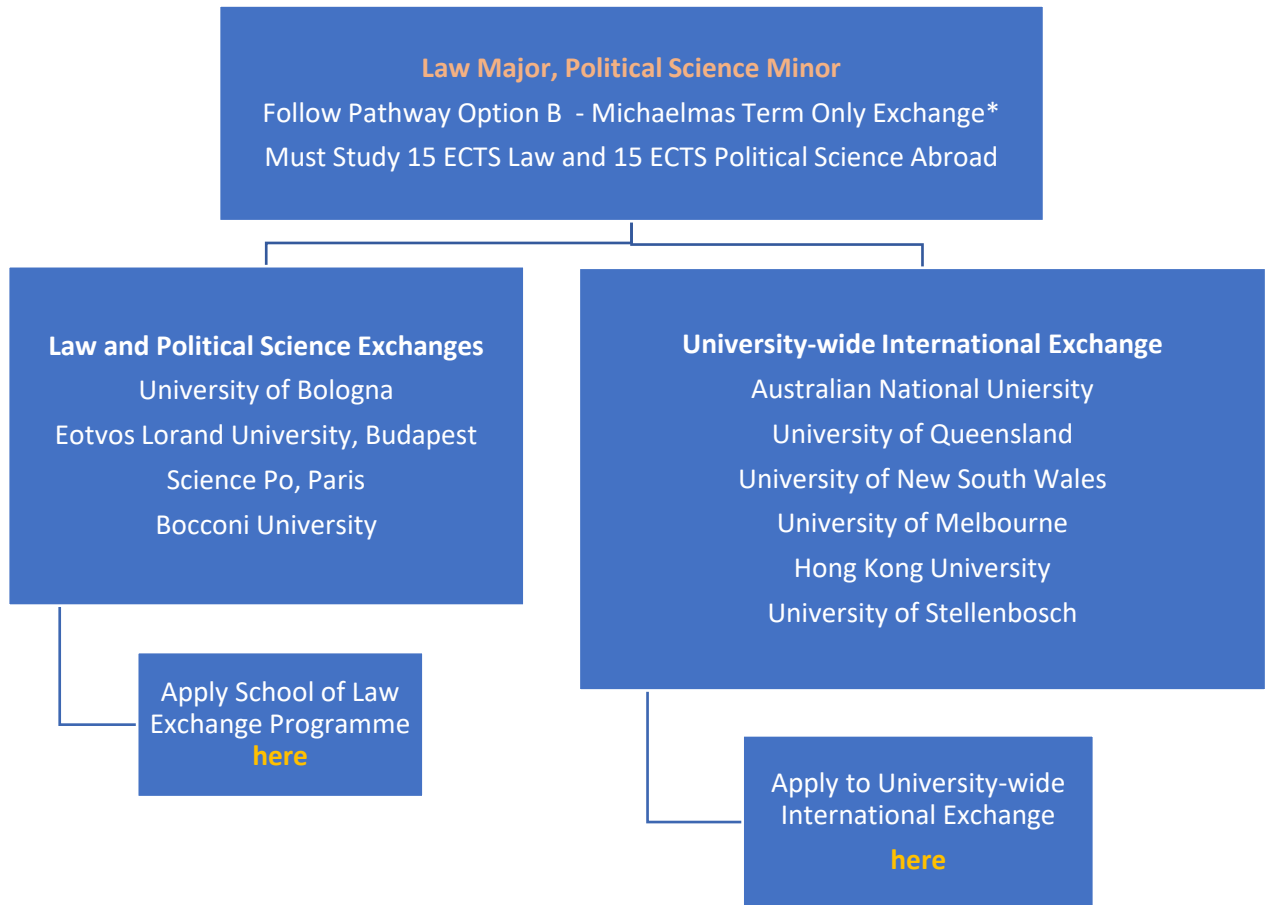

You cannot study abroad if you follow pathway Option A, whereby you study 40 ECTS Law & 20 ECTS Political Science in JS and SS year, as it would be too difficult to study all the required Professional Law modules.

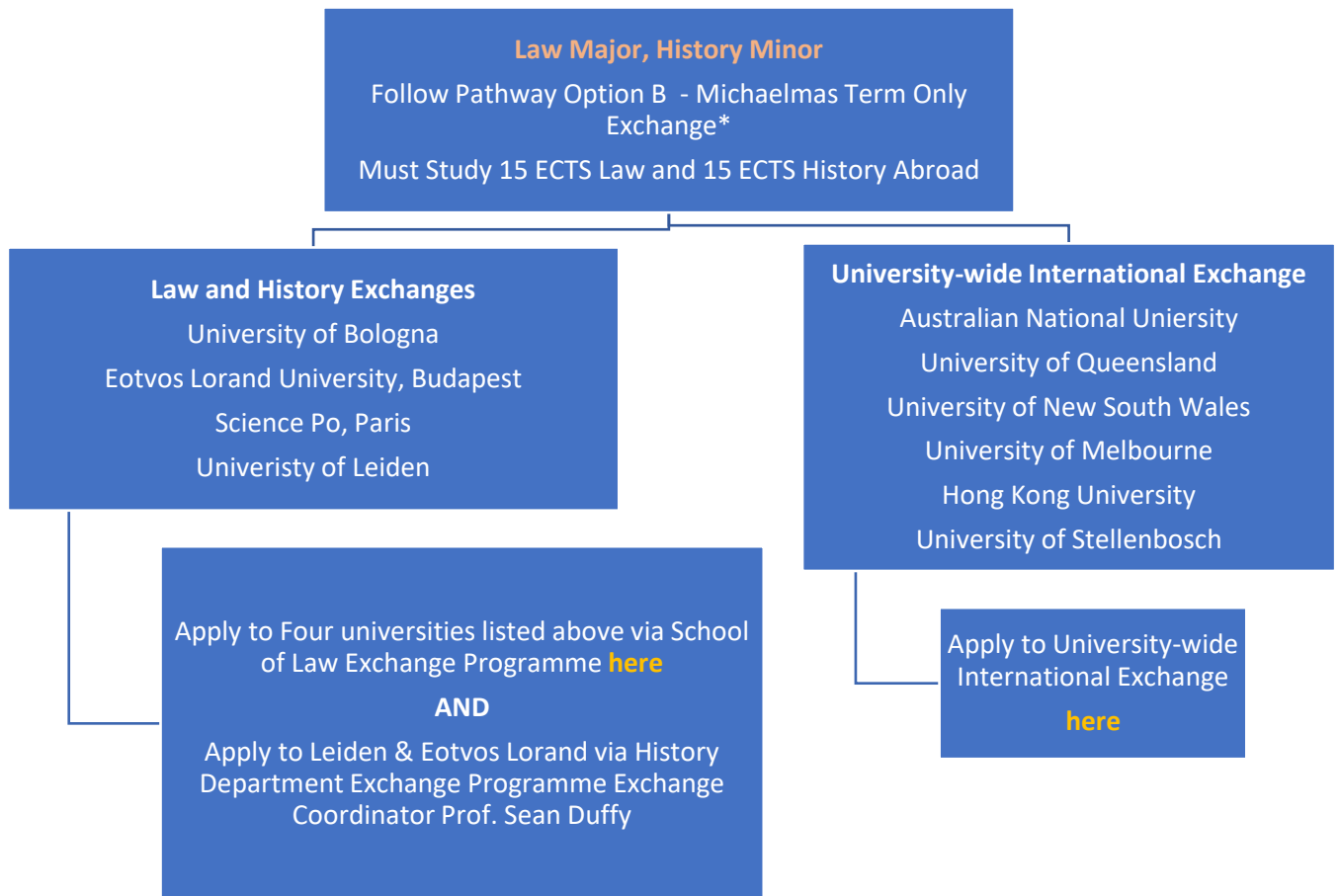

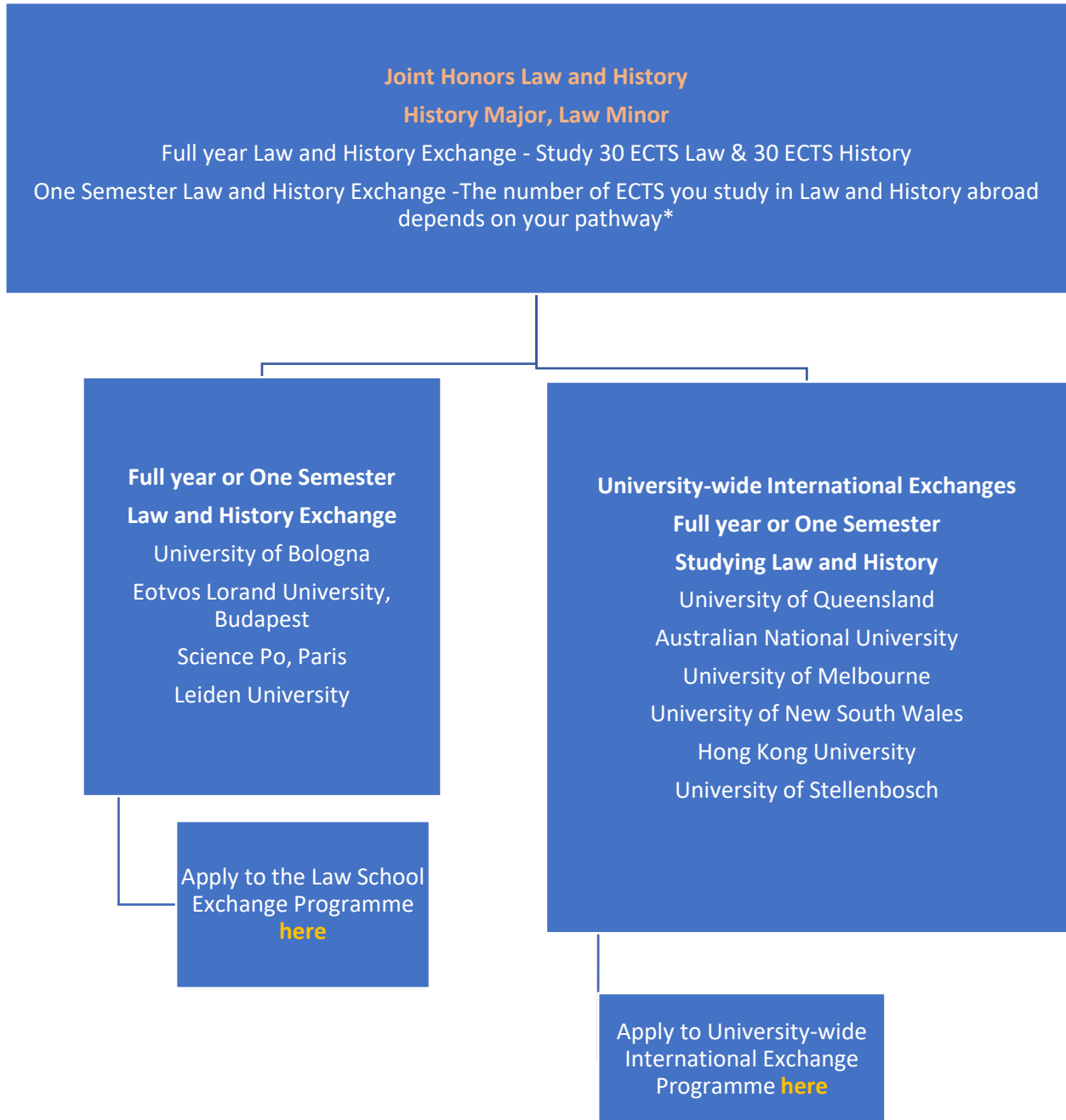
