Section A

Helpful Information about the Programmes and Studying Abroad

This document outlines the rules and requirements for Junior Sophister students currently taking part in the exchange programme 2019/20. Senior Freshman students applying for the exchange programme in 2020/21 should also follow these Rules & Requirements for the application process and to anticipate what rules will govern their study abroad experience for 2020/21. Please note the rules are updated every October and can change slightly each year.

Participation in the Law School European Erasmus or Non-EU Exchange Programme is an ideal way of broadening your horizons, improving your language skills, learning about the culture and legal system of another country and developing transferable skills which will stand to you in the future. While living and studying abroad is an inherently challenging experience, at both personal and academic levels, the Trinity students who are selected to go abroad tend to adjust to their new environments and acquit themselves well. The students who have participated in the scheme since its inception have attested as to its value and how delighted they were at the opportunities it afforded them.

The essential premise of the programme is that a student travels abroad usually for the full academic year, but also possible for one semester, in the Junior Sophister year College regulations do not permit us to offer exchange participation in any other year. The rules of the Law School will apply to those exchanges; however, additional rules may apply. Law students may apply to other universities (for example Australian National University, University of Queensland) via non-EU College-Wide exchange procedures through Academic Registry. We understand that you cannot yet make a firm commitment, but we need indications of serious interest on the part of applicant students. Thus, unless you are reasonably committed to taking up a place, if offered one, do not fill out the Law School Exchange Programme application form. The deadline to apply is **Monday 16th December 2019 at 5pm.**

Think carefully about your list of preferences and **do some research** into all the options you are considering. All of our partner universities are very distinguished and highly reputable. You can find a great deal of useful information on their websites: see

<http://www.tcd.ie/law/programmes/undergraduate/year-abroad>. Use this information both in deciding the order of your preferences and to find out all you need to know before travelling to the university to embark on a year of studies. There are limited places for each university; we must send the same number of students that we receive. There are quotas agreed in our exchange agreements, and we cannot amend the quotas unless the other university is also willing. We will do our best to accommodate your first preference, or at least a choice you will be happy with, but this cannot be guaranteed. In particular, we expect there to be high competition for places at universities where English is the language of instruction. Therefore, if you are putting these universities first, please also consider whether, in the event you were not offered a place in your preferred universities, you would prefer to study next year in Trinity or in a different partner university.

The student going abroad continues to pay Trinity fees, in so far as these are required, but pays **no registration fees** to the host university. In exceptional cases host universities may require administration fees or other charges. Participation in the Erasmus programme (this does not include non-EU exchanges) is usually assisted by a grant from the European Commission, but this is not guaranteed. Students can apply for the grant through Academic Registry. The Law School has no say in the allocation or distribution of the grant. You can contact erasmus@tcd.ie for more information.

The Law School can only provide you with limited assistance with regard to information on **accommodation** and **modules abroad**. You are advised to get in touch with the contact person at the host university for information regarding modules and accommodation. You should also check the host university's website to learn as much as possible about your destination and avail of any advice offered there to visiting students. You may find it useful to make contact with other Law School students who have been there before. You can obtain student contact details from the Law School International Student Office law.exchange@tcd.ie.

Bear in mind that many universities report an accommodation shortage. If your host university offers student accommodation, please carefully note and respect the deadline to apply. If you do not secure student accommodation, you are advised to arrive a few weeks in advance of the term to ensure that you get settled and find accommodation before lectures begin. It is advisable to investigate accommodation in your new destination as early as possible, even at the beginning of the summer vacation. In any case, there is often a certain amount of

bureaucracy to deal with on arrival in a new country and you should allow plenty of time for this before classes start.

The Erasmus/Exchange Academic Coordinator (Dr. Caoimhin MacMaolain law.exchange@tcd.ie) is available to answer academic queries but any such advice is likely to be very general in nature. For information on accommodation, modules etc., **students should take guidance first and foremost from the host university.**

Section C

Regulations for Erasmus and Exchange Programmes

1. Application

In order to apply to study abroad in your Junior Sophister year on an Erasmus or Exchange programme, you must do the following:

Visit the Law School 'Year Abroad' webpage

(<http://www.tcd.ie/law/programmes/undergraduate/year-abroad/>) and carefully read the Erasmus and Exchange Rules and Requirements (this document) and Personal Declaration for Study Abroad. If you agree to abide by the rules and personal declaration for study abroad, you can complete and send the following documents electronically to law.exchange@tcd.ie by 5pm

Monday 16th December 2019:

- ☐ Law School Exchange Programme application form
- ☐ Signed Personal Declaration for Study Abroad
- ☐ Submit a motivational letter and CV

Provisional offers will be made on the basis of the following criteria:

- ☐ Grades received in Junior Fresh year;
- ☐ Proficiency in the language of instruction at any institution where you are applying for a place;
- ☐ Level of interest in and suitability for the particular place, as evidenced in motivational letter and CV.

Interviews will also be conducted in respect of Indiana University, Bloomington in January 2020.

A final offer is strictly dependent on you achieving a II.1 in your Senior Freshman examinations in your first attempt. If a student fails an exam in the May examination period, he cannot resit it in August and go abroad based on results obtained in the second attempt.

The provisional and final offers will be notified to your TCD email address. You must accept each offer within the time specified in the email; otherwise, it will lapse.

2. Workload requirements

As in Trinity, you will be required to complete a certain number of credits in your Junior Sophister year abroad. Trinity, along with all universities in Europe, applies the European Credit Transfer System (ECTS). An ECTS is a measure of student learning input. This allows for a standardised comparison of workload across universities. For Non-EU universities, not using the ECTS credit system, you will be required to study what is considered a standard workload in that university (see page). Whichever applies, your workload abroad will be broadly equivalent to the Junior Sophister workload in Trinity. You must then satisfy the following requirements:

- ☐ For LL.B. students, if studying within Europe, you are required to complete law modules amounting to 60 ECTS.
- ☐ In recognition of the additional student learning input required in studying through a foreign language, a module taught through a language other than English will be multiplied by 1.33 to determine its weighting in meeting your workload requirements and calculating your grade.
- ☐ Therefore, if you do all your modules through a language other than English, in effect you must do modules that the host university measures at 45 ECTS.
- ☐ If you combine modules taught through English and a foreign language, you are required to take 60 ECTS and the ECTS of the modules taught through a foreign language will be multiplied by 1.33.
- ☐ Law and Business students are required to complete 60 ECTS in total, including at least:
 - ☐ 20 ECTS of Business modules
 - ☐ 20 ECTS of Law modules

The remaining 20 ECTS must be either Law or Business modules with the exception of 5 ECTS which can come from any discipline, such as a language module.

- ☐ Law and Political Science students are required to complete 60 ECTS in total, including at least:

☐ 25 ECTS of Political Science modules

☐ 25 ECTS of Law modules

The remaining 10 ECTS must be either Law or Political Science modules with the exception of 5 ECTS which can come from any discipline, such as a language module.

- ☐ For the avoidance of doubt, the 1.33 weighting on modules taught through a language other than English also applies to the specific requirements for the joint degree programmes.
- ☐ In calculating your 60 ECTS completed credits (or equivalent outside Europe), you may include a maximum of 5 ECTS (or equivalent) of modules that are not part of your discipline(s).
- ☐ In calculating your 60 ECTS completed credits (or equivalent outside Europe), you may include a maximum of 10 ECTS (or equivalent) of pass/fail modules. A pass/fail module is a module for which no grade is awarded but which you take on a pass/fail basis.
- ☐ In some circumstances, you may complete more than the required 60 ECTS. When we convert your year abroad results, we will count the grades in your best 60 ECTS.
- ☐ If you participate in a one semester exchange, you are expected to complete a minimum of 30 ECTS (or equivalent) abroad and 30 ECTS in Trinity College Dublin, in order to complete 60 ECTS for the full academic year.
- ☐ For one semester exchange, when calculating your 30 ECTS completed credits (or equivalent outside Europe), you may include a maximum of 5 ECTS (or equivalent) of pass/fail modules.
- ☐ If studying outside of Europe, the table outlines the minimum number of credits students must complete to meet the course requirements abroad:

**Note that a Law module in an Australian university is converted as equivalent to 10 ECTS. A Business or Political Science module is converted as equivalent to 7.5 ECTS (in line with [ECTS Equivalents Credit Table for UK & Non-European Study Abroad Exchanges](#)). Students are expected to complete the equivalent of a minimum of 60 ECTS for full academic year.*

**** Note that a Law module in a National University of Singapore is worth 4, 5 or 8 credits. A Law and Political Science student is expected to complete a minimum of 16 local credits in law. Students are expected to complete a minimum of 16 local credits in Political Science.*

If you are a Law and Business student taking part in Business exchange in a non-EU College-wide partner university e.g. McGill University, University of Toronto, University of Sydney, you must complete the equivalent of 30 ECTS and all 30 ECTS will be counted for your semester abroad. For more details on choosing suitable Business modules and satisfying the 30 ECTS equivalent requirement, please contact business.exchange@tcd.ie.

If you do not satisfy any of these requirements, you will fail the year. The onus is on you to select modules that will allow you to meet these requirements. If you are taking part in a European Erasmus exchange you must fill in a Learning Agreement Form that will be provided to you. This Form will be reviewed by the Erasmus/Exchange Academic Coordinator. The Coordinator will approve your choice of modules and countersign the agreement only if the

overall requirements and discipline-specific requirements in terms of ECTS credits are met.

You should consult by email with the Erasmus/Exchange Academic Coordinator in relation to your module choices. You must submit your Learning Agreement by **1 November for the first term and 1 April for the second term**. Joint degree students should also consult the Erasmus/Exchange Co-ordinator in the Political Science Department and Business School to ensure their Political Science/Business modules can be approved and learning agreement signed.

3. Choosing Modules

You are permitted to study most law or law-related modules provided by the Law School in your host university, subject to the approval of the Erasmus/Exchange Academic Coordinator. If a module is taught in a Department outside of the Law School, you must show how the module includes legal material for it to be approved. You are not permitted to take a module abroad which you have already studied in Trinity College. The Erasmus/Exchange Coordinator may make an exception if the content of the module is substantially different. The same principle applies when you return to Trinity College in Senior Sophister year. You are not permitted to study a module in TCD which you have already studied abroad unless you have the approval of the Erasmus Coordinator and the lecturer in Trinity College Dublin. Students are encouraged to carefully plan their studies for their year abroad and take into consideration the modules they will need to study in SS year to meet professional legal bodies requirements. Students are recommended to study EU Law or Jurisprudence abroad to cover the compulsory law modules required for the professional legal bodies.

The Law School provides a list of EU Law and Jurisprudence modules taught in our partner universities which have been approved in the past as equivalent to EU Law and Jurisprudence studied in Trinity for the purpose of gaining entry into the professional legal bodies. This list is circulated via email to students.

Please note that the Law School cannot guarantee that the same modules will be available during your year/semester abroad. You will need to check with your host university if the same modules are on offer during your year/semester abroad.

If there are no pre-approved modules listed for a partner university, you need to find a module on offer in the university and send a module description to the Erasmus/Exchange Coordinator to law.exchange@tcd.ie for approval.

Therefore the list of pre-approved modules offered is non-exhaustive. Modules will be added on a rolling basis, as new modules may be offered by partner universities that might also satisfy the relevant requirements.

Please note that that if a module has been approved on this list, it is not a guarantee that the module will always be approved in the future as approvals are subject to review, for example, there could be significant changes to module content in a pre-approved module.

If the Director of Teaching and Learning (Undergraduate), in consultation with the Erasmus Coordinator (and, where appropriate, module lecturers), deems a module taken abroad to be a satisfactory equivalent to the module in Trinity, the Law School can certify this to the King's Inns. Students must note, however, that the Law School cannot give any commitment to students that outside professional or other bodies will necessarily regard modules studied abroad as meeting those bodies' particular requirements. Students are therefore advised to check the requirements of particular professional bodies directly with those bodies.

Research Methods Module Requirement for Law and Political Science Students:

If you wish to study Political Science exclusively in your Senior Sophister year or plan to conduct a Year Long Research Project (Capstone / Dissertation) in Political Science in your Senior Sophister year, then you need to study a Research Methods module in your Junior Sophister year.

If you take part in the exchange programme in your JS year you are recommended to find an equivalent of Research Methods module in your host university and seek approval from the Erasmus/Exchange Coordinator, Dino Hadzic (DHADZIC@tcd.ie) in the Political Science Department and the lecturer in charge of the Research Methods module at Trinity (Thomas Chadeaux (chadefat@tcd.ie)). You are permitted to look in other departments in your host university for an equivalent Research Methods module e.g. Economics or Sociology Departments may provide a suitable module.

If you take part in a **one semester Michaelmas term** exchange in JS year, you have two options to meet this module requirement:

1. Find equivalent of [POU33011: Research Methods for Political Science A](#) in your host university and seek approval from Erasmus/Exchange Coordinator in Political Science Department and the lecturer in charge of the Research Methods module at

Trinity (Thomas Chadeaux (chadefat@tcd.ie). You can then join [POU33012 Research Methods for Political Science B](#) in Hilary term in Trinity College.

2. If you cannot find equivalent Research Methods module taught abroad, you may have the option to follow POU33011 remotely during Michaelmas term semester abroad, if the lecturer permits. You must complete course work independently. You will not receive credit for POU33011 if you follow the module remotely while abroad. When you return to Trinity in Hilary term, you can join POU33012 Research Methods for Political Science B.

If you have any queries regarding this issue, you can contact the Erasmus/Exchange Coordinator, Dino Hadzic (DHADZIC@tcd.ie) in the Political Science Department.

If you do not want to major in Political Science in SS year or you do not plan to conduct a Year Long Research Project (Capstone / Dissertation) in Political Science in your SS year, then it is not mandatory to take this Political Science Research Methods module in your JS year.

Compulsory Independent Research Requirement Rules

There is a **College requirement** of an independent research project/dissertation in the Sophister years for all degree programme entrants from 2014 onwards.

The Law School's aim is to facilitate all law students, including those who study abroad, and students on joint degree programmes, to be able to complete their degree having covered all professional body requirements (if they wish to do so).

Please find below information on how Law, Law and Business, and Law and Political Science students can meet the independent research requirement in their Sophister years.

Law

10 ECTS Research Project in the SS year.

OR

If you spend your JS year abroad:

- You may choose as part of your JS year to complete a 5 ECTS pass/fail comparative law dissertation (that is, comparative analysis of something you studied on year abroad vis-a-vis the Irish law equivalent). This is assessed by Trinity, not the host university. The module descriptor is provided by the Law School

International Office.

OR

- You may choose to take the 10 ECTS Research Project above in your SS year instead.

Law and Business

10 ECTS Research Project in the SS year.

OR

Fulfill the requirement set out by Business

OR

If you spend your JS year abroad:

- You may choose as part of your JS year to complete a 5 ECTS pass/fail comparative law dissertation (that is, comparative analysis of something you studied on year abroad vis-a-vis the Irish law equivalent). This is assessed by Trinity, not the host university. The module descriptor is provided by the Law School International Office.

OR

- You may choose to take the 10 ECTS Research Project above upon your return in your SS year.

OR

Fulfill the requirement set out by Political Science

OR

If a Law and Political Science student across JS and SS years wants to take all the following law modules: private law remedies, equity, administrative law, constitutional law 2 (in SS year), EU, company, jurisprudence, evidence and English land law - then the student can meet the independent research requirement by being assessed in **constitutional law 2** by means of a long research essay instead of the standard assessment in that module,

OR

If you spend your JS year abroad

- You may choose as part of your JS year to complete a 5 ECTS pass/fail comparative law dissertation (that is, comparative analysis of something you studied on year abroad vis-a-vis the Irish law equivalent). This is assessed by Trinity, not the host university. The module descriptor is provided by the Law School International Office.

OR

- You may choose to take the 10 ECTS Research Project above upon your return in your SS year.

If a student opts to complete the 5 ECTS pass/fail comparative law dissertation during their JS year abroad, the year abroad mark would be assessed on the basis of the best 55-ECTS equivalents. If a student takes part in a one semester exchange, and complete the 5 ECTS pass/fail comparative law dissertation, the semester abroad mark would be assessed on the basis of the best 25 ECTS. Students must register their interest to complete this module by 1 November to law.exchange@tcd.ie and it must be included in the learning agreement. For students on Hilary term exchange, the deadline to register your interest is 1st March 2020. Please note that the assessment is graded on a pass/fail basis, therefore a grade is not provided. However the examiner will provide brief feedback on the assignment.

4. Grade Conversion

The Court of Examiners will first consider whether you have satisfied all the workload requirements. There is no general requirement that you pass modules. Your grade will be calculated on the basis of your best 60 ECTS (or equivalent if studying outside Europe) of modules completed. If you are studying for one semester abroad, your grade will be calculated on the basis of your best 30 ECTS (or equivalent) of modules completed.

Modules outside your discipline cannot count for more than 5 ECTS (or equivalent if studying outside Europe) of your converted grade.

Pass/fail modules, up to a limit of 10 ECTS (or equivalent if studying outside Europe) will be removed from the calculation of your grade conversion. Therefore, your grade conversion will be calculated on the basis of the marks received in the best 60 ECTS (or equivalent) of your other modules (or equivalent) less the ECTS (or equivalent) gained in the pass/fail modules. If you study abroad for one semester, pass/fail modules up to the limit of 5 ECTS can be removed from the calculation of your grade conversion. The Court of Examiners converts the grades from your host university to their equivalent in the Trinity marking scale. The scales applied by the Law School are available on the Law School Year Abroad website. The scales applied by the School of Business and Political Science Department are available from those

School's Coordinators.
