## Eligibility

To be eligible for an academic exchange at Trinity Business School you must be:

- a registered student at one of our Exchange Partner universities and institutions; and
- nominated by your home university/institution

Exchange students from our partners do not pay tuition fees. If you do not wish to participate in a formal exchange you may attend as a Visiting Student and fees will apply. Please check partnership arrangements with your home university/institution.

### TCD Admission Requirements

#### Academic Requirements:

All students must have completed a minimum of four full semesters of relevant third level studies prior to commencing their exchange. For three-year degree programmes, we can only accept students on exchange for the first semester of the third (final) year. Students must not complete their studies whilst on exchange. We do not accept students in their second year of studies.

For non-EU students a minimum cumulative GPA 3.1 or equivalent is required.

**Language Requirements:** The language of instruction at Trinity College Dublin is English. The required level is B2. If English is not your spoken language or the language of instruction at your home University, you will require proof of proficiency as follows:

- IELTS: Overall 6.5 with no band below 6.0
- TOEFL: 90 internet-based (& a written score of 21)
- Duolingo minimum overall score of 120/160 (no section <105): [Duolingo.com](https://www.duolingo.com)

## Teaching & Assessment

Teaching consists of lectures and tutorials. Class size is dependent on the module, most modules have no class size quotas. Assessment methods depend on the module but may include a combination of exams, individual/group coursework or assignments which may take place during the semester. Examinations take place at the end of each semester. Reassessment / Supplemental examinations for both semesters take place mid-end August.

## Module Choices

A wide-range of business modules are available from 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> years. All pre-requisites MUST be satisfied with equivalent learning:

Please note that these are subject to change prior to semester start. While we do accept post-graduate students, only the listed undergraduate modules are available to take. It is up to the home institution how credits and grades are managed.

TCD uses ECT credit system. Exchange students take 20-30 ECTS per semester and a majority of business modules (minimum of 50% ECTS in Business for Erasmus students). You may also choose modules in other departments with the approval of the relevant coordinator at the time of application. You may also take ONE Trinity Elective module per semester subject to available places. [Module Enrolment](#)

Trinity Business School holds mandatory information meetings for incoming students during Orientation Week. You enrol in your courses during this time with The Academic Registry. Early enrolment may be available, and you will be notified of this by email.

**Learning Agreements** will be signed after the final list of modules has been published on the TBS website.

Please do not ask students to sign LAs until the final list of modules has been published.

Learning Agreements will be signed via EWP Dashboard when possible, for Erasmus exchanges, or via a Business School document upload form when students have been registered in the TCD system and have an @tcd email address. Do not send LA by email.

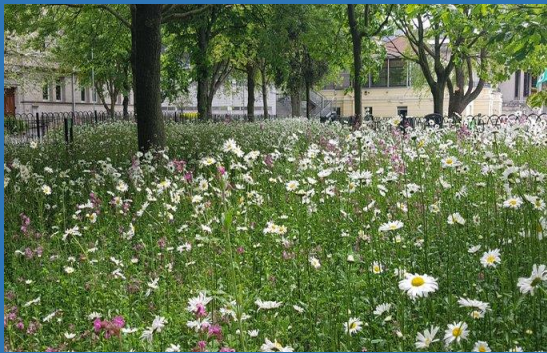

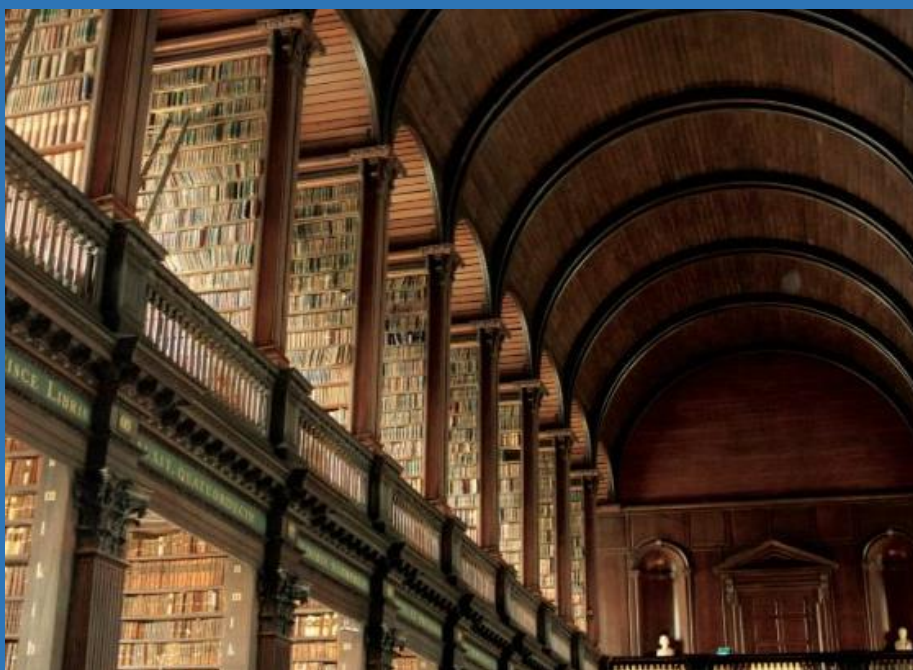
