A meeting of the University Council was held on 14<sup>th</sup> May 2025 at 11.15am in the Trinity Board Room, Trinity Business School.

### **SECTION A.1: Policy Matters**

The Provost welcomed everyone to Council. She thanked the Academic Secretary for whom this is last Council meeting and outgoing SU representatives – SU Education Officer, STEM and HS Faculty and Postgraduate representatives.

The Provost requested that Council members declare any potential conflicts of interest relating to the agenda. The Secretary to the College/Director of Governance advised Council that there were the following statements of interest declared:

- A.22 School of Physics Quality Report Professor Jonathan Coleman as Head of School The Secretary to the College/Director of Governance advised that Head of School would normally be asked to step out of the meeting for the item but noted that Professor Coleman had sent apologies for the meeting.
- A.23 School of Engineering Quality Report Professor Breiffni Fitzgerald The Secretary to the College/Director of Governance advised that he could remain in the meeting should there be discussion on the item.

# CL/24-25/179 Proposal to remove 30ECTS credits in Dual B.A. Programmes with Columbia University and to revise the degree calculation for entrants from 2026/27.

The Senior Lecturer and Dean of Undergraduate Studies presented a proposed revision to the degree calculation of the Dual B.A. Programmes with Columbia University, awarded by the University of Dublin, which have been operating very successfully since 2017. The proposed revision specifically included:

- the removal of the additional 30 ECTS Trinity credits from the Dual B.A. Programmes during the sophister years while students are attending Columbia University, and
- a revised degree calculation ensuring that the Trinity Degree included students' academic performance from Senior Fresh (at Trinity) as well as Junior and Senior Sophister years (at Columbia).

This change will commence for entrants to the 2026/27 academic year onwards. This proposed revision addressed the challenges faced by Trinity students in completing all the requirements for the sophister years in Columbia University at the same time as fulfilling additional Trinity credits in those years.

Council held a brief discussion on the agenda item as presented. It noted that this proposal was for a specific change to an existing Dual Degree partnership, and that a broader strategic discussion regarding university partners and partnerships could be held at a future Council meeting, if desired.

# CL/24-25/180 PG Renewal: Blueprint for Multidimensional Skills Development for Trinity Postgraduate Students facilitated through existing offerings and a new Triple I (International, Intersectoral, Interdisciplinary) Framework activity engagement model.

The Dean of Graduate Studies introduced the item by giving the context and background on Multidimensional Skills Development and the Triple I (International, Intersectoral,

Interdisciplinary) framework. She then introduced Professor Rachel McLoughlin and Ms Orla Bannon, leads of two Postgraduate Renewal Programme work packages, who co-presented the Blueprint for Multidimensional Skills Development and Triple I frameworks for Trinity Postgraduate Students to Council. They outlined the extensive consultation undertaken and highlighted the following key points:

- The importance of ensuring that all postgraduate students taught and research have opportunities to engage with interdisciplinary, intersectoral and international activities.
- The roles and responsibilities of the university, students and supervisors supporting this initiative.
- The need to integrate the Triple I framework with the model for multidimensional skillset development for PGR students, as required under the Irish Universities Association (IUA) guidelines for doctoral students.
- That the current integrated framework is intended as a roadmap for research students to help them identify, engage in, and record learning activities that develop a wide range of skills, through engaging with Triple I experiences. This is proposed as an online interactive resource, captured within students' e-learning portfolios.
- That delivering on the benefits of this work will require centralised oversight of the framework, the development of a digital resource to share information with students, training for both students and staff, and functionality to enable students to record and document their achievements for future career purposes.

During Council's discussion, members highlighted the benefits of a centralised resource, which would improve accessibility for students and for staff applying for research funding. Council emphasised that both clearly defining the boundaries between opportunities and obligations and ensuring strong student engagement are essential to the success of the framework. It was noted that the current TRDA awardee cohort had played and will continue to play a valuable role in piloting the use of resources and identifying both benefits and challenges of the framework.

### CL/24-25/181 Senior Lecturer's Annual Report 2023/24

The Senior Lecturer and Dean of Undergraduate Studies presented the Senior Lecturer Annual Report for 2023/24 to Council. He outlined key activities and data from 2023/24 under following headings:

- Academic Integrity a comprehensive policy and procedure were developed in 2023/24.
- Trinity Education Project Council noted the ongoing embedding and further expansion of offerings.
- Education for Sustainable Development (ESD) Senior Lecturer and Dean of Undergraduate Studies reported on initiatives including five dedicated ESD fellows, the rollout of an ESD module to upskill academic staff, and an ESD module for all undergraduate students in Business.
- Undergraduate Admissions he reported on rising admission numbers but highlighted the
  relatively low percentage of students enrolling from Munster and Ulster, as well as decline
  in numbers coming through some Access routes. He outlined a range of All-Ireland
  initiatives managed by Trinity Global to enhance recruitment from across the island.

The Senior Lecturer and Dean of Undergraduate Studies concluded his report by presenting to Council the key activities that have followed the 2023/24 reporting period and advising of planned revision of the report format to better support decision-making.

Council held a brief discussion and recognised the need for a forum to improve understanding of broader Access initiatives.

### CL/24-25/182 The Library of Trinity College Dublin Annual Report 2023/24

The Librarian and College Archivist presented the Library of Trinity College Dublin Annual Report 2023/24 to Council. She reported that the Library has made determined and remarkable progress across each of its strategic strands in 2023/24:

- Pillar 1. Space The Librarian provided an update on Old Library Redevelopment
  Project including completion of the Research Collections Study Centre in the Ussher
  Library Atrium, completion of 'Book of Kells Experience' featuring digitised content
  from the Library's Virtual Trinity Library, and completion of fire suppression testing in
  Norway. She also reported on the new Laidlaw Library at Trinity East, which will be
  College's 8<sup>th</sup> library, and its first 21<sup>st</sup>-century library, and inaugural 'digital first and
  foremost' library; and the denaming of the Berkeley Library.
- Pillar 2 Digital The Librarian outlined the aftermath of the major cyberattack on the British Library and impact on UK electronic-Legal Deposit for Trinity.
- Pillar 3 Teaching Learning & Research She reported on findings of bi-annual Library Pulse Survey, and the programme of improvements.
- Pillar 4. Priorities Funding The Librarian highlighted key benefactors supporting the Old Library Redevelopment Project after events in the US, where the Provost & Librarian presented, and London.
- Pillar 5. Policies and Programmes She reported on the completion of Library Content & Collection Security Policy.

The Librarian also highlighted to Council some external events such as Cuala Press exhibition and Medieval Manuscript Symposium. She provided an overview of progress on the two crosscutting strategic strands of Sustainability & Climate Action and Equality Diversity & Inclusion.

The Librarian concluded the report by reflecting on the major geopolitical and socio-economic shifts ahead, the tectonic shifts in technology, particularly AI, issues of Digital Autonomy, Knowledge Security in tension with Open Scholarship. She paid tribute to all the individual staff in the many different roles across the Library, whose hard work and commitment had achieved the remarkable progress in 2023/24.

During a brief Council discussion, it was noted that a review of the most equitable approach to resource allocation would be conducted by the Library management team, that RFID (Radio Frequency Identification) tags for the rest of the collections were prioritised when funding became available, and that consultations on the digital-first library were ongoing, with an anticipated project completion date of the Laidlaw library at the end of 2027.

# CL/24-25/183 Vice-Provost/ Chief Academic Officer's Report

The Vice-Provost / Chief Academic Officer reported to Council that:

- Marino Institute of Education (MIE) an associated College of Trinity and a valued partner – is facing a challenging financial situation and is currently considering its options.
- The Vice-Provost / Chief Academic Officer thanked the SU Education Officer for his dedication, diplomacy and perseverance in bringing the Student Partnership Agreement document together. Regrettably, there was insufficient time to bring it through the necessary governance prior to Council review. However, the SU Education Officer has lived the values embedded in the draft through his tenure in office and was highly commended for this by the VP-CAO.

### CL/24-25/184 Provost's Report

The Provost provided an update to Council that:

- The Board will be asked to consider and approve the College Strategic Plan 2025-2030 at its meeting in June, with the implementation plan to be shared at the following meeting.
- The Scientific Council of the European Research Council (ERC) are looking to fill positions on their Council and they have issued a call in respect to this. Trinity may submit nominations directly or via the LERU network, and suggestions for nominations can be shared with the Dean of Research.
- Dr Diarmuid O'Brien had been appointed as the new CEO of Taighde Éireann- Research Ireland. He had previously worked in Trinity in the Centre for Advanced Materials and BioEngineering Research (AMBER) and as the Chief Innovation & Enterprise Officer.

The Provost also reported on the speech delivered by Minister for Further and Higher Education, Research, Innovation and Science, Mr James Lawless, TD, to IUA members earlier in the week. The Minister spoke of prioritising research and innovation, competitive calls for funding, a potential Talent Fund for all career levels, the possibility of a revised version of the Programme for Research in Third-Level Institutions (PRTLI) scheme, and student accommodation and access, amongst other priorities. The Provost noted that the overall message and direction appeared positive and that it will be important that the Arts, Humanities and Social Sciences (AHSS) are prioritised in delivering on this ambition. She added that the College and IUA would actively engage with the Minister and his department on the details and push for securing resources to deliver on these priorities.

During a brief Council discussion, it was suggested that nominating an AHSS representative to the ERC Scientific Council might send a strong message on the importance of Arts, Humanities and Social Sciences. It was also noted that government funding schemes may be more likely to support retrofit and refurbishment projects rather than entirely new capital developments.

The Provost concluded by encouraging Council members to bring strategic discussion items to future meetings.
