*Students on courses with clinical or other professional placements or on courses that will bring them into professional contact with children and/or vulnerable adults will be required to undergo vetting by the Garda Síochána (Irish Police Force), through the National Vetting Bureau, or other relevant police force prior to commencing placements. If, as a result of the outcome of these vetting procedures, a student is deemed unsuitable to attend clinical or other professional placements, he/she may be required to withdraw from his/her course of study.*
