Assistant Supervisors may be appointed to contribute intellectual insight and guidance, the extent and parameters of which may vary and should be negotiated with the student, the principal supervisor and the Thesis Committee. The Assistant Supervisor role is in addition to, never a substitute for, supervision by a Principal or Cosupervisor.
