Research Impact



Research Impact

Since its establishment in 2012, the Trinity Centre for Practice and Healthcare Innovation (TCPHI) has demonstrated a consistent and productive research trajectory, generating over 500 Scopus-indexed outputs. These include 358 journal articles, 5 books, 20 book chapters, 14 conference papers, 23 editorials and letters, and 76 reviews. These scholarly contributions have laid a strong foundation for continued influence across healthcare, academia, policy, and public well-being. While bibliometric data alone cannot fully capture research impact, it does provide insight into the uptake and reach of scholarly outputs. A range of measurable outcomes—often important precursors to broader societal impact—illustrate the centre's increasing engagement and influence.

Key indicators of influence include:


- Academic Citations: TCPHI's outputs have been cited nearly 10,000 times (9,584 citations in Scopus). The most cited article, Doyle et al. (2020), has received 878 citations, reflecting its prominence in nursing scholarship.
- Media Uptake: Altmetric data indicates that 498 of the centre's publications have received over 4,138 mentions across social media platforms.
- News Coverage: The centre's research has been featured 89 times in international and national news outlets, including Forbes, PLOS Medicine, Dermatology Times, The Irish News, and The Conversation.
- Blogs and Online References: Outputs have been referenced in over 30 blogs, including citations in Wikipedia (9 mentions) and YouTube (2 mentions), further supporting public and professional engagement.
- Policy Citations: A total of 129 publications have been cited in 114 policy documents spanning 25 countries. Notable citing bodies include the World Health Organization, OECD, the Analysis & Policy Observatory, and the European Observatory on Health Systems. Countries represented in these citations include Australia, Belgium, Ireland, France, Sweden, Canada, the UK, and the USA.
- Clinical Guidelines: Five outputs have been cited in clinical guidelines, signalling emerging translational value.
- Patent Citation: The work by Deparis et al. (2019) is referenced in a patent titled System and Method for Training a Machine Learning Model Based on User-Selected Factors, highlighting potential technological applications.

Research Impact



Pathways to Impact

Research impact is broadly defined as demonstrable benefits to society, the economy, culture, public policy, health, or the environment. While impact often materialises over time, TCPHI is already contributing to key areas with potential for long-term societal benefit.



One such area is the development and implementation of Advanced Practice Nursing (APN) roles. The centre is contributing to the international evidence base on the value of APNs in improving quality of care, patient outcomes, collaborative practice, and service delivery. For example, the article by Elliott et al. (2024) is cited in the forthcoming State of the World's Nursing 2025 report by the World Health Organization. This recognition of APN roles can inform legislative and policy developments, including national health strategies, human resources planning, and regulatory frameworks for nursing and midwifery

These outcomes represent significant steps towards broader, lasting impact and reflect the centre's commitment to evidence-informed healthcare improvement.


