Post Summary

We are seeking to recruit a post-doctoral research fellow to investigate the use of deep reinforcement learning (RL) and swarm intelligence techniques to optimize urban and highway traffic in the presence of autonomous and conventional vehicles within the ClearWay project funded by Science Foundation Ireland.

The increasing availability of sensor data, including from connected and autonomous vehicles, will make it possible to capture the detailed state of a road network in real time. Along with the ability to exercise an increasing level of control over individual vehicles either indirectly, e.g., via urban traffic control or driver guidance systems, or directly, in the case of (semi-) autonomous vehicles, this offers the opportunity to deploy new approaches to traffic management with the explicit goal of optimizing end-to-end travel-time reliability.

Extending the state of the art in deep RL and swarm intelligence, ClearWay will design algorithms for optimization of urban and highway traffic as a function of the increasing levels of sensor data and increasing levels of control over individual vehicles available. Such algorithms will need to take account of the scale, complexity, and inherent non-stationarity of traffic systems, while adapting to the many transient perturbations that effect traffic flow. The focus is on decentralized and multi-agent algorithms that allow traffic controllers to cooperate towards system-wide optimal solutions. The successful candidate is expected to make contributions to the state of the art in deep RL applied to cyber-physical systems in areas such as multi-agent cooperation, lifelong learning, transfer learning, and explainability.

Standard Duties and Responsibilities of the Post

The successful candidate will join an inter-disciplinary team of highly-skilled and innovative researchers undertaking research in the areas of RL and intelligent mobility. This will involve:

1) Reviewing and analysing existing and emerging research in relevant fields.

2) Proposing new algorithms to address identified gaps in the state of the art, implementing, and evaluating those algorithms rigorously.

3) Undertaking systems development and integration activities and conducting large-scale simulation studies.

5) Disseminating the results of the work in a variety of fora but especially academic papers.

The successful candidate will be expected to assist with administrative and management work associated with Trinity's work in ClearWay through monitoring and ensuring effective delivery of the project milestones and deliverables, budget, ethics, quality control and compliance. They will engage in appropriate training and development opportunities to develop own transferable skills, career and reputation as well as other duties as assigned by the PIs.

The successful candidate must have a PhD in Computer Science, Computer Engineering, Electronic Engineering, or a related field. The post is applicable to both new and experienced PhD holders, and salary will be commensurate with experience and achievement.

The Selection Process in Trinity

The Selection Committee (Interview Panel) may include members of the Academic and Administrative community together with External Assessor(s) who are expert in the area. Applications will be acknowledged by email. If you do not receive confirmation of receipt within 1 day of submitting your application online, please contact the named hiring lead on the job specification immediately and prior to the closing date/time.

Given the degree of co-ordination and planning to have a Selection Committee available on the specified date, the University regrets that it may not be in a position to offer alternate selection dates. Where candidates are unavailable, reserves may be drawn from a shortlist. Outcomes of interviews are notified in writing to candidates and are issued no later than 5 working days following the selection day.

In some instances the Selection Committee may avail of telephone or video conferencing. The University's selection methods may consist of any or all of the following: Interviews, Presentations, Psychometric Testing, References and Situational Exercises.
