Post Summary

The School of Nursing and Midwifery, Trinity College Dublin is seeking to recruit a postdoctoral researcher to assist with service improvement and innovation initiatives in the Dublin South Central Mental Health Services, CHO 7, Health Service Executive (HSE).

The purpose of the project is to link with The Trinity Centre for Practice & Healthcare Innovation in Trinity College Dublin to support mental health nursing research for Advanced Nurse Practitioners in Mental Health (ANPs-MH), with the aim of improving evidence-based care and practice and to support innovation in nursing practice through increased research activities. The role will involve liaising between the service providers, ANPs-MH and research teams to explore the implementation of evidenced based research for the enhancement of service user outcomes in practice. This will involve conducting research for internationally peer reviewed outputs for dissemination to the wider mental health nursing workforce.

This post is offered on a part-time basis (2 days per week), for 12 months and will start immediately. This position will appeal to anyone who wishes to develop their research career and profile. The salary is commensurate with the IUA scale for a postdoctoral position. The post will primarily be based in the School of Nursing & Midwifery, Trinity College Dublin, 24 D'Olier Street, Dublin 2. However, the post will require regular travel to HSE Mental Health Services in CHO 7. The post holder will be part of a multidisciplinary team at the TCPHI and where necessary will receive training, guidance and support.

Standard Duties and Responsibilities of the Post

With supervision and support to:

- Work collaboratively with the ANPs-MH, service providers and research teams in achieving the goals set out.
- Help set up and participate in a project oversight group.
- Obtain Ethical Approval for any projects.
- Assist with dissemination through international peer reviewed publications.
- Prepare reports and papers for publication.

Funding Information

The post is funded by the Health Service Executive through the Dublin South Central Mental Health Services.

Person Specification

Qualifications

- A PhD in nursing or one of the social sciences or allied health professions is preferable.

Knowledge & Experience Required (Essential and Desirable)

- A background in health that includes research (preferably in mental health or mental health nursing).
- Conducting systematic reviews
- Experience of writing for publication and/or having a publication record.
- Experience in both qualitative and quantitative research is essential.
- Familiarity with statistical analysis and qualitative data is desirable.

Skills & Competencies

- Excellent oral and written communication skills.
- Experience in both quantitative and qualitative research methods including recruitment, data collection, data analysis and publication.
- Familiarity with a qualitative and quantitative data analysis package such as NVivo/IBM SPSS is essential.
- Writing reports and papers for publication.
- An ability to work both under his/her own supervision and as part of a team.

GARDA CLEARANCE:

Police vetting will be sought in respect of individuals who come under consideration for a post.

PLEASE NOTE: Applicants will be required to complete and return a Garda vetting form should they come under consideration for appointment. In some cases they may be requested to complete the form on the day of interview. This form will be forwarded to An Garda Síochána (Irish Police) for security checks on all Irish addresses at which they have resided. An Garda Síochána will make enquiries with the Police Service of Northern Ireland with respect to addresses in Northern Ireland. If an applicant is not successful in obtaining the post for whatever reason, this information will be destroyed. If an applicant, therefore, subsequently comes under consideration for another position, they will be required to supply this information again.

While applicants must complete information in relation to all addresses at which they have resided, the vetting is only done on addresses on the island of Ireland.

If an applicant has resided / studied in countries outside of Ireland for a period of 6 months or more, it is mandatory for them to furnish a Police Criminal Records Check/ Police Certificate from those countries stating that they have no convictions recorded against them while residing there. Applicants will need to provide a separate Police Criminal Records Check/ Police Certificate for each country in which they have resided. The Police Criminal Records Check/ Police Certificate must be dated after the date the applicant left the relevant country. Applicants should provide documentation in the English and/or Irish language. Translations must be provided by a registered translation company/institute in the Republic of Ireland; all costs will be borne by the applicant. Only original version documents will be accepted.

Applicants should be aware that any information obtained in the Garda Vetting process can be made available to the employing area.

It is the responsibility of the applicant to seek security clearances in a timely fashion as they can take some time. No applicant will be appointed without this information being provided and being in order.

The Selection Process in Trinity

The Selection Committee (Interview Panel) may include members of the Academic and Administrative community together with External Assessor(s) who are expert in the area. Applications will be acknowledged by email. If you do not receive confirmation of receipt within 1 day of submitting your application online, please contact the named Recruitment Partner on the job specification immediately and prior to the closing date/time.

Given the degree of co-ordination and planning to have a Selection Committee available on the specified date, the University regrets that it may not be in a position to offer alternate selection dates. Where candidates are unavailable, reserves may be drawn from a shortlist. Outcomes of interviews are notified in writing to candidates and are issued no later than 5 working days following the selection day.

In some instances the Selection Committee may avail of telephone or video conferencing. The University's selection methods may consist of any or all of the following: Interviews, Presentations, Psychometric Testing, References and Situational Exercises.

It is the policy of the University to conduct pre-employment medical screening/full pre-employment medicals. Information supplied by candidates in their application (Cover Letter and CV) will be used to shortlist for interview.

Applications from non-EEA citizens are welcomed.
