The TCPHI is seeking to recruit a postdoctoral researcher to assist with increasing research capacity and service improvement innovation initiatives in the HSE Community Healthcare Dublin South, Kildare & West Wicklow Public Health Nursing Services. The role of the research fellow will be to work with nurses in clinical practice and academics from the school of Nursing & Midwifery on nurse-led research projects.

This post is offered on a full-time basis (5 days per week), for 17 months and will start immediately. This position will appeal to anyone who wishes to develop their research career and profile. The salary is commensurate with the IUA scale for a postdoctoral position. The post will primarily be based in the School of Nursing & Midwifery, Trinity College Dublin, 24 D'Olier Street, Dublin 2. However, the post will require regular travel to the health care centres in Heytesbury Street, Russel Square, Tallaght, Kildare, Wicklow and other travel within CHO7 as required by the post. The post holder will be part of a multidisciplinary team at the TCPHI and where necessary will receive training, guidance and support.

## Standard Duties and Responsibilities of the Post

- To work collaboratively with the project Principal Investigator, Steering Committee and project teams to achieve the research plan.
- To assist academics and nurses in designing, planning and conduct of different project studies.
- Obtain Ethical Approval for the different research projects.
- Assist with systematic reviews.
- To conduct qualitative and quantitative data collection and analysis as required.
- To carry out administrative tasks associated with the different projects.
- To support the process of publication and dissemination of research findings.
- Any other duties that fall within the post as allocated by the Principal Investigators.

#### **GARDA CLEARANCE:**

Police vetting will be sought in respect of individuals who come under consideration for a post.

PLEASE NOTE: Candidates will be required to complete and return a Garda vetting form should they come under consideration for appointment. In some cases they may be requested to complete the form on the day of interview. This form will be forwarded to An Garda Síochána (Irish Police) for security checks on all Irish addresses at which they have resided. An Garda Síochána will make enquiries with the Police Service of Northern Ireland with respect to addresses in Northern Ireland. If a candidate is not successful in obtaining the post for whatever reason, this information will be destroyed. If a candidate, therefore, subsequently comes under consideration for another position, they will be required to supply this information again.

While candidates must complete information in relation to all addresses at which they have resided, the vetting is only done on addresses on the island of Ireland.

If a candidate has resided / studied in countries outside of Ireland for a period of 6 months or more, it is mandatory for them to furnish a Police Criminal Records Check/ Police Certificate from those countries stating that they have no convictions recorded against them while residing there. Candidates will need to provide a separate Police Criminal Records Check/ Police Certificate for each country in which they have resided. The Police Criminal Records Check/ Police Certificate must be dated after the date the candidate left the relevant country. Candidates should provide documentation in the English and/or Irish language. Translations must be provided by a registered translation company/institute in the Republic of Ireland; all costs will be borne by the candidate. Only original version documents will be accepted.

Candidates should be aware that any information obtained in the Garda Vetting process can be made available to the employing area.

It is the responsibility of the candidate to seek security clearances in a timely fashion as they can take some time. No candidate will be appointed without this information being provided and being in order.


## In the QS World University Subject Rankings:





## The Selection Process in Trinity

The Selection Committee (Interview Panel) may include members of the Academic and Administrative community together with External Assessor(s) who are expert in the area. Applications will be acknowledged by email. If you do not receive confirmation of receipt within 1 day of submitting your application online, please contact the named Recruitment Partner on the job specification immediately and prior to the closing date/time.

Given the degree of co-ordination and planning to have a Selection Committee available on the specified date, the University regrets that it may not be in a position to offer alternate selection dates. Where candidates are unavailable, reserves may be drawn from a shortlist. Outcomes of interviews are notified in writing to candidates and are issued no later than 5 working days following the selection day.

In some instances the Selection Committee may avail of telephone or video conferencing. The University's selection methods may consist of any or all of the following: Interviews, Presentations, Psychometric Testing, References and Situational Exercises.

It is the policy of the University to conduct pre-employment medical screening/full preemployment medicals. Information supplied by candidates in their application (Cover Letter and CV) will be used to shortlist for interview.

Applications from non-EEA citizens are welcomed.
